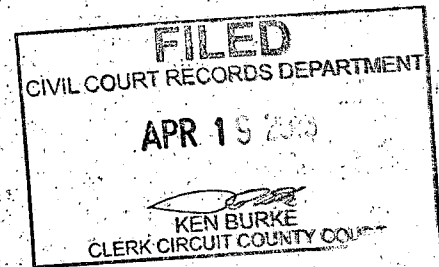

2. I married Terry Gene Bollea, professionally known as Hulk Hogan, on December 14, 2010. For almost two years, we had a very happy and stress-free marriage. Since Gawker.com posted the Sex Tape of my husband on October 4, 2012, however, there has been a significant strain on our marriage.

3. The Sex Tape, which remains up at Gawker.com, shows in graphic detail my husband having sex with Heather Clem in a private bedroom. This affair occurred four years before we married.

4. I often have nightmares about the Sex Tape, and often lose sleep because it remains up at Gawker.com. The knowledge that anyone, at any moment, can go to Gawker.com and watch my husband having sex is extremely distressing and causes me significant embarrassment.

Often, when my husband and I are out running errands, or going out to dinner with friends, or out in public with Terry's children, we are confronted by strangers who approach us and start to talk to us about the Sex Tape, which remains up at Gawker.com. This is extremely distressing and embarrassing for me, for my husband, for his children, and for our friends who are with us.

I declare under penalty of perjury that the foregoing statements are true and correct to the best of my knowledge, information and belief.


