Ken and Christina –

It has come to our attention that last week a process server attempted to serve a number of entities and individuals at the offices of Gawker Media, LLC at 210 Elizabeth Street in New York. After Gawker Media's receptionist explained that those offices were not the proper place for service for those defendants and that she could not accept service, the server then threw down the papers and left.

As you know, Gawker Media, LLC has voluntarily accepted service and has appeared in the action. It is the one responsible for the content of [gawker.com](http://gawker.com).

As previously explained, there are no claims against the other defendants and in most cases no jurisdiction over them in Florida. That said, should plaintiff still want to serve those other parties, please be advised that:

1. Gawker Media Group, Inc. and Blogwire Hungary Szellemi Alkotast Hasznosito KFT do not have any operations or any employees, let alone a principal place of business, at the 210 Elizabeth Street address.
2. As previously advised, Gawker Entertainment, LLC, Gawker Technology, LLC, Gawker Sales, LLC are dissolved companies, which also have no principal place of business at that address since they are dissolved.
3. Nick Denton and Kate Bennert need to be served personally, not by depositing papers at their workplace.

While we view it as overkill to sue eight defendants (including three dissolved companies) in addition to Gawker Media, LLC which is the entity that actually operates [gawker.com](http://gawker.com), that is of course your prerogative. Should you continue on that course, however, we wanted to provide you with the above information so that you could serve them properly.
