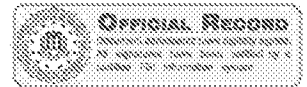

Also present during the interview was attorney [redacted] attorney [redacted] and [redacted] client [redacted]. After being advised of the purpose of the interview and the identity of the interviewing Agents, [redacted] provided the following information:

[redacted] stated there have been multiple reports on the internet from websites such as Gawker and TMZ that have stated a sex tapes exists between [redacted] attorney and [redacted] HEATHER COLE. [redacted] believes the reference of [redacted] attorney is in fact him. Several of these posts and leaks appear to be from a Twitter user by the name of [redacted] either directly or indirectly. [redacted] and [redacted] believe [redacted] is the alias of [redacted] an employee of [redacted] in St. Petersburg, FL.

On September 28, 2012, [redacted] and two other associates went to the [redacted] office located at [redacted] St. Petersburg, FL. [redacted] purpose was to ask for [redacted] and ask him to stop posting threatening and intimidating messages on the internet. [redacted] and the others signed in and waited for [redacted] to show up. When he showed up, [redacted] and the others walked outside. [redacted] asked [redacted] if he knew who they were as [redacted] knew who [redacted] was. Further, [redacted] told [redacted] if he preferred, [redacted] would speak to [redacted] attorney. [redacted] stated he would talk. [redacted] asked [redacted] to please stop posting on the internet. [redacted] asked if [redacted] was threatening him. [redacted] denied threatening [redacted] and eventually terminated the meeting.

Following the confrontation, [redacted] created an entry on his blog entitled [redacted] with information regarding the confrontation he had with [redacted] believes this confirmed [redacted] identity as [redacted]. After this post, the postings stopped for about a week. On October 4, 2012, the HULK HOGAN sex tape was released to Gawker. [redacted] found out that the tape(s) were being shopped to various media sites to include VIVID and [redacted] as well as TMZ.

After [redacted] said [redacted] was [redacted] on his radio show, [redacted] alleged defamation, however has not perfected his claim to date. [redacted]

attorney is [REDACTED] who has an office near the Tampa Theatre. [REDACTED] told [REDACTED] he and his client needed \$10,000 to settle the issue which [REDACTED] took as an extortion attempt. [REDACTED] told [REDACTED] that would not happen and soon thereafter, the Gawker leak occurred. [REDACTED] believes every time a settlement is denied, another name is released or rumor is leaked.

[REDACTED] stated he never had sex with COLE and therefore, no video exists of he and COLE. b6 -2, 4

[REDACTED] stated the negative publicity from a situation like this is damaging to his business and his reputation both professionally and personally. Further, [REDACTED] is in fear for his safety after multiple tweets regarding physical harm have been posted. Also, [REDACTED] found a mutilated cat at his residence and candy found on his porch that said "Boo." [REDACTED] showed interviewing Agents a picture of the mutilated cat.

[REDACTED] stated he has negotiated defamation settlements on behalf of [REDACTED] with [REDACTED] and [REDACTED]

[REDACTED] advised he has spoken to Detective [REDACTED] of the Hillsborough County Sheriff's Office (HCSO), cell phone number [REDACTED] and Detective [REDACTED] of the HCSO, cell phone number [REDACTED]. HCSO has initiated a case to look into the theft of the sex tape, unlawful distribution of the tape and harassment. [REDACTED] has also spoken to Major [REDACTED] of the St. Petersburg Police Department regarding the same.

[REDACTED] advised [REDACTED] agent is [REDACTED] who would be able to negotiate on behalf of [REDACTED] and [REDACTED] and would be willing to assist. b6 -2, 4
