Sept. 28, 2012 [redacted] confronts [redacted] about his involvement in the [redacted] accounts

Oct. 1, 2012 [redacted] discovers the remains of a mutilated cat at his residence in South Tampa

Oct. 4, 2012 Hulk Hogan sex tape is released on [www.gawker.com](http://www.gawker.com)

Oct. 8, 2012 (approx) [redacted] is left candy on his doorstep from someone anonymously with a message only stating "Boo"

Oct. 21, 2012 [redacted] tweets, "Tell you a secret. Depending on how tomorrow's show goes down, you might get to hear about another sex tape"

Oct. 22, 2012 [redacted] reveals the name of [redacted] as being connected with the [redacted] accounts.

Oct. 22, 2012 A Twitter user by the name [redacted] posted an image of a DVD with the text [redacted] you want to tell you (sic) public audience you have more tapes or shall I?"

Oct. 22, 2012 [redacted] posts [redacted] homes address on Twitter and encourages people to "trick or treat" and states that [redacted] Daewoo is in the driveway.
