**AMENDED ORDER BARRING RELEASE OF JURORS' NAMES**


**THIS CAUSE** came before the Court on March 14, 2016, upon the Intervenor's Motion to Vacate prior Order Barring Release of Jurors' Names. Upon consideration of argument of the attorneys, the Court enters this amended Order.

**THIS IS** a case of public interest which has generated significant media attention, locally and nationally, and the Court recognizes the need to protect the integrity of our justice system by assuring the jurors' rights to safety and privacy and the trial court's discretion in administering the courtroom. Potential jurors, simply because they are performing or have performed their civic duty, do not lose their inherent right of privacy. Inadequate attention to these interests could compromise the integrity of our justice system.

Therefore, it is hereby

**ORDERED** that members of Court Administration, the Clerk of Court of Pinellas County, and attorneys associated with the parties of this case and their clients shall not release the names or addresses of any juror until the trial in this case is completed.
