DEFENDANTS NICK DENTON'S AND A.J. DAULERIO'S MOTION FOR STAY TO SEEK APPELLATE REVIEW

On July 25, 2016, Plaintiff Terry Bollea filed an emergency motion as to Defendants Nick Denton and A.J. Daulerio asking this Court to vacate and/or modify its June 10, 2016 oral ruling on Defendants' Motion for Stay of Execution Pending Appeal, as well as to assess sanctions and attorneys' fees ("Motion to Vacate"). Per this Court's instructions, Defendants Denton and Daulerio filed their opposition to that emergency motion on July 26, 2016, and both parties filed proposed orders on July 27, 2016. This motion for a brief, provisional stay is being filed contemporaneously with Defendants' proposed orders out of an abundance of caution, as it appears that the Court will not hold a hearing on Plaintiff's motion.

Should the Court enter any order on Plaintiff's July 25, 2016 emergency motion other than one of the orders proposed by Defendants, Defendants respectfully request the Court stay its order for seven days to allow the Second District Court of Appeal to have a meaningful opportunity for appellate review. In determining whether to issue a stay to maintain the status quo during an appellate proceeding, courts have traditionally considered two factors: "the moving party's likelihood of success on the merits, and the likelihood of harm should a stay not

be granted." *Perez v. Perez*, 769 So. 2d 389, 391 n.4 (Fla. 3d DCA 1999) (citing *State ex rel. Price v. McCord*, 380 So. 2d 1037 (Fla. 1980)). For all the reasons set forth in their opposition to Plaintiff's emergency motion, Defendants have demonstrated a high likelihood of success on the merits and have illustrated a near certainty of harm should a stay not be granted. *See* Defs.' Opp. at 14-16. The one-week stay that Defendants request, if neither of their proposed orders is signed, would preserve the status quo long enough to give the appellate court time to fully consider all of the issues raised in Defendants' Motion for Stay and Plaintiff's arguments in opposition thereto—or, at the very least, give the Court of Appeal the opportunity to put in place whatever stay it sees fit.
