2                   When we take them, we will then go around,  
3           because GMGI is in bankruptcy and Gawker Media is  
4           in bankruptcy, well, we'll file proof of claims  
5           against them to assert those rights, those  
6           indemnity rights that Mr. Daulerio has, against  
7           those companies. We think at this point it is  
8           against both companies.

9                   There were some arguments raised about  
10          positions that we took in the bankruptcy case. We  
11          were very careful on our filings in the bankruptcy  
12          case to only attack the indemnity rights of Gawker  
13          Media. We didn't attack the indemnity rights of  
14          GMGI. GMGI is a Cayman Islands company. Their  
15          laws are different. You can indemnify people for  
16          intentional torts in the Cayman Islands.

17                  And the indemnity rights we're talking about  
18          are a pattern and a practice, which we learned  
19          through depositions in that case, after our  
20          response was actually filed, that Mr. Denton was  
21          assured that his indemnity rights for both  
22          companies would be honored.

23                  We assumed that Mr. Daulerio got the same  
24          assurance because they've stated publicly that  
25          they're not going to cut their riders loose and
