ORDER OF REFERRAL TO SPECIAL MAGISTRATE

THIS CAUSE came before the Court on its own Motion to refer case to a Special Magistrate on October 28, 2013. The Court has heard argument of counsel and is otherwise duly advised in the premises, therefore, it is hereby **ORDERED AND ADJUDGED**, as follows:

1 In accordance with Rule 1.490, Florida Rules of Civil Procedure, the Court hereby appoints James R. Case, 205 Palm Island NW, Clearwater, Florida 33767, Phone (727) 443-6513, Fax 727-446-2374, Email jumcase@tampabay.rr.com, as Special Discovery Magistrate.

2 The Court further appoints James R. Case as a Special Discovery Magistrate for future discovery disputes of ongoing nature until final resolution of this action.


3 The costs of the Special Discovery Magistrate shall be shared as follows:

a	Plaintiff	50%
b	Defendant	50%

Counsel for the parties' shall be responsible for ensuring payment to the Special Discovery Magistrate in accordance with their agreement. The Court retains jurisdiction to enforce any agreement with the Special Discovery Magistrate.

4 Hearings shall be held at such locations and in such manner as agreed to by the Special Discovery Magistrate and counsel for the parties, or in the absence of such agreement, at such place in Pinellas County, Florida as determined by the Special Discovery Magistrate
