I, Scott Kidder, hereby declare under penalty of perjury that the following is true and correct to the best of my knowledge.


1. The statements made in this Affidavit are based on my personal knowledge.
2. I am Managing Director of Kinja, KFT, formerly known as Blogwire Hungary Szellemi Alkotast Hasznosito KFT (“Blogwire Hungary” or “Kinja”), and submit this Affidavit in support of its Motion to Dismiss in this action. I am competent to testify as to the facts set forth below, and, if called as a witness, could and would testify to such facts under oath.
3. Kinja is a Hungarian intellectual property holding company and a software development company. Kinja also publishes the Hungarian website, cink.hu. In form, it is the Hungarian equivalent of a limited liability company (although I am not a Hungarian legal expert, it is my understanding that “KFT” is the Hungarian equivalent of “LLC”).
4. Kinja is a wholly owned subsidiary of Gawker Media Group, Inc., which also owns Gawker Media, LLC.

5. Kinja owns and licenses to Gawker Media, LLC trademarks, domains and proprietary software used by Gawker Media, LLC in connection with the various Gawker Media, LLC websites, including Gawker.com, and performs certain technology services for those websites.

6. This lawsuit concerns the publication on the website www.Gawker.com on or about October 4, 2012 of an article (the "Gawker Story") entitled "Even For a Minute, Watching Hulk Hogan Have Sex on a Canopy Bed is Not Safe For Work. But Watch It Anyway," along with a 101-second video file (the "Excerpts").

7. Kinja plays no role in developing or publishing the content published at any of the Gawker Media, LLC websites, including Gawker.com, where the Gawker Story and Excerpts were published. As such, Kinja necessarily could not have played any role and did not play any role in publishing or editing the Gawker Story and/or the Excerpts.
