**ORDER DENYING WITHOUT PREJUDICE DEFENDANT BLOGWIRE
HUNGARY'S MOTION TO DISMISS REGARDING JURISDICTION**

This cause came before the Court on January 17, 2014, on the Motion to Dismiss of Defendant Blogwire Hungary Szellemi Alkotast Hasznosito, KFT (now known as, and referred to herein as, "Kinja, KFT"). The Court has reviewed the Court file, reviewed and considered the Motion and response papers, heard argument of counsel, and is otherwise fully advised.

Accordingly, IT IS ORDERED AND ADJUDGED as follows:

(1) Kinja's motion to dismiss for failure to state a claim (regarding jurisdiction) and for lack of personal jurisdiction is DENIED WITHOUT PREJUDICE. Kinja may renew its motion after Plaintiff has an opportunity to take additional jurisdictional discovery.

(2) The Court has not adjudicated the portion of Kinja's motion to dismiss in which it joined in the substantive grounds for dismissal set forth in Defendant Gawker Media, LLC's motion to dismiss, which motions will be adjudicated at a later date.
