Dear Judge Campbell:

As you know, together with Seth Berlin, I represent the Gawker Defendants in the above-referenced matter. I enclose the Notice of Hearing for April 23, 2014, along with a binder containing the briefing to date on the Gawker Defendants' Motions to Dismiss.

By way of background, Gawker originally filed its motion to dismiss in January 2013, when these proceedings were in federal court. After the case was remanded, each of the other remaining Gawker Defendants joined the motion in full as they were served. The Gawker Defendants awaited the Second District Court of Appeal's ruling on the temporary injunction before noticing the hearing, as that appeal implicated the same legal issues raised by their motions to dismiss. As we believe that decision simplifies the issues previously raised in the parties' briefs, Gawker's reply brief (Tab I) addresses the District Court's decision, which we hope the Court will find helpful.


