During the course of the above-referenced litigation, the Court determined that the telephone records of Plaintiff Terry Gene Bollea from 2012 are discoverable and must be produced. Plaintiff has retrieved copies of records showing outgoing calls from his home phone from his telephone service provider, Bright House Networks Information Services (Florida), LLC ("Bright House"), but has been told that Bright House requires a court order before releasing records reflecting incoming calls.

The parties have agreed to and prepared the enclosed Stipulated Order directing Bright House to produce Plaintiff's complete residential telephone records for 2012 to his counsel, including call logs reflecting outgoing and incoming calls. 
