**STIPULATED ORDER DIRECTING BRIGHT HOUSE
NETWORKS INFORMATION SERVICES (FLORIDA), LLC TO
RELEASE TELEPHONE RECORDS OF PLAINTIFF TERRY GENE BOLLEA**

The parties in the above-captioned action are engaged in the discovery process. This Court has previously determined that the telephone records of Plaintiff Terry Gene Bollea from 2012 are discoverable and must be produced.

Plaintiff has retrieved copies of records showing outgoing calls from his home phone from his telephone service provider, Bright House Networks Information Services (Florida), LLC ("Bright House"), but has been told that Bright House requires a court order before releasing records reflecting incoming calls.


