CLARIFICATION ORDER

Due to the number of exhibits, including many DVD recordings and various copies of different portions of which were a significant part of this trial, the Court is entering this order for clarification purposes and to ensure the accuracy of the record.

On March 17, 2016, at the close of the Defendants' case, the Defendants moved into evidence Exhibit No. 310 (a 1 minute and 41 second clip of the video which was determined to have been published by the Defendant, Gawker Media, on their website) and Exhibit No. 311 (the 30 minute DVD which was represented as the original version received by the Defendants). Without objection, the Defendant's Exhibit No. 310 was admitted into evidence.

Plaintiff objected to the admission of Defendant's Exhibit No. 311 into evidence, and the Court recessed to review the exhibit.

The Court did not admit Defendant's Exhibit No. 311 into evidence due to authentication issues and pursuant to Florida Rules of Judicial Administration, 2.420(c)(9)(A)(v) and 2.420(c)(9)(A)(vi) to avoid substantial injury to innocent third parties who were named and included in the DVD and to the Plaintiff by disclosing matters protected by a privacy right. This exhibit was marked for identification purposes, but was not admitted into evidence. The Court ordered that it be sealed in the record.


Based upon the foregoing, it is hereby

ORDERED as follows:

1. Defendant's Exhibit No. 310 which was admitted into evidence and viewed by the jurors shall be sealed.

2. Defendant's Exhibit No. 311 which was marked for identification purposes, but was not admitted into evidence, shall be sealed.
