JOINT STIPULATION REGARDING RON HOWARD

Plaintiff Terry Gene Bollea ("Plaintiff") and Defendants Gawker Media, LLC, Nick Denton, and A.J. Daulerio (collectively "Defendants") jointly stipulate as follows:

1. During the course of discovery in the above-captioned litigation, Gawker Media, LLC served a subpoena for deposition and a subpoena for documents on Ron Howard.
2. The subpoenas were issued after the Court entered an Order on December 2, 2014 adopting as "the ORDER of this Court," the Special Discovery Magistrate's November 11, 2014 Report and Recommendation that, *inter alia*, limited the documents Defendants could seek from Howard and provided that "defendants may not take discovery from plaintiff or any third parties of any financial information pertaining to (a) plaintiff, (b) plaintiff's commercial affairs, or (c) the use of plaintiff's image, name, or likeness."
3. On March 26, 2015, Howard produced documents in response to the subpoena.
4. Plaintiff will not call Howard to testify at trial.
5. In light of the foregoing, Defendants will not depose Howard or call Howard to testify at trial.


