**ORDER RE: GAWKER MEDIA, LLC's EXCEPTIONS
TO SPECIAL DISCOVERY MAGISTRATE'S REPORT
AND RECOMMENDATION DATED MARCH 11, 2015**

This cause came before the Court on March 19, 2015, on Defendant Gawker Media, LLC's ("Gawker") Exceptions to Special Discovery Magistrate's Report and Recommendation Dated March 11, 2015. The Court has reviewed the Court file, reviewed and considered the Motions and response papers, heard argument of counsel, considered the Report & Recommendation, and is otherwise fully advised. Accordingly, IT IS ORDERED AND ADJUDGED, as follows:


The Report and Recommendation of Special Discovery Magistrate Re: Plaintiff Terry Gene Bollea's Motion to Overrule Defendant Gawker Media, LLC's Objections to Corporate Designee Deposition Topics and Motion for Protective Order (signed March 11, 2015) is **ADOPTED** as the Order of the Court:

- a) Plaintiff's Motion to Overrule Gawker's Objections is **GRANTED**;
- b) Gawker's objections to the topics of examination listed in Plaintiff's notice of deposition served December 29, 2014 are overruled;
- c) Gawker's motion for protective order is denied;

- d) Plaintiff's Motion to Compel Deposition is granted; and
- e) Gawker is ordered to produce its corporate designee as to the topics of examination listed in Plaintiff's notice of deposition served December 29, 2014, except that:
 - 1) Gawker's corporate designee shall not be required to answer questions about topics that were addressed at the prior deposition of Gawker's corporate designee, and
 - 2) This Court's prior rulings about the permissible scope of discovery will apply.
- f) The fact discovery cutoff will be extended to allow the completion of the deposition, which is currently scheduled for April 14, 2015, and which shall not be postponed absent extenuating circumstances.
