FRIDAY; MAY 29, 2015 AT 9:30 A.M.



Any additional Motions must be noticed by the appropriate party for the CMC date and time and copies provided to all parties and this Court.

ALL ATTORNEYS AND/OR PRO SE OR SELF REPRESENTED PARTIES ARE REQUIRED TO ATTEND IN PERSON.

If either counsel or pro-se litigant has a conflict and cannot attend the Case Management Conference, and the Judge determines that it is for good cause, it will be that person's responsibility to contact the Court's Judicial Assistant, Teresa McCreary at tmccreary@jud6.org, to determine when the Conference may be rescheduled. If opposing counsel/pro-se does not give consent to rescheduling the Conference, or if an agreement as to a specific date and time cannot be mutually agreed upon, a timely written motion and hearing will be needed to seek an alternate date.
