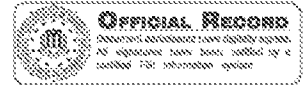
**Details:**

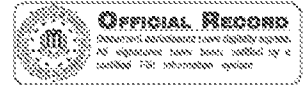

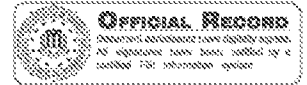
