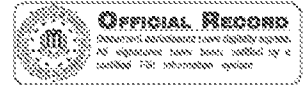

Therefore, we take no position on the FBI's intention to provide the evidence to local authorities, especially since, as we discussed, the FBI intends to follow its own procedures and consult its own legal counsel with respect to this plan.

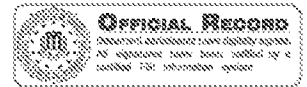

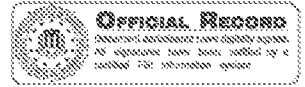
