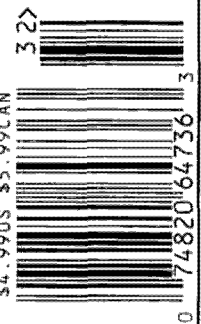

"I guess we're all a little racist," he crowed to Heather, the wife of his former pal Bubba "The Love Sponge" after their athletic 2007 sex romp.

DESPITE HIS calculated TV image as a born-again Christian, the tapes prove the heinous Hulk is a very different man off camera!

In a startling exchange, the 61-year-old 12-time world champion rants at Heather - who he sued for invasion of privacy after the XXX tape was leaked to a website - about his frustrations with blonde bombshell Brooke, 27.

"She is making some real bad decisions now," Hulk said, sources told The ENQUIRER.

"My daughter Brooke jumped sides on me. I spent 2-3 million dollars on her music career. I've done everything like a jackass for her.

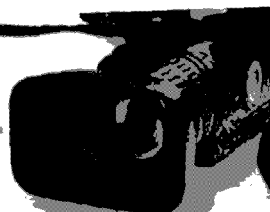
"The one option Brooke had, Brooke's career besides me, is [to] sell beach records."

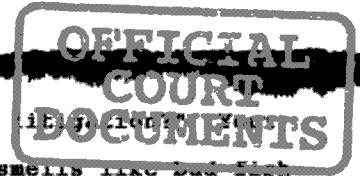

Impeccable sources told The ENQUIRER the sections dubbed over are said to be these rants - in which Hulk also badmouthed his ex-wife Linda, who he said was "f---ing up my MTV show!" The pair divorced in 2009.

Adding fuel to raging inferno, the first man to have listened to the Hulk tapes, TheDirty.com publisher Nik Richie, told The ENQUIRER in an exclusive interview: "He 100 percent said the

N-word. He was just saying it like it was part of his vocabulary."

Nik said he does not have a copy of the tape, nor did he provide the transcript to The ENQUIRER.

THE AUDIO alterations became apparent when, faced with the prospect of losing their lawsuit against Hulk, website Gawker sued the FBI to release its hidden cache of evidence.

■ After acquiring the bombshell transcript of Hulk Hogan's N-word racist rants, The National ENQUIRER contacted Hulk on Thursday, July 23, asking him to explain himself before we published.

■ In a desperate stab at damage control, Hulk alerted the WWE to our scoop. The WWE swiftly scrubbed his name and image from their website, removed his merchandising and booted him from their Hall of Fame.

■ Five minutes after The ENQUIRER published the story online, the WWE fired Hogan: "WWE is committed to embracing ... individuals from all backgrounds as demonstrated by the diversity of our employees."

website's attorney, Seth Berlin, claimed the audio in one of the tapes mysteriously changes "at a key moment."

"I want to understand how that audio got changed," Berlin told a Florida judge. "It smells like a bad fish."

Berlin further suggested that the FBI had conducted an "extortion" probe against a California man who was peddling the raunchy material - at the behest of Hulk!

"The sellers' play was to force Hogan into signing a deal that they all could make money from and sell the tape," Nik explained to The ENQUIRER.

HULK FILED HIS sensational lawsuit after Gawker posted a two-minute clip of the video.

The world-famous grappler claimed he was unaware he was being filmed in bed, and broadcasting his X-rated antics on the Internet invaded his privacy.

Gawker - which declined to comment when contacted by The ENQUIRER [as did lawyers for Hulk] - charged the FBI's actions in the Hulk probe are tantamount to a "cover up."

"The deeper you go, the more interesting it gets," the site's CEO Nick Denton teased in a recent post on his site.

That interest, according to insiders, is the shameful truth hidden for decades about Hulk's racist, hateful ways that now have the potential to jeopardize his lucrative multi-million-dollar career. **NE**

NIGHT HE CAME CLOSE TO KILLING HIMSELF!

HULK HOGAN'S scandal-scarred life in and out of the wrestling ring once drove him to consider suicide!

In a 2007 memoir, he revealed he was "riddled with personal torment" after wife Linda dumped him. He said he sat alone in his house for two days, downing Xanax with rum, and then sticking a handgun in his mouth. "But before pulling the trigger, the phone suddenly rang," he wrote.

The caller was his then "American Gladiators" co-host Laila Ali, who convinced him not to take his life.

Hulk's life imploded in a \$50 million divorce when Linda accused him of cheating with a close friend of daughter Brooke. The woman, Christiane Plant, later apologized, telling The ENQUIRER: "I'm terribly sorry for what occurred."

There was more trouble when his son was involved in a felony car crash in Clearwater, Fla., in 2008 that seriously injured a pal. Nick was sentenced to eight months in prison.

Hulk faced allegations of steroid use in the early '90s, and briefly left the grappling game. But even before the racist scandal, he couldn't avoid controversy. In 2011, The ENQUIRER reported Hulk was embroiled in a gay furor following allegations made by a friend of ex-wife Linda.

Barbara Leslie - the estranged wife of Ed "Brutus 'The Barber' Beefcake" Leslie - said her husband's "bromance" with Hulk always struck her as "extraordinarily suspicious."

"I've watched my husband and Hulk interact for the past 20 years, and there have been many times when I felt they were much too close for comfort," she said.

Hulk, who married second wife Jennifer in 2010, scoffed at the charges.
