## ORDER ON DISCOVERY MOTIONS

This cause came before the Court on January 17, 2014, on Gawker Media, LLC's (1)

Motion to Compel in Connection with Subpoenas to Former Defendant Bubba the Love Sponge

Clem. and (2) Motion to Compel Plaintiff to Produce Communications Related to His Settlement
with Bubba the Love Sponge Clem. The Court has reviewed the Court file, reviewed and
considered the Motions and response papers, heard argument of counsel, and is otherwise fully
advised. Accordingly, IT IS ORDERED AND ADJUDGED:

- (1) Gawker Media LLC's Motion to Compel in Connection with Subpoenas to

  Former Defendant Bubba the Love Sponge Clem ("Bubba Clem") is GRANTED IN PART AND

  DENIED IN PART, as follows:
  - (a) On or before February 6, 2014. Bubba Clem is ordered to produce all documents in his possession, custody or control, including without limitation audio files and private Twitter messages, if any, pertaining to the Bollea video which is the subject matter of this action (the "Bollea Video"): to preserve until thirty (30) days after the termination of this action, including without limitation any appeals, any public tweets pertaining to the Bollea Video so that they are accessible to the parties; and to serve a

supplemental written response identifying with specificity any requests as to which Mr.

Clem has no responsive documents in his possession, custody or control.

- (b) On or before February 6, 2014. Bubba Clem shall take photographs of each wall and each corner of his bedroom and shall produce those photographs to counsel for Gawker Media, LLC.
- (c) Bubba Clem shall not be required to produce documents related to his settlement negotiations with plaintiff in this matter.
- (2) Gawker Media, LLC's Motion to Compel Plaintiff to Produce Communications
  Related to His Settlement with Bubba the Love Sponge Clem is DENIED.
- (3) Plaintiff and Bubba Clem are each ordered to preserve all audio and/or video footage that depicts any sexual activity between plaintiff and Heather Clem (the "Tapes") in their possession, custody or control until thirty (30) days after the termination of this action, including without limitation any appeals. On or before February 6, 2014, Plaintiff and Bubba Clem are each directed to produce any Tapes in their possession, custody or control to the Special Discovery Magistrate in this action, the Honorable James R. Case. Judge Case shall review any such Tapes for relevant content and shall arrange to have an official court reporter transcribe any such relevant content for distribution to the parties.
