

TERRY BOLLEA met with interviewing Agents on 2/4/2013 at the Pinellas Resident Agency of the FBI for the purpose of debriefing the meeting which took place on 12/14/2012 as well as authenticating the transcripts/recording from the same date. After being advised of the identity of the interviewing Agents and the nature of the interview, BOLLEA provided the following information:

Prior to listening to the tape, BOLLEA was asked what was his impression of the sex tapes that KEITH DAVIDSON was selling. BOLLEA stated that he believed DAVIDSON had the original tapes, there were no other copies and that the tapes were stolen. BOLLEA stated DAVIDSON told he and DAVID HOUSTON the tapes were stolen during the meeting. BOLLEA recalled hearing the tapes were stolen and then feeling nervous about the situation because if the tapes were stolen, DAVIDSON and his client did not have the copyright to the tapes. Further, BOLLEA stated he wondered why he would be paying for the tapes if DAVIDSON and his client did not legally own them. After DAVIDSON said they were stolen, BOLLEA believes DAVIDSON tried to back peddle from what he said.

BOLLEA further recalled DAVIDSON stated he was going to help BOLLEA by attempting to get GAWKER to remove the sex tapes from the website. DAVIDSON was bragging about other cases he had while they were in the restaurant. DAVIDSON told BOLLEA and HOUSTON that the type of negotiations they were involved in with the sex tapes was his main type of business.

Interviewing Agents and BOLLEA then listened to 1d8 which contained the recording of HOUSTON's pocket recorder for the purpose of authenticating the recording and transcript. BOLLEA and interviewing Agents made corrections to the transcript and BOLLEA signed and dated the corrected transcript. The transcript will be kept in a 1A in the case file.

During the recording, BOLLEA stated that he was left alone in the room with the sex tapes. BOLLEA further explained the situation by stating when he, DAVIDSON and HOUSTON went up to DAVIDSON's room, BOLLEA and DAVIDSON entered with HOUSTON staying in the hall to make a phone call. DAVIDSON showed BOLLEA the case with the sex tapes and then went to the bathroom. For a short time, BOLLEA was alone in the room with the tapes.
