

Interviewing Agents asked BOLLEA whether there are additional individuals to his knowledge that were close enough to BUBBA to have potentially slept and have been filmed with HEATHER CLEM. BOLLEA advised that the individuals he could think of include

BOLLEA was asked whether he recalled a time whereby BUBBA entered the room while he was with HEATHER CLEM to talk to him. BOLLEA recalled this happening during one of the sex acts as BUBBA was "dogging" BOLLEA by pulling his hair extensions in front of HEATHER CLEM. BOLLEA thought this was strange as the two had just had sex or were about to have sex.

BOLLEA began speculating on possible links and issues regarding rights to the BOLLEA sex tapes between various individuals involved in the investigation and their attorneys. This includes, husband (also b6 -2, 4 b7C -2,
