CLEM acknowledged making comments on the tape regarding the sex tape being his retirement fund, however, CLEM stated he was being a "smartass" and if he meant what he said, he would have never said it on tape.	
	CLEM believes that the sex tape he has seen released to the Gawker website took place approximately six (6) years ago. The sex act took place in CLEM's bedroom. CLEM stated that he, COLE and BOLLEA all knew that they were being filmed. Further, it was COLE's idea to tape and was most likely discussed between she, CLEM and BOLLEA. The camera was not concealed; rather it was a security type camera in the room which fed to the master security unit. CLEM again advised that the camera was obvious and everyone knew about the filming.
