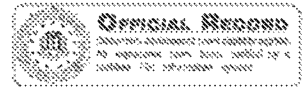

**THE GAWKER DEFENDANTS' MOTION TO DISMISS
ON THE GROUNDS OF FRAUD ON THE COURT**

On 11/9/2012, BUBBA CLEM, w/m, home address [redacted] St. Petersburg, FL 33715, DOB [redacted] SSAN [redacted] cell phone number [redacted] was interviewed at the law office of [redacted] cell phone number [redacted]. Also present during the interview was CLEM's attorney STEVEN DIACO, attorney [redacted] and attorney [redacted]. After being advised of the purpose of the interview and the identity of the interviewing Agents, CLEM provided the following information:

CLEM stated there were multiple individuals who are important to the complaint and therefore described them as the following:

[redacted] is believed to have an alias and own and operate the Twitter account [redacted] also began a Wordpress blog one year ago which is entitled "REAL BUBBA." CLEM believes he is able to identify [redacted] as [redacted] and the author of REAL BUBBA as he blogs and tweets about meetings which he was a part of and provides details about.

[redacted] owns and operates [redacted] in Dade City, FL. CLEM stated that when he was with Sirius Radio, [redacted] became the largest super fan he has had. CLEM believed [redacted] was acting strange and began distancing himself from [redacted] approximately a year ago. When the [redacted] Twitter account began, [redacted] brought a presentation to CLEM about who the identity of [redacted] was. [redacted] concluded that [redacted] was actually [redacted] which CLEM stated on his morning radio show. CLEM stated he "blasted" [redacted] on his radio show and [redacted] filed a defamation lawsuit against CLEM. CLEM eventually settled the lawsuit with [redacted] on the basis that CLEM defamed him when he erroneously stated he was [redacted]. Following the settlement, CLEM tweeted a message to the effect of "Hit the road JACK" aimed at [redacted] and then called [redacted] out for being [redacted] on his radio show. [redacted] then filed a defamation lawsuit against CLEM.

Interviewing Agent asked CLEM to explain his role in the filming and producing of the sex tapes between his ex-wife HEATHER COLE (formerly CLEM) and TERRY BOLLEA, aka HULK HOGAN. CLEM advised that COLE wanted to sleep with BOLLEA while they were married and further advised COLE was into

sleeping with other men and taping the act. CLEM was fine with this arrangement. When BOLLEA was going through a tough time with his ex-wife, he was staying at CLEM's residence. The sexual act took place and was taped by COLE. CLEM acknowledged making comments on the tape regarding the sex tape being his retirement fund, however, CLEM stated he was being a "smartass" and if he meant what he said, he would have never said it on tape.

CLEM believes that the sex tape he has seen released to the Gawker website took place approximately six (6) years ago. The sex act took place in CLEM's bedroom. CLEM stated that he, COLE and BOLLEA all knew that they were being filmed. Further, it was COLE's idea to tape and was most likely discussed between she, CLEM and BOLLEA. The camera was not concealed; rather it was a security type camera in the room which fed to the master security unit. CLEM again advised that the camera was obvious and everyone knew about the filming.

CLEM advised he has never seen the tape, other than what he viewed on Gawker. COLE had previously taped herself having sex with other men and had a tape collection. CLEM was unsure how many times this occurred and who the other individuals were. However, CLEM stated that the other individuals/videos did not contain celebrities such as [REDACTED] [REDACTED] as has been rumored on various websites. Further, CLEM denies the existence of a tape with COLE and DIACO as has been rumored. CLEM believes these rumors as well as others are initiated each time CLEM or DIACO do not cooperate with [REDACTED] and others. CLEM and DIACO believe the Gawker and TMZ website rumors are being fed by [REDACTED] and more specifically, [REDACTED]

The sex tape COLE and BOLLEA was burned to a DVD by COLE and labeled by CLEM as "HOCAN." CLEM was unable to recall whether the bedroom camera was always running or whether the taping was initiated by COLE. COLE had the knowledge of the system to be able to record and burn footage from the security system. CLEM recalls DVDs and Mini 8 tapes within COLE's collection.

When CLEM and COLE separated in March 2011, CLEM stated COLE went to his agent's office, [REDACTED] and showed him a cellophane bag containing the sex tapes she had made, to include the one with BOLLEA. Further, COLE stated the bag was the "ultimate fuck you" to CLEM. In June 2011, CLEM was able to get the bag with the tapes back which he placed in his office, in his desk, in a lower drawer under other stuff. CLEM believes there were between two and five tapes in the bag. In December 2011, his radio show and

crew moved to another building located at [REDACTED] Tampa, FL. His crew moved all of the show's equipment to the new building. CLEM advised he had forgotten about the tapes at that time.

During a mediation hearing in January 2012, CLEM stated the first question from the mediator was in regards to the sex tapes. The mediator wanted CLEM to sign an agreement that he would have a \$1.4 million penalty if any of the sex tapes were released. CLEM did not agree to the agreement and did not hear anything additionally about the terms. CLEM felt at this time, something was wrong.

In March 2012, the website Thedirty.com showed screen shots of COLE engaging in sexual intercourse with BOLLEA. CLEM went looking for the tapes in his desk in both the new and old office and was unable to find them. CLEM stated that [REDACTED] has stated he has spoken to all of CLEM's former employees and could have had something to do with the theft of the tapes.

Recently, various Twitter accounts to include [REDACTED] [REDACTED] and others have Tweeted several intimidating and threatening messages about CLEM and DIACO. CLEM stated his vehicle information and home address has been Tweeted. Further, Tweets about his girlfriend [REDACTED] [REDACTED] have been posted. CLEM denied these allegations. CLEM stated multiple times he does not feel safe at his house because of these Tweets/posts on the internet.

CLEM advised he believes the individuals behind the Twitter accounts have begun to call his guests and sponsors. CLEM has had several guests cancel their appearances on his radio show at the last second because they received negative phone calls prior. CLEM's sponsors to include McDonalds and others have been contacted by anonymous individuals with negative information about CLEM. CLEM lost a \$50,000 contract with [REDACTED] from [REDACTED] told CLEM he received negative phone calls from anonymous individuals.

CLEM advised COLE has been quiet since the sex tape scandal hit, however, she has had lunch with [REDACTED] according to Twitter posts.
