THE COURT: So we're here on Case No.

12-012447, Terry Bollea versus Gawker Media and others. I appreciate you all making yourselves available for this morning.

Here in the courtroom I have Ken Turkel and Rachel Fugate. I wanted to just announce the rulings from the last hearing. So I don't anticipate this taking very long, but I appreciate you all making yourselves available on such short notice.

First of all, I would like to talk about the defendants' motion for access to corrected and unredacted DVDs produced by the FBI. I received the five DVDs that Judge Case had in a safe deposit box on Friday. I reviewed them over the weekend. And I am granting the motion to the extent that the lawyers can review the DVDs. So we can schedule a time when the lawyers would be able to view them. I won't put you in the small jury room with a really loud fan again this time. I want to try to arrange for a conference room where you would be able to project the DVDs onto a screen and watch them that way so you're not all huddled around a small laptop.

1st, there were motions -- there was a motion in limine from the plaintiff on the issue of racial slurs, and that part of it we need to revisit. I think after you all have had an opportunity to review the DVDs, you will see that.

I recognize that this -- I'm only allowing the attorneys to look at it. I'm not saying that they are admissible. In fact, I'm sure some of them definitely are not admissible, but I'll let you all review them, and then we can discuss what each side wants to do with them, which for the majority of those DVDs, it's slim to none. I can just tell you that ahead of time.

And I'm going to -- after the attorneys have an opportunity to look at those DVDs, I'm going to suggest that the attorneys or that you go back to mediation. I'm not going to require it, but I think you'll see why.

I did want to confirm with the defense -Exhibit 17, the CD that I received, the audio, I
did receive that last Thursday after the hearing.
I did listen to that audio. I just wanted to
confirm that that came from the FBI.

Is that right, Ms. Fugate?
