Hulk Hogan just can't seem to identify his female co-star in <u>the sex tape that just surfaced</u> -- telling TMZ, he banged so many chicks after he left his ex-wife ... the woman could be one of MANY possible conquests.

Hulk called in to TMZ Live moments ago ... claiming he went on a 4-month alcohol-fueled lady-screwing bender between the time when he left his ex-wife Linda ... and met his current wife Jennifer.

Hulk tells us, "During that time, I don't even remember people's names, much less girls."

Hulk says he hasn't had sex with another woman since meeting Jennifer 5 years ago -- so the tape has to be at least 5 years old.

Hulk still has no idea who's selling the tape or how that person acquired it -- but Hulk's lawyer says, "If anyone goes forward with this thing, we're gonna find 'em and we're gonna prosecute."

Excerpts from TMZ Live, March 7, 2012

HARVEY LEVIN: (In progress) – today as he said good-bye. And there's something funny about this tape.

CHARLES LATIBEAUDIERE: You just don't expect that.

MR. LEVIN: Let's start with Hulk Hogan.

So Hulk, you know, was famously married to Linda Hogan, is now married to Jennifer McDaniel. In between Hulk hooked up with a brunette, which –

MR. LATIBEAUDIERE: He went against type.

MR. LEVIN: Went against type -

MR. LATIBEAUDIERE: See what happens, Hulk, when you go against type?

MR. LEVIN: And there was a sex tape that was made and apparently, according to Hulk at least, made without his knowledge or consent. And it's pretty graphic. We are going to talk about it.

MR. LATIBEAUDIERE: Now, the tape is not out. At this point it's just being shopped around town to porn companies, Vivid being one of them. But it's not – has not been released, and they can't release it –

MR. LEVIN: Until - unless -

MR. LATIBEAUDIERE: Till Hulk -

MR. LEVIN: – Hulk signs off.

MR. LATIBEAUDIERE: And the woman signs off.

MR. LEVIN: But there – but look, I mean, there are ways this stuff gets leaked on the Internet, and there are all sorts of things. So we're going to talk about the tape, and the best person to talk to about the tape is probably Hulk Hogan.

MR. LATIBEAUDIERE: Hulk Hogan -

MR. LEVIN: And he joins us now on "TMZ Live."

Hulk, first of all, welcome.

TERRY BOLLEA: Yeah, first of all, guys, there were several brunettes, OK? Let's at least get that – (inaudible) –

MR. LATIBEAUDIERE: Oh, there were several brunettes in between? All right.

MR. BOLLEA: No, there was – between the divorce from Linda and the time I met Jennifer, I had about four and a half months that I really went crazy. And I actually wrote about it in my book about staying drunk and crazy and hitting all the bars. So I was really out of my mind for a while.

MR. LEVIN: So you were actually – and we're going to get to the sex tape. But you obviously prefer blondes. But was going for brunettes kind of a statement against Linda Hogan?

MR. BOLLEA: No, brother, it was just - I don't know what was wrong with me. I was just so shocked and broken up -

MR. LATIBEAUDIERE: And drunk -

MR. BOLLEA: – you know, because I dreamed that I was the guy that would always stay married. And then, you know, when the whole thing went down, and you know, Linda fell in love with a younger guy, I guess everything – and it's nobody's fault but my own. So I'm not blaming her. But you know, I just went crazy for a while.

MR. LEVIN: OK, so Hulk, I want to say we are also joined on the phone with David Houston, who is your lawyer in this whole thing.

So David, welcome as well.

DAVID HOUSTON: Thank you, Harvey.

MR. LEVIN: So walk us through this. So when - what year was this tape shot?

MR. BOLLEA: Well, brother, I don't know what year it was. But this year around September, end of September, October I will have been with Jennifer about – for five years.

MR. LEVIN: That long?

MR. BOLLEA: So the question I'm wondering is: You know, why would someone hold on to this for at least five years, you know, and then do this to me now? That's what I don't understand, and I did not know it was being done. You know, I didn't say, hey, brunette. Let's put a camera up and have a sex tape.

I mean, I'm dumb but I'm not dumb and dumber. And so I just don't know why someone would do this, number one; and number two, why they would wait five years to release it, at least five years.

MIKE WALTERS: Hulk – Harvey – hey, Hulk, this is Mike Walters. I've actually seen part of this tape, and it's kind of how we wrote the story.

And from what it looks like and from what I've seen, it appears to be a little bit old. And the reason I say that is, from what – that you see of Hulk and what he looks like and how he's – and what he's discussing about working out and stuff, it seems – and I discussed with them earlier when we did the Web story. But it only shows a brunette. It shows him. It's a bedroom. It appears to be security footage from inside of a home and it shows Hulk kind of going towards a brunette woman. And then that's all that I've seen. I haven't seen whether or not this tape is some lengthy thing or what exactly happens after that.

MR. LEVIN: Does that ring any kind of a bell with you, Hulk?

MR. BOLLEA: You know, Harvey, I'm not trying to be a smart aleck. I'm horrible with remembering names, you know? But that's why I call everybody brother. But during that time, that four- or five-month window where I was going crazy, I was – the first thing I did was I – when I sat down with Jennifer, I said, I don't even remember people's names.

You know, the last weekend that I met, I meet so many people, much less girls five or six or seven years ago, or five years ago, whenever it was, it's just I couldn't remember a name if I had to. And the truth is it wasn't just one brunette. I was running pretty wild there for a few months.

MR. LEVIN: So -

MR. HOUSTON: And Harvey, we started – we started hearing about this last night. And one of the first things we tried to do is put together a picture of who this could be. It sounds like it's somebody that hit hard times and had the tape, and then hooked up with someone that had the ability to try to market it. And in fairness to them, we want to put them on notice they're committing a felony. And a lot of people aren't worried about civil liability because they may not have anything. But I think everybody's worried about whether they're going to spend time in jail. And in reality this is notice. And if anybody goes forward with this thing, we're going to find them and we're going to have them prosecuted.

MR. LEVIN: Mike, you saw this. Does it look like a house?

MR. WALTERS: It appears to be, like, a master bedroom. It's a very large bedroom.

It's a – there's like, a four-post bed. It looks comfortable.

It doesn't look like a hotel room or like somewhere that, Hulk, you haven't been before.

It looks like just a bedroom. And like I said, it looks comfortable enough that possibly either it is the person – the woman's house or a familiar house. It doesn't look like walking in and out like a hotel room. It just appears to be normal, run-of-the-mill, like, master bedroom, is what it looks like.

MR. LEVIN: So Hulk, let me ask you something.

MR. BOLLEA: Yes, sir?

MR. LEVIN: Because you know, this is happening so much now. And you're victimized here because you had no idea that there was a camera there. It must be extremely perilous for any celebrity to hook up with somebody, particularly somebody that you haven't met or don't very well, not knowing what the heck is going on in the house where you're having sex.

MR. BOLLEA: Well, yeah, I mean, talk about reality check. I mean, my God. I mean, who would have dreamed that, you know, camera phones would have been used, you know, for this type of vehicle?

You know, so I mean, thank God, you know, I met Jennifer, and she saved me, number one. I love her to death. And thank God that I'm not part of that stuff anymore. That's just why I don't understand the agenda of why someone would wait so long to do this. It's just insane to me.

MR. LEVIN: So there are people now saying, OK, well, we've seen this before. Kim Kardashian threatened suit and says, I'm going after anybody with a vengeance who would possibly release this. Paris Hilton does the same thing. But ultimately these tapes get released and they can't get released, David, as you know, without the person who was in that tape signing off.

MR. HOUSTON: Right.

MR. LEVIN: So there are skeptics saying, oh, well, this is just another one of those.

To that you say?

MR. HOUSTON: Absolutely not. And Harvey, there's a bit more. If you do it in the state of Florida, it's actually a felony because Florida remains, as Nevada and one other – I think,

Maryland – that has a two-party consent requirement for the release of any type of communication of this nature.

So a consequence of it is, it's not just a civil case where we're claiming outrage for the purpose of building up interest to sell it later. We'll see that criminal prosecution is brought forth. This is no feigned outrage to sell a tape. It's disgusting. Terry certainly isn't that type of person. Hulk and certainly Jennifer wouldn't approve of it if it were. It's a situation where he's just blatantly being taken advantage of and it's just outrageous.

MR. LEVIN: Hulk, can I make – can I crack one tiny joke here?

MR. BOLLEA: Sure, brother. Why not?

MR. LEVIN: Just because the one thing that I just found so funny is that you are so famous for your wrestling gear. And apparently in this video there is a suntan line that would reveal that whoever that person is -

MR. LATIBEAUDIERE: Stop dancing around it, Harvey.

MR. LEVIN: - was wearing a thong.

MR. LATIBEAUDIERE: Say it. He was wearing a thong.

MR. BOLLEA: Yeah, well, let me put – let me put it to you this way, brother. When you wrestle in the ring you don't want, like the girls, that tanning line, you know, with the underwear cutting into your cheeks. So basically when you wear these so-called tights in the wrestling ring, most of the guys wear a jock strap. I prefer a thong. But at the end of the day, let me put it to you this way. I use the thong, like, to lay in a sunbed, not out in public. But the main thing is, thank God that what my ex – you know, I don't even want to go there. But let's just say, thank God it wasn't a guy.

MR. HOUSTON: Yeah, well, that was the only thing we thought could be worse: if it was a young male. So we were grateful.

MR. LEVIN: OK, well -

MR. BOLLEA: You're brutal, David.

MR. LEVIN: That's your lawyer?

MR. LATIBEAUDIERE: That's your lawyer, right?

MR. LEVIN: OK, well, look, you guys, thank you so both so much for joining us. And let us know if you – if you find whoever did this because obviously we'd like to follow up on it.

MR. BOLLEA: (Inaudible.)

MR. HOUSTON: Yeah, and that's a promise. Whoever's done it, Harvey, if they're listening, back off and back off now. We will find you. It's not that difficult.

MR. LEVIN: OK. Whoever it is should take that as a threat and a promise.

MR. HOUSTON: (Inaudible) – the truth.

MR. LEVIN: OK, man. Thank you so much, both of you.
