**AFFIDAVIT OF ANDREW REISMAN**

ANDREW REISMAN, being duly sworn, deposes and says under penalty of perjury:

1. If called to testify as a witness in the above-captioned litigation, I would testify to the following facts.

2. I am employed as CEO of Elijah, a company specializing in computer forensics and electronic discovery services. My office address is 10314 NW 55<sup>th</sup> St., Sunrise FL 33351

3. During my tenure at Elijah I have had primary responsibility for hundreds of computer forensic engagements involving thousands of computers and other forms of electronic media, and have well over 10,000 hours of investigative experience on such engagements. I have earned industry certifications including EnCase Certified Examiner (EnCE), AccessData Certified Examiner (ACE), Certified Computer Forensic Examiner (CCFE), Certified E-Discovery Specialist (CEDS), Certified Fraud Examiner (CFE), Systems Security Certified Practitioner (SSCP) and Electronic Evidence Specialist (EES).

4. Elijah was retained by Thomas & LoCicero, LP, counsel for defendants Gawker Media, LLC, Nick Denton, and A.J. Daulerio (“defendants”) in the above-captioned litigation.

5. I oversaw the collection of the materials identified in this affidavit. The collection was done under my direction and control by Elijah employee, Iv Simaku. Mr. Simaku is no longer employed by Elijah.

6. On September 8, 2010, a tweet stating “Breaking out of jail <http://twitvid.com/5S0ET>” was posted to the Twitter account of the user @HulkHogan. *See* Defs.’ Trial Ex. 572 at GAWKER 26896 (attached hereto as Exhibit A).

8. The original tweet contained a link to the following webpage:

9. A screenshot of the web page referenced in ¶ 8 has been bates labeled GAWKER 26885 and is attached hereto as Exhibit B (Defs.’ Trial Ex. 571).

10. The webpage at <http://telly.com/5S0ET> at the time contained a video of Terry Bollea, who is known professionally as “Hulk Hogan.”

11. Elijah extracted the video file from the web page <http://telly.com/5S0ET> and preserved it as a file named “5S0ET.mp4”. A disk containing that video file is designated as Defendants’ Trial Exhibit 316 and is attached hereto as Exhibit C.

12. The video file and the pertinent data are preserved in a folder labeled GAWKER 27119, which is a true and accurate copy of the html, metadata, video, and associated files that Elijah preserved from the <http://telly.com/5S0ET> webpage that was linked to by the Twitter page <https://twitter.com/HulkHogan>. A disk containing that folder is attached hereto as Exhibit D.
