ORDER OF CONTINUANCE AND RESCHEDULING RETURN HEARING

It having come to the attention of this Court that one or both parties have demonstrated good cause to warrant a continuance of the return hearing in this cause and

- Petitioner appeared with counsel Alan Perlman, Esq. via Zoom
- Respondent appeared pro-se
- Parties stipulated in open court in writing;

it is

ORDERED AND ADJUDGED that the Temporary Injunction Without Notice entered herein shall remain in full force and effect until further Order of this Court. It is further ordered that the Clerk of Court shall immediately forward a copy of this Order together with a copy of the Temporary Injunction Without Notice, to the Pinellas County Sheriff's Office

OR

ORDERED AND ADJUDGED that the Petition for Temporary Injunction was DENIED previously and remains as such.

It is further **ORDERED AND ADJUDGED** that:

1. The return hearing on the Petition for Injunction for Protection Against Violence shall be rescheduled before the assigned Judge. The party or its representing counsel for whom this Order of Continuance is being granted shall be responsible for rescheduling the return hearing before the assigned judge as soon as possible;

OR

2. The return hearing on the Petition for Injunction for Protection Against Violence shall be rescheduled by the Clerk of the Circuit Court on the next available regular Domestic Violence Court (DVI) or Repeat/Stalking (RVI) calendar.

OR

3. The return hearing on the Petition for Injunction for Protection Against Violence shall be heard on:


July 9, 2021, at 10:00 a.m. p.m. before the Honorable Judge Presiding at

4. Other: Respondent's Motion to Continue is GRANTED to complete Discovery; Motion granted without objection of the Petitioner and Petitioner's counsel. Parties shall exchange discovery by June 29, 2021 at 12:00 P.M. and shall submit their anticipated witness list by June 25, 2021 at 5:00 P.M. Parties may amend their witness list after discovery has been exchanged but must submit to the Court by July 2, 2021 at 5:00 P.M. See Zoom information below.
