3     examined and deposed as follows:

4                                   DIRECT EXAMINATION

5     BY MS. MANUELE:

6             Q.     Could you please state your name and  
7     occupation for the record?

8             A.     Officer Brian J. Bunish. Occupation, police  
9     officer for the St. Petersburg Police Department.

10            Q.     And how long have you been with St. Pete?

11            A.     Four years.

12            Q.     Any prior law enforcement experience?

13            A.     Yes. I was with the Kansas City Police  
14     Department for 15 years.

15            Q.     And then you moved to paradise?

16            A.     I did.

17            Q.     We're here today because you have been listed  
18     as a witness in the State of Florida versus Cornelius  
19     Whitfield regarding a homicide and attempted homicide  
20     from February 1st and February 2nd of 2021. Are you  
21     familiar generally with the circumstances?

22            A.     Generally, yes.

23            Q.     Okay. And did you write, like, two  
24     supplements detailing your involvement?

25            A.     Yes.

1 Q. Okay. You don't have a copy with you?

2 A. I don't.

3 Q. Did you review them prior to coming in?

4 A. I did.

5 Q. There was, like, one paragraph.

6 A. Very short.

7 Q. In reviewing your supplements, was there  
8 anything that you found to be inaccurate that you would  
9 like to change?

10 A. No.

11 Q. Okay. And if you want to take a look or  
12 reference it for any reason, just let me know.

13 A. Okay.

14 Q. You can have a copy.

15 Tell me how you became involved in the case.

16 A. I became involved in the case because I did  
17 not go to the initial scene. I was -- I was dispatched  
18 to go to headquarters where I was given the directive to  
19 be posted outside the witness interview room to where no  
20 unauthorized personnel would come in.

21 Q. And do you know who was in the witness room?

22 A. I do not.

23 Q. Okay. Do you know if it was just one person  
24 or multiple people?

25 A. I do not.

1 Q. Okay. Did anybody go in or go out?

2 A. Just police, police detectives and police  
3 personnel.

4 Q. Were you to keep a log of any sort of  
5 personnel that went in the interview room?

6 A. No.

7 Q. Okay. What was your call sign back then?

8 A. Oh, that. I do not know that one.

9 Q. Some options that it could be?

10 A. 2020. So it was probably 3, probably 60  
11 something.

12 Q. Okay.

13 A. You know, off the top of my head.

14 Q. We won't hold to you it.

15 A. I was probably on evenings then.

16 Q. Evenings. What time was the evening?

17 A. It would have been from, like, 4:00 in the  
18 afternoon to 2:00 in the morning.

19 Q. Okay. So there's at least two witnesses.  
20 Officer Robison transported both witnesses back to the  
21 scene, you indicate in your report anyway.

22 A. Yeah.

23 Q. Did you transport anyone to or from?

24 A. No.

25 Q. Do you know if those witnesses, if it was a

1 man and a woman or two men or --

2 A. I don't recall.

3 Q. Okay.

4 A. You know Officer Robinson is no longer with  
5 us?

6 Q. I did know that. He --

7 A. He passed away last year.

8 Q. Oh, shit. I did not realize that. Okay.

9 A. Yeah. He's been sick for very long. He's  
10 been sick for a long time.

11 Q. I thought I had heard something bad, but I  
12 couldn't remember. That must have been what it was.  
13 And I looked automatically for like bad stuff, not  
14 tragic things.

15 A. Right.

16 Q. Sorry. So he was with St. Pete when he  
17 passed?

18 A. Uh-huh (Affirmative response).

19 Q. Would you have been equipped with a body  
20 camera on this day?

21 A. I would have.

22 Q. Do you know if you -- if it was ever  
23 activated?

24 A. It was never activated. Our cameras are never  
25 activated when we are in the police station.

1 Q. Okay.

2 A. So we're always told to turn it off.

3 Q. Why is that?

4 A. I would assume because of all the sensitivity  
5 that we have within the police station that we don't  
6 want nothing recording unless --

7 I would be able to turn it on if there was a  
8 situation arose to where I felt that I needed it.

9 Q. Okay. So it's not a situation where they  
10 just -- there's like a computer block or something, they  
11 won't go on in the building?

12 A. No, no. I could turn it on if the situation  
13 arose.

14 Q. Gotcha. Were you watching, from the interview  
15 rooms, were you at all like in the another room paying  
16 attention to what was going on in the interview room?

17 A. No. So as you walk in, there's like a little  
18 stand around a little lobby and then you've got like the  
19 four rooms.

20 Q. Is this the new department you would have been  
21 in?

22 A. Uh-huh (Affirmative response).

23 Q. And is that the extent of your involvement at  
24 the police station?

25 A. Yes.

1 Q. Where do you respond after that, if anywhere?

2 A. So my next report would have been, if the  
3 scene was held for a certain period of time, then  
4 officers would have took turns just patrolling or  
5 standing outside being posted outside the crime scene --

6 Q. Okay.

7 A. -- making sure that no one went in or out.

8 Q. Okay. And you were scene security?

9 A. Right.

10 Q. You are not in control of the crime scene log?

11 A. No.

12 Q. Okay.

13 A. No. That's just -- if the scene is being held  
14 for a particular period of time --

15 Q. Uh-huh (Affirmative response).

16 A. -- or they assume that the crime scene is  
17 going to last longer for, like, them collecting the  
18 evidence that they need, then certain officers will take  
19 turns and just be posted up there while they are on  
20 shift.

21 Q. Okay. And while you were posted up, did you  
22 overhear any lay witness statements or anything --  
23 either --

24 I'm guessing you were not questioning  
25 witnesses.



1 A. No.

2 Q. Did any witnesses or laypersons come by and  
3 make any statements in your presence?

4 A. No.

5 Q. Okay. And you said February 3rd, 2020. Is it  
6 fair to say that's supposed to be '21, right?

7 A. Yes, probably, yes.

8 Q. Okay. Just wanted to -- I assumed, but okay.  
9 Were you still on scene when they were doing  
10 any kind of, like, processing of the apartment? Do you  
11 know? Or do you know if they were processing while you  
12 were on scene?

13 A. No, I don't think anybody was on scene. I  
14 think we were just watching to make sure that no one  
15 went in or out.

16 Q. All right. As far as you know, have you ever  
17 had any contact with Cornelius Whitfield?

18 A. Not to my knowledge, no.

19 Q. February 16th, so a couple weeks after this he  
20 was arrested and there was a triple homicide. Were  
21 you -- so far as you know, were you ever on that scene  
22 at Emerson Avenue?

23 A. No, not -- not to my knowledge, no.

24 MS. MANUELE: Okay. I don't have any other  
25 questions.

FLORIDA RULES OF CIVIL PROCEDURE

Rule 1.310

(e) Witness Review. If the testimony is transcribed, the transcript shall be furnished to the witness for examination and shall be read to or by the witness unless the examination and reading are waived by the witness and by the parties. Any changes in form or substance that the witness wants to make shall be listed in writing by the officer with a statement of the reasons given by the witness for making the changes. The changes shall be attached to the transcript. It shall then be signed by the witness unless the parties waived the signing or the witness is ill, cannot be found, or refuses to sign. If the transcript is not signed by the witness within a reasonable time after it is furnished to the witness, the officer shall sign the transcript and state on the transcript the waiver, illness, absence of the witness, or refusal to sign with any reasons given therefor. The deposition may then be used as fully as though signed unless the court holds that the reasons given for the refusal to sign require rejection of

the deposition wholly or partly, on motion under  
rule 1.330(d)(4).
