RESULTS:

FIREARMS

Items 1 and 2

- The pistol was test fired using the submitted magazine and was found to be functional.

Items 3 and 4

- The pistol was test fired using the submitted magazine and was found to be functional.

Items 5 and 6

- The pistol was test fired using the submitted magazine and was found to be functional.

Items 7 and 8

- The pistol was test fired using the submitted magazine and was found to be functional.

AMMUNITION

Item 9

- The cartridge was test fired in the Item 1 pistol and used for microscopic comparison.

Items 15A-15C

- The cartridges were test fired in the Item 3 pistol and used for microscopic comparison.

CARTRIDGE CASES

Items 16, 20, 23 and 24

- The cartridge cases were **Identified** to the Item 1 pistol.

Items 17, 19 and 22

- The cartridge cases were **Identified** to the Item 5 pistol.

Item 18

- The cartridge case was **Identified** to the Item 3 pistol.

PROJECTILES

Item 21

- The bullet was **Inconclusive** to the Item 3 pistol.
- The bullet was **Eliminated** to the Item 5 pistol based on a difference in class characteristics.
- The bullet is 38 caliber class (38, 357, 9mm) based on its design features.

Items 25 and 26

- The bullets were **Identified** to the Item 1 pistol.

Item 27

- The jacket fragment was **Inconclusive** to Items 1, 3, 7, 21, 25, and 26.
- The jacket fragment was **Eliminated** to the Item 5 pistol based on a difference in class characteristics.

Items 28, 29 and 30A

- The bullets were **Identified** to the Item 5 pistol.

Items 30B and 30C

- The items are **No Value for Microscopic Comparison**.

CROSS REFERENCE RESULTS:

- The Item 1 and 2 cartridge cases submitted in FDLE case #20250301259 (St. Petersburg Police Department case #2021004037) were **Identified** to the Item 1 pistol.
- The Item 3A bullet submitted in FDLE case #20250301259 (St. Petersburg Police Department case #2021004037) was **Identified** to the Item 1 pistol.
- The Item 3A bullet submitted in FDLE case #20250301259 (St. Petersburg Police Department case #2021004037) was **Inconclusive** to Item 27.
- The Item 4 bullet submitted in FDLE case #20250301259 (St. Petersburg Police Department case #2021004037) was **Inconclusive** to Items 1, 25, 26, and 27.
- The Item 4 bullet submitted in FDLE case #20250301259 (St. Petersburg Police Department case #2021004037) was **Eliminated** to the Item 7 pistol based on a difference in class characteristics.

REMARKS:

Tests generated during examination are being returned in FDLE Items 1.1, 3.1, 5.1, 7.1, 9 and 15.

The method of testing for ammunition components (that have results that fall into the range of conclusions defined below) included physical examination and microscopic comparison. Elimination results that are reported as *based on a difference in class characteristics* include only physical examination.

- **Identified:** Agreement of all discernible class characteristics and sufficient agreement of individual characteristics where the extent of agreement leads to the conclusion that the items were fired in/from the same firearm.
- **Inconclusive (+):** Agreement of all discernible class characteristics and some agreement of individual characteristics but insufficient for an identification.
- **Inconclusive:** Agreement of all discernible class characteristics without significant agreement or disagreement of individual characteristics; therefore, the items could neither be identified nor eliminated as having been fired in/from the same firearm.
- **Inconclusive (-):** Agreement of all discernible class characteristics and some disagreement of individual characteristics, but insufficient for an elimination.

- **Eliminated:** Significant disagreement of discernible class characteristics and/or individual characteristics leading to the conclusion that the items were not fired in/from the same firearm.

No Value for Microscopic Comparison: The item was examined visually and microscopically. It lacks sufficient individual characteristics for microscopic comparison to other items.
