9	A Deputy Levi Blake. Last name is B-L-A-K-E.
10	Q Deputy Blake, my name is Maria DeLiberato. I'm
11	an assistant public defender. Myself and Nichole
12	Blaquiere represent Juan Molina-Salles. It is PCSO case
13	number SO22-305232. Ms. Constantine is here for the
14	State. She's having some issues with her audio, but she's
15	communicating in the chat, so we're ready to proceed.

What are the 14 changes now? 15 Α we all meet at a centralized location most of 16 the time, and then they come and get us and send us to our 17 job sites from there. 18 Okay. Α How far away was your traffic detail from Deputy 23 Q Hartwick? 24

As far as face-to-face, I don't remember whether I had physical 5 6 face-to-face contact with him or not. Do you think -- your memory is that you got your 7 Q 8 location for that night via text message? That would have been normal at the time, yes. 9 10 And do you remember what the instructions were Q 11 on the detail as far as what you were supposed to be 12 doing? 13 I don't remember what the instructions were. know that I was shutting down eastbound Bryan Dairy Road 14 15 at 49th Street. Okay. And when you shut down a road, do you 16 Q 17 typically like sit in your cruiser with lights on to sort of block the traffic? Is that how -- how do you shut down 18 19 a lane or direction of traffic? 20 So they shut it down for us by posting signs. cones, all those things on the roadway, and then they tell 21 22 us pretty much where they want our cars placed and how they want them placed specifically. 23 Okay. And -- but while you're sort of blocking 24

19	was also there?

21	Q And when you arrived, was he already performing		
22	CPR on Deputy Hartwick?		
23	A When I arrived, all lifesaving attempts had		
24	stopped at that point.		
25	Q Okay. And what was your role then once		

lifesaving attempts had stopped? I think you said it was 1 2 about four or five minutes that you got there, right? 3 Α Correct. 4 What did you do? 0 5 I put caution tape up in the area because there 6 was a lot of construction workers that were just walking around and walking through everything. So I put up the 7 caution tape in the area to stop them from doing that. 8 9 And it sounds like as part of your role, you're on the Major Accident Investigation Team. That's part of 10 vour role with the Sheriff's office? 11 12 It was at the time, yes. 13 Not -- you were at the time but not anymore? Q 14 Α That's correct. So you blocked off the scene. What else did you 15 Q 16 do? At that time, I had directed one of the 17 18 lieutenants to check his body to make sure there was no 19 gunshot wounds or anything of that nature. It was just assessing the scene and waiting for, you know, any further 20 direction from command staff because everybody was getting 21 22 there at that time. Okay. Did you interview anyone? 23 Q I did not interview anybody. 24 Α 25 And it sounds like after you -- there was a Q
