PETITION FOR WRIT OF HABEAS CORPUS AD TESTIFICANDUM

TO THE JUDGES OF THE SAID ABOVE-STYLED COURT:

The State Attorney in and for the Sixth Judicial Circuit of the State of Florida in and for Pinellas County shows this Court:

1. A criminal charge is pending in this county against JUAN ARIEL MOLINA-SALLES in the above styled cause.


State Attorney for trial preparation on 2/28/25 at 10 AM,

The JURY TRIAL in the above styled cause is expected to begin at 03/03/25 at 8:30 AM and expected to last approximately 5 days; however, there are various other factors that can cause delays in trials. As such, should the testimony in the above cause be delayed, the undersigned requests permission to have the witness through the end of the JURY TRIAL.

WHEREFORE, your Petition prays that this Honorable Court issue a Writ of Habeas Corpus Ad Testificandum directing the UNITED STATES MARSHAL SERVICE, to deliver the said DUGLAS HERNANDEZ-VALLADARES to the custody of the Pinellas County Sheriff, at the Pinellas County Jail, at 14400 49<sup>th</sup> Street North, Clearwater, Florida, 33762. Upon resolution of the above styled cause, DUGLAS HERNANDEZ-VALLADARES, may be returned to the custody of the UNITED STATES MARSHAL SERVICE to be returned to said US Marshal contract facility to serve the remainder of his sentence by the UNITED STATES MARSHAL SERVICE.
