Affidavit of Detective Bolton in Support of Second Phase of Arthur Hearing

Your Affiant, Detective Colin Bolton, is currently employed as a sworn police officer for the city of Largo and has been so employed since June 24, 2013. Your Affiant has attended the Police Academy through Hillsborough Community College. Your Affiant was assigned as a crime scene investigator in 2016. Your Affiant has been assigned as a detective in the Investigative Services Division (ISD) at the Largo Police Department since March 2022. Your Affiant is currently assigned to the Crimes Against Persons (CAP) section of that division.

On March 21,2023, your Affiant was assigned an investigation regarding a missing person, S.C. Your Affiant's investigation regarding the circumstances of the homicide of S.C. by the actions of Defendant Kosowski has previously been filed.

Your Affiant is aware that Defendant Kosowski was detained on March 25, 2023 in Tarpon Springs, Pinellas County, Florida.

Defendant Kosowski was in control of his Toyota Corolla when he was detained. A search warrant was signed and executed on his Toyota Corolla. This vehicle was seized, searched, and processed for evidence of this crime.

Your Affiant learned the contents of Defendant Kosowski's Corolla. This included over 280,000 dollars in cash. He also had in his vehicle masks (including ski masks, a black plastic face mask and a Guy Fawkes mask), duct tape, plastic brass knuckles, a stun gun, a Tracfone, multiple firearms, a ballistic vest with "EMS" written on it, patches for PCSO and Clearwater PD, industrial trash bags, a crowbar, and a vial of succinylcholine, a paralytic agent. (Please see attached photographs Exhibit A, B, C, D, E).

In his vehicle, were Defendant Kosowski's Polish Passport and his United States Passport.

Your Affiant is aware a search warrant was executed on Defendant Kosowski's Tarpon Springs home. Your Affiant was present for the execution of the search warrant. During execution of the search warrant, your Affiant observed license tags near the rear northwest corner of the garage. They were mixed in among some decorative faux tags. The license plates were from multiple states and included a trailer tag and two

motorcycle tags. The plates were from NH, NM, VT, MI, and FL.

Both of Defendant Kosowski's vehicles were equipped with tag

flipping devices. A button wired inside the cabin of both

vehicles allowed for the changing of tags while the vehicles

were in motion.

A soft sided, open top trunk storage container was located near the middle of the garage with multiple items inside of it including a box of disposable gloves, Toyota Corolla manuals, gun parts, tactical body armour plates, velcro patches embroidered with "EMS" and "SHERIFF" and a flashing light assembly for a vehicle. Numerous guns were located in multiple areas in the garage including a closet under the stairs, in a folding wagon near the middle rear area, on top of and inside of the trailer parked inside of the garage and inside four storage cases. In addition to numerous gun cases located inside of a closet in the garage, there were numerous ammo boxes and a large bowie knife inside of a sheath in the closet.

Your Affiant is aware that Defendant Kosowski is employed as a plastic surgeon. Defendant Kosowski was arrested with 280,000 dollars of cash. Also located inside the house were over one hundred rifles and a room full of guitars. The guns and the guitars were worth over tens of thousands of dollars. Defendant Kosowski owns a home on the water in Tarpons Springs, Florida.


