- 9 testified as follows:
- 10 DIRECT EXAMINATION
- 11 BY MR. BRUNVAND:
- 12 Q My name is Bjorn Brunvand. We're here on
- 13 State of Florida versus Tomasz Kosowski. Present
- 14 are Mr. Vonderheide, Ms. Spadaro, and the court
- 15 reporter.
- If you could please state your name,
- 17 Detective.
- 18 A Court reporter or me?
- 19 Q No, you. I'm sorry, Detective, yeah.
- 20 A That's okay. John Melton, detective with
- 21 Tarpon Springs Police Department.
- 22 Q And, Detective Melton, how long have you
- 23 been with the Tarpon Springs Police Department?
- 24 A This is my eighth year.
- 25 Q And any previous law enforcement

- 1 experience prior to Tarpon Springs?
- 2 A I do. I started with the Pinellas County
- 3 Sheriff's Office in 1989 and I left service with the
- 4 sheriff's office in 2008.
- 5 Q Okay. And did you prepare a report or
- 6 multiple reports detailing your involvement in this
- 7 case?
- 8 A Yes, sir.
- 9 One or more?
- 10 A I did one report under case number TS23,
- 11 dash, 7723 and assist other agency for the Largo Police
- 12 Department.
- 13 Q Okay. Have you had a chance to review
- 14 your report prior to coming in here today?
- 15 A Yes.
- 16 Q And I say coming in here today. We're all
- 17 appearing via Zoom. But having done these for so
- 18 long, saying come in here, I guess why I still use
- 19 that language.
- 20 Did your report appear to be complete and
- 21 accurate as to describing your involvement in this
- 22 case?
- 23 A Yes, sir. To my involvement, yes.
- Q Okay. The report that I have that appears
- 25 to be yours, the narrative part is about a

- 1 page-and-a-half. It starts out on page three of
- 2 mine and it says, "On 3/23/23 at 1700 hours,
- 3 Detective Warwick, Sergeant Crawford, and I were
- 4 assigned to assist Largo P.D. on a missing person
- 5 investigation."
- 6 A Yes, sir.
- 7 Q Would that appear to be the same report
- 8 that you're looking at?
- 9 A Yes, sir.
- 10 Q All right. Tell us what, what is the
- 11 initial information that you were provided with at
- 12 that time as it relates to this report.
- 13 A Sure. I got -- I was advised by Sergeant
- 14 Crawford that Largo Police department would be coming
- 15 to Tarpon Springs to conduct a missing persons
- 16 investigation. We were just put on standby because
- 17 there might be a search warrant involved and our CID
- 18 would go and assist them. To what level at that point
- 19 in time, I did not know what level of assistance we
- 20 would be providing. We just got put on standby.
- 21 So I had already -- you know, I had worked
- 22 my full day. This was roughly 5:00 p.m. on that day
- 23 and --
- 24 MS. SPADARO: Can I stop you. I'm really
- 25 sorry to interrupt. It just looked like we

- 3 MR. BRUNVAND: Okay.
- 4 THE COURT REPORTER: I mean the question
- 5 prior was with regard to did your report appear
- 6 to -- my timeclock's blocking it -- but as to
- describing your involvement in this case. And
- 8 then the answer was yes, sir, to my
- 9 involvement, yes.
- MR. BRUNVAND: Okay.
- 11 THE COURT REPORTER: Because I don't know
- 12 how many questions --
- MR. BRUNVAND: Yeah, I'm not sure. So I
- think we were just at the very early stages of
- 15 talking about what was taking place up in
- 16 Tarpon.
- 17 Q So why don't we -- Detective Melton, why
- 18 don't you start over and just tell us the
- 19 information that you had obtained --
- 20 A Sure.
- 21 Q -- and where you were standing and what
- 22 was happening early on in your investigation.
- 23 A Sure. So it would have been roughly 5:00
- 24 p.m. on March 23rd and Sergeant Crawford had notified
- 25 the folks that were here in NCID, which was myself and

- 1 Detective Warwick, that we were probably gonna have to
- 2 assist Largo Police Department in a missing persons
- 3 case.
- And at that, and at that point in time we
- 5 were just put on kind of standby to help them as
- 6 other information came in.
- 7 I don't know what information Sergeant
- 8 Crawford knew about it. I know Major Trill was
- 9 going in and out of Crawford's office, they were
- 10 having discussions, and I wasn't privy to their
- 11 discussions.
- But I just sat at my desk. I went out and
- 13 got food and I stood by. I stood by until -- I
- 14 can't tell you the exact time later. But at some
- 15 point earlier -- later than 5:00 but early in the
- 16 early evening hours I was told we were going to help
- 17 Largo serve a search warrant at a house at 511
- 18 Seaview in Tarpon Springs and it's possibly
- 19 involving a homicide case.
- 20 Q Okay. Were you familiar with 511 Seaview
- 21 prior to this?
- 22 A No.
- Q Okay. And do you, do you go to 511
- 24 Seaview at some point?
- 25 A Yes. So later that evening at roughly

- 1 11:00 -- it was just after 11:00, I'm not looking at my
- 2 report but I think it was roughly 11:09, we arrived on
- 3 scene.
- 4 I had been tasked to assist. I am not on
- 5 SWAT. There is a SWAT team that was tasked with
- 6 serving or assisting Largo in serving a search
- 7 warrant at the house.
- 8 My initial role was to be the lead car
- 9 leading the SWAT team up to the residence and then
- 10 taking -- establishing, like, a perimeter position
- 11 on the northeast corner of the property while the
- 12 SWAT team did their business.
- 13 Q Okay. So yesterday we spoke with a
- 14 witness, and I can't remember who it is, but that
- 15 witness's idea of where the northeast corner is on
- 16 the property and my idea was slightly different.
- 17 Where is the northeast corner of the
- 18 property?
- 19 A So my opinion is as you're facing -- when
- 20 you're standing in the roadway in front of 511
- 21 Seaview --
- 22 Q Right.
- 23 A -- and you're looking at the front door --
- 24 Q Right.
- 25 A -- the northeast corner would be that corner

- 1 of the property. Not entering the property, but you
- 2 just walk to the right toward Fred Howard Park to that,
- 3 to that corner that borderlines the roadway and the
- 4 north side of the property.
- 5 Q Sure. That would -- I would agree, that
- 6 would be the northeast corner. So we're on the same
- 7 page.
- 8 A Yeah. So that -- so, yes, that was -- if we,
- 9 if we extracted northeast, if you drove past the front
- 10 door of the property to the very next property line,
- 11 that's where I was in position.
- 12 Q Okay. Were you present for the briefing
- 13 with the SWAT team earlier? If you, you know --
- 14 A I was.
- 15 O Was that a few minutes earlier or when did
- 16 that take place?
- 17 A I don't know the exact time of that to be
- 18 honest, sir. However, it was in the -- within the hour
- 19 preceding 11:00 p.m. So we met at First Baptist Church
- 20 out there on Gulf Boulevard.
- 21 Q Okay. Is that also next to, like, a fire
- 22 department?
- 23 A It is next to Fire Station 70, yes.
- 24 Q Okay. And what do you recall about the
- 25 debriefing? Who was conducting it and what kind of

- 1 information was being presented?
- 2 A Largo -- I don't remember the officer's name
- 3 with Largo, the detective's name or what rank he had.
- 4 But it was a Largo officer who was explaining or just
- 5 telling us what they were doing, that they had the
- 6 search warrant, what they were looking for at the
- 7 house.
- 8 I come to find out later more information.
- 9 But at that time I did not know -- well, I knew they
- 10 were going to go to the house, that it was a
- 11 suspected -- involved in a homicide investigation
- 12 and that we were gonna -- our SWAT team was gonna
- 13 assist them in doing a search warrant at the house.
- Q Okay. Were you guys informed that they
- 15 did not believe that the suspect would be present at
- 16 the home?
- 17 A I don't recall that at that briefing. I do
- 18 recall that once we served the search warrant on the
- 19 scene, because I heard people talking and saying he's
- 20 possibly 15 minutes out. That's not -- that was not in
- 21 my purview. I was not engaged in that conversation. I
- 22 just overheard people saying I think he's 15 minutes
- 23 out.
- 24 Q And that's actually on the 25th, right,
- 25 not on the 23rd?

- 1 A Nope, that's on the 23rd. My only
- 2 involvement in this case is the night of the 23rd the
- 3 serving of the search warrant until about 2:00 a.m. on
- 4 the morning of the 24th.
- 5 So we served the search warrant just after
- 6 11:00 on the 23rd and then I completed my
- 7 involvement at 511 Seaview at 2:00 a.m. on the 24th.
- 8 Q Okay. So on -- is it on the 24th then
- 9 that you're hearing that he's 15 minutes out?
- 10 A No, that would be -- that would still be
- 11 before midnight on the 23rd.
- 12 Q And --
- 13 A I have to, I have to look at the body camera
- 14 just to get that exact time. But I know it's recorded
- 15 on that body camera. You hear chatter in the
- 16 background, radio chatter.
- 17 Q Okay, all right. And is the person that's
- 18 being referred to, is it your belief that that's Tom
- 19 Kosowski or someone else?
- 20 A Yes, Mr. -- yes.
- 21 Q Okay. Tom Kosowski?
- 22 A Yes.
- 23 Q Okay.
- 24 A I say Kosowki. Kosowski, sorry.
- 25 Q Yeah. Okay. So during the debriefing,

- 1 any photographs shared of the location, the back
- 2 yard, anything like that?
- 3 A Not during the briefing. Prior to leaving
- 4 the police department here we, we did look at
- 5 photographs of the house on Google, you know, just
- 6 typing the address in.
- 7 Q Okay. Like Google Earth type information?
- 8 A Yes. Just to -- just so we had where the
- 9 location of the house was. Especially since I was the
- 10 lead car in the motorcade I needed to know that it was
- 11 the second house north from where you make the
- 12 right-hand turn, that it was the second house north,
- 13 third house north, whatever it was. And so I
- 14 understood how far north I had to go.
- 15 Q Okay. And what about any printed-out
- 16 BOLOs or photographs of Tom Kosowski, was any
- 17 information like that shared?
- 18 A I don't recall any of that, sir.
- 19 Q Okay. What about Largo Police Department
- 20 showing photographs that they may have taken while
- 21 doing surveillance at the house prior to the search
- 22 warrant?
- 23 A I did not see any of those, sir.
- Q Okay. You say you covered the ground
- 25 floor entry door also on the east side. I'm trying

- 1 to remember. Is that next to the garage, or where
- 2 is that?
- 3 A So, okay, so from my position, my, my
- 4 direction was once the SWAT team had made entry to the
- 5 house there was a door that was -- if you're at the
- 6 stairwell or a stairway going up to the front, to the
- 7 left, so it would be on the south side of that
- 8 stairway, there's a entryway into the first floor, the
- 9 ground floor.
- 10 So once the SWAT team went in -- because
- 11 they went in up on the one floor above the ground
- 12 level --
- 13 Q Right.
- 14 A -- I came over, I came over and held that
- door in case somebody ran out of the house or something
- 16 like that and I held that door while the SWAT team went
- 17 through the house until such point as one of the
- 18 members of the SWAT team came out of that door.
- 19 Q Okay. Were you wearing any type of
- 20 recording device?
- 21 A I did.
- 22 Q A body cam of sorts?
- 23 A I did, yes.
- 24 Q Was it activated?
- 25 A It was.

- 1 Q Okay.
- 2 A And that video was downloaded and is in our
- 3 case file.
- 4 Q Okay. And you viewed it?
- 5 A I did.
- 6 Q And listened to it?
- 7 A Yes, sir.
- 8 Q Okay. And it appeared to capture the
- 9 things that you saw and experienced?
- 10 A Yes.
- 11 Q Okay. So the next thing that happens,
- 12 SWAT team completed the sweep and then you read the
- 13 search warrant?
- 14 A Yes. So we did not -- so, yes. So then
- 15 after the SWAT officers came out of that door I thought
- 16 that I was done and I went over to where the leaders
- 17 were huddling and then I was asked to read the search
- 18 warrant.
- I did not know that I was going to be
- 20 doing at that. And I -- it was made known to me
- 21 that a member of Tarpon Springs Police Department,
- 22 since the house was in our jurisdiction, needed to
- 23 read the search warrant. So they asked me to read
- 24 the search warrant and I did.
- 25 Q Okay.

- 1 A That is also captured on my body cam.
- 2 Q Okay. And then what happens? After you
- 3 read the search warrant, what do you do?
- 4 A I read the search warrant. And then I was
- 5 tasked with going into the ground level of the home
- 6 after the search warrant was read and performing a
- 7 search of the ground level for items that were in --
- 8 you know, listed in the search warrant and advised by
- 9 some members of the Largo Police Department.
- 10 Q So tell me about that. What -- so you're
- 11 conducting the search of the ground floor, the
- 12 garage area?
- 13 A Yes, sir.
- 14 Q Okay. And Largo -- who with Largo Police
- 15 Department is with you?
- 16 A Is with me. There's a detective that's
- 17 captured on my camera. His -- I can't remember. His
- 18 name was Jerry Hunt. That's his name. Jerry Hunt,
- 19 Detective Hunt. And he was in there with me on the
- 20 ground floor.
- 21 And later, later some forensic technicians
- 22 from the sheriff's office also come into the ground
- 23 floor. But I was told that they were looking for a
- 24 gray Toyota Tundra pickup truck, which we located on
- 25 the ground floor. I was also told that we could

- 1 possibly be looking for a body or body fluids, i.e.
- 2 blood. So we looked, we looked for those items.
- Also I was told we were looking for some
- 4 type of cart, like a, like a beach-style cart. And
- 5 we found a cart in the floor and I just pointed the
- 6 cart out to the Largo officers.
- 7 There was a freezer, like a, a long
- 8 five-foot-long deep freezer that we looked in when
- 9 we searched. There was nothing in there. It was
- 10 empty. It wasn't even plugged in.
- 11 There was a refrigerator. We looked in
- 12 the refrigerator and a small freezer associated with
- 13 that refrigerator. We looked in there. There was
- 14 just food items in the refrigerator. That was on,
- 15 plugged in.
- We, we looked for -- well, there was --
- 17 information was passed that he may have, he may have
- 18 used another car and put a body in the trunk of
- 19 another car.
- 20 And we actually found a tire in the
- 21 garage. I don't know if it was from the car or not.
- 22 But I pointed it out to the Largo officer that there
- 23 was a tire here. You know, if it was a small car
- 24 and they needed room in the trunk of the car, you
- 25 know, maybe he had to remove the tire. I just

- 1 pointed out there was just a covered tire in there,
- 2 spare tire, you know, for a car.
- 3 And then of course I -- you know, much of
- 4 what I did see would have been in that gray truck.
- 5 Q Okay. And tell us about that.
- 6 A So inside the gray truck, I opened the doors,
- 7 I did not find, you know, any, any body or anything
- 8 like that in the passenger compartment of the gray
- 9 pickup truck. But I did locate keys to the gray pickup
- 10 truck in the armrest console. Excuse me. I pushed the
- 11 button to open the tailgate. It did not open all the
- 12 way because there was a tonneau cover that was on it
- and we needed the keys for the tonneau cover to open
- 14 it.
- 15 Sergeant Crawford had located keys hanging
- 16 on a, on a key -- I don't know what you would want
- 17 to call it. It's like a key ring, but it's affixed
- 18 to a wall and you would hang your keys on it. Like
- 19 when you walked in your doorway, you left your keys
- 20 hanging there.
- 21 Sergeant Crawford found a set of keys
- there that he believed contained the tonneau cover
- 23 key. So he gave that key to me. I tried it or he
- 24 tried it. I can't remember who. I have to look at
- 25 the body camera, sir. We were able to open that

- 1 tonneau cover with the key.
- 2 I think it was me because I remember
- 3 saying so the -- it was like spring loaded and I
- 4 remember saying, here, can you grab this. Because I
- 5 didn't want it to slide open, you know, and rip open
- 6 across the top and damage or anything else.
- 7 So I remember saying to Sergeant Crawford,
- 8 hey, can you grab this so it doesn't, you know,
- 9 fling up and damage. I just didn't want to damage
- 10 the truck in any way.
- 11 So, anyway, we were able to open the
- 12 tonneau cover and to see into the bed of the pickup
- 13 truck where I saw what I believed to be or could
- 14 possibly have been blood in the back of the bed of
- 15 the pickup truck.
- There was, there was a stain. I don't
- 17 know if you'd want to call it a stain. There was
- 18 like a residue of a former fluid. It was -- had a
- 19 sheen to it that you could see that was distinctly
- 20 of a different color than the bed of the truck. And
- 21 I, and I just pointed that out to the officers and
- 22 to -- later to the forensic techs.
- 23 Q Okay. Then what do you do?
- 24 A Then I just stood by at that point in time
- 25 while the forensic techs came in and did their

- 1 photographing.
- 2 And, and I believe that they -- as it was
- 3 getting towards the time now 2:00 when I left, they
- 4 had performed a presumptive test on that, you know,
- 5 that discolored area in the truck, and it was
- 6 positive for human blood.
- 7 Q Okay. Presumptive test positive for human
- 8 blood or positive for blood?
- 9 A My understanding, it was human blood.
- 10 Q Okay, all right. But you'll leave that to
- 11 the experts?
- 12 A Yes, sir.
- 13 Q Okay, all right.
- 14 A I did not do the test. They did the test.
- 15 I'm not trained in that presumptive test. They, you
- 16 know, they executed it and that's what I was told.
- 17 Q Did they indicate -- do you recall them
- 18 saying this is positive for human blood or positive
- 19 for blood? Or you're not sure?
- 20 A It's sticking out in my mind that they said
- 21 human blood.
- 22 Q Okay. And who was present when they said
- 23 that?
- A I don't remember the tech's name, sir.
- 25 Q Okay.

- 1 A Would it be all right if I look in my report
- 2 and I'll see if it's in there?
- 4 report anytime you want to.
- 5 A Yeah, my report doesn't say that. I would
- 6 have to go, I would have to go and look at their
- 7 forensic report to tell you who it was.
- 8 Q Okay.
- 9 A And that's going to be associated with
- 10 Largo's case not my case. So I don't have it in front
- 11 of me.
- 12 Q Okay. Did someone from Largo -- going
- 13 back to the beginning of this. Did someone from
- 14 Largo contact you directly about becoming involved
- 15 and assisting in this case?
- 16 A I don't recall that.
- 17 Q Do you recall Largo calling you on the
- 18 phone?
- 19 A I don't recall that that night. I know that
- 20 in a, I know that in a subsequent, subsequent day I
- 21 spoke with Detective Bolton --
- 22 Q Okay.
- 23 A -- on the phone and provided him with a list
- 24 of the items that the sheriff's office had taken from
- 25 the house, you know, that he needed for the subpoena

- 1 return or the -- I'm sorry. Did I interrupt you?
- 2 Q No, no. I interrupted you. For the
- 3 subpoena return, or?
- 4 A Search warrant return. Excuse me, the search
- 5 warrant return.
- 6 Q Search warrant.
- 7 A Yeah.
- 8 Q All right.
- 9 A And I had contacted him with that information
- 10 and then I had to -- I met him at his police department
- 11 to give him the return, because he filed the return
- 12 with the State. Or with the clerk's office, excuse me.
- 13 (Ms. Ramos Wicks joins the virtual
- 14 deposition.)
- 15 Q So I know we've gone -- I think we've gone
- 16 through this. But other than the Google Earth
- 17 photographs, you had indicated that you have no
- 18 recollection of seeing any other photographs of the
- 19 property prior to going out to the property to
- 20 assist with the search.
- 21 A Somebody did come up with photos of the
- 22 interior of the property that they found off of -- I
- 23 don't know if it was -- I don't know what website it
- 24 was, sir. It was like real estate --
- 25 Q Okay.

- 1 A -- like realtor photos, like, if the house
- 2 had been for sale previously.
- And that was done -- the reason that's
- 4 done is for the, for the SWAT team, for the tach
- 5 team, to know what they're -- when they go into a
- 6 house to kind of get a general idea of the layout of
- 7 the house I'm guessing for their safety.
- 8 Like I said, I'm not on SWAT team or
- 9 anything like that. But I'm just looking at it from
- 10 a tactics perspective.
- 11 And I did see these pictures. I'm not
- 12 sure who generated those pictures or, you know,
- 13 what -- if it was realtor.com or Zillow or what. I
- 14 don't -- that I don't know.
- 15 Q But what about potentially having been
- 16 shown photographs that may have been taken by
- 17 members of the Largo Police Department the day prior
- 18 or a couple days prior?
- 19 A I don't -- I have no recollection of those
- 20 pictures, sir.
- 21 Q Okay, all right. Do you know whether or
- 22 not such photos exist?
- 23 A I do not.
- 25 the SWAT team to enter 511 Seaview?

- 1 A I'm -- I do not know. I do not know, no.
- 2 This is the right answer. I do not know. I can
- 3 speculate. But I don't want to speculate, sir.
- 4 Q Well, why don't you speculate. I mean as
- 5 long as you say I'm speculating, then you're okay.
- 6 A Well, just like I said earlier, right,
- 7 Major -- now Major Crawford, then Sergeant Crawford,
- 8 was talking with Major Trill. They had had some
- 9 meetings. So I'm gonna guess that that's where it came
- 10 down from.
- 11 Q Okay.
- 12 A I'm not privy to those meetings though. So I
- 13 don't know.
- 14 Q May they have had contact with Largo P.D.
- 15 independently of you and then --
- 16 A Oh, yes.
- 18 A Oh, yeah. It came down to me from -- through
- 19 Sergeant Crawford.
- 20 Q Okay. So Sergeant Crawford may be the
- 21 person to talk to about what kind of contact was had
- 22 between him and Largo P.D.?
- 23 A Yes, sir.
- Q Okay. What do you recall as far as
- 25 information that had been relayed to you about this

- 1 Toyota Tundra and what significance that might have
- 2 and why, why it was being sought?
- 3 A Basically the search warrant says they were
- 4 looking for a gray Toyota Tundra pickup that had Tundra
- 5 written on it, TRD Pro written on it. Just like the
- 6 truck we found in the garage.
- 7 Q Right.
- 8 A And that, that came out of the warrant. And
- 9 then in the warrant, you know, it talked about, it
- 10 talked about looking for blood and bodily fluids and
- 11 things like.
- 12 So I assumed it had been involved in a
- 13 homicide or that a homicide could have occurred or
- 14 the truck could have been involved in a homicide.
- Okay. And I guess I wasn't being real
- 16 clear. I was more curious about whether or not
- 17 there was any conversation or information provided
- 18 to you before you, you know, ended up reading the
- 19 search warrant about the Tundra and about what you
- 20 guys were looking for during this search.
- 21 A I'm sure there was. I don't remember any
- 22 exact, you know, specific conversations, but I'm sure
- 23 it was. Because when I was getting the advice from the
- 24 Largo detective about looking in the ground floor, you
- 25 know, they wanted to look in the back of that pickup

- 1 truck specifically.
- 2 Q Okay. And is this once you've entered the
- 3 property or is it prior to?
- 4 A This is after the search warrant has been
- 5 served. And it was either prior to going in or once we
- 6 went in the ground floor just in our conversation over,
- 7 you know, their advising me.
- 8 Q Okay. What about during the debriefing,
- 9 anything?
- 10 A I'm sure that there was something said, sir,
- 11 because obviously they were interested -- like I said,
- 12 it's in the warrant and they were interested --
- 13 Q Right.
- 14 A -- in the gray pickup.
- 15 Q But you don't recall the specifics?
- 16 A I don't, sir. But I was, I was there to form
- 17 a overwatch position on that northeast corner. I did
- 18 not know I was doing all this other stuff that I ended
- 19 up getting into.
- 20 Q Okay, all right. Was your recording
- 21 device activated during the debriefing?
- 22 A No. Yes. If you're talking about the
- 23 meeting that occurred prior to serving the search
- 24 warrant at First Baptist Church, no, it was not
- 25 activated.

- 1 Q Not. Okay. And what's the reason for
- 2 that?
- 3 A Not required to. They're talking about
- 4 tactical operations and I'm not required to have it
- 5 going during that.
- 6 Q Okay. Sometimes I'll see body cam
- 7 recordings that are activated with video only and
- 8 sound is turned off because of, you know, having
- 9 discussions about tactical issues and what have you.
- 10 Do you know whether or not your recording
- 11 might have been on recording video or was it just
- 12 not on at all?
- 13 A It -- all of our recorders have that -- I
- 14 think it's called pre-event recording.
- 15 Q Right.
- 16 A So if one of my officers doesn't have his
- 17 camera activated and has an interaction with the public
- 18 that results in a complaint, right --
- 19 O Yeah.
- 20 A -- I can go back and if -- within a certain
- 21 amount of time I can go back and I can bring up the
- 22 pre-event recording as long -- again, as long as it
- 23 hasn't been recorded over on --
- 24 Q Right.
- 25 A -- mistake and I can get video from it. It

- 1 does not give me audio. It only gives me video from
- 2 it.
- 3 Q Okay.
- 4 A So the camera is -- to answer your question,
- 5 the camera is always recording. But if it's not
- 6 marked -- you know, if it's not activated to record the
- 7 audio and the whole thing, like for a case, then
- 8 there's no audio and eventually it will go away.
- 9 Q Okay. Do you know the time -- so not just
- 10 the date, but the date and the time that the search
- 11 warrant was signed by Judge Federico?
- 12 A Not without looking at it. Not off the top
- 13 of my head.
- 14 Q Do you have a copy there with you?
- 15 A I do.
- 16 Q Okay. Take a look at it and see if that
- 17 information is on there.
- 18 A So on page four right above the signature it
- 19 says, "Done and ordered in Pinellas County, Florida the
- 20 23rd day of March 2023, Philip J. Federico" signed and
- 21 then underneath it "Philip J. Federico, Circuit Court
- 22 Judge, Sixth Judicial Circuit."
- 23 Q Okay. So it doesn't have a time?
- 24 A It just says 23rd day of March.
- 25 Q Okay. All right. Do you know whether or

- 1 not when you first arrived for the debriefing
- 2 whether or not the search warrant had already been
- 3 obtained? Or was there a delay awaiting to get the
- 4 search warrant?
- 5 A I was not -- I was told that they have the
- 6 search warrant. And --
- 7 Q Okay.
- 8 A -- and then my leadership said this is what
- 9 we're doing, so we did it. I was provided a copy of
- 10 the search warrant to read once we were on scene.
- 11 Q Was that the first time you saw the search
- 12 warrant when it was provided to you?
- 13 A Yes, sir.
- 14 Q Okay.
- 15 A And I'm pretty sure that's recorded on my
- 16 body camera.
- 17 Q The -- would you agree that the time that
- 18 you spent at 511 Seaview was approximately three
- 19 hours?
- 20 A Yes, sir.
- 21 Q 11:09 I think is when it starts. And when
- 22 do you, when do you leave the following morning?
- 23 A At 02 a.m.
- Q Okay. So just shy of three hours?
- 25 A That's correct.

- 1 Q Okay. You discussed generally what you,
- 2 what you did during those three hours. How long did
- 3 it take for the SWAT team to clear the house once,
- 4 once you arrived, if you recall?
- 5 A I don't know the exact time of that, sir. I
- 6 would have to, you know, go to the body camera and
- 7 physically --
- 8 Q Okay.
- 9 A -- physically review it.
- 10 Q Okay. But it's your belief that the body
- 11 camera records the entire time that you're there,
- 12 right?
- 13 A My body camera does not run consistently from
- 14 11:09 to 02.
- 15 Q Okay.
- 16 A There's a period of time outside of the house
- 17 that my body camera is shut off.
- 18 Q When it's shut off, what are you doing
- 19 when it's shut off?
- 20 A Probably just standing there not engaged in
- 21 any kind of action.
- 22 Q Okay. Are you waiting for something or --
- 23 at that point?
- A No. I just wasn't tasked with anything.
- Okay, all right. Do you know whether or

- 1 not a copy of the search warrant was left at the 511
- 2 Seaview?
- 3 A I was told that Detective Miller had left
- 4 the copy there.
- 5 Q Okay. Would that include the affidavit
- 6 or -- in support of the search warrant or just the
- 7 search warrant, as far as you know?
- 8 A I don't know.
- 9 Q Okay. What about the search warrant
- 10 inventory?
- 11 A The search warrant --
- 12 Q I'm sorry. Go ahead.
- 13 A No, that's okay. So the search warrant
- 14 inventory -- I'm just looking at my report here.
- 15 So I went back to the residence the next
- 16 day on 3/24 and left a copy of everything that was
- 17 taken and left a copy on the door. I affixed it to
- 18 the door. Because the door was shut and locked.
- 19 The city crew had come out -- according to
- 20 the report, the city crew had come out earlier that
- 21 morning and had locked the door, you know, secured
- 22 the front door. And I went back out, the door was
- 23 secured, and I had taped a copy -- with Evidence
- 24 tape I had taped a copy of the items removed from
- 25 the house to the front door as well.

- 1 Q I may have already asked you this. But
- 2 were you paired up with a Largo Police Department
- 3 officer or detective for your portion of the search?
- 4 A I was advised by, yes, that previous Largo
- 5 police officer that I told you his name.
- 6 Q Hunt?
- 7 A Jerry Hunt.
- 8 Q Okay. Were there different teams that
- 9 were assigned to search different parts of the home?
- 10 A I believe. I wasn't -- I didn't -- I wasn't
- 11 part of giving out those assignments.
- 12 Q Okay. Do you know who would have given
- 13 out those assignments?
- 14 A I don't. Maybe, maybe Sergeant Crawford.
- 15 Q Okay. Sergeant Crawford would make the
- 16 most sense, right?
- 17 A Yep. Yes, sir.
- 18 Q And I'm assuming based on what you just
- 19 said that you don't know how many search teams there
- 20 may have been?
- 21 A I don't.
- 23 organized the rest?
- 24 A That's correct.
- 25 Q Do you, do you know Detective Compton with

- 1 Largo Police Department?
- 2 A Not by -- maybe if I saw a picture of him.
- 3 But not off the top of my head, no.
- 4 Q Okay, all right. Do you know anything
- 5 about whether or not Detective Compton or someone
- 6 else found some lingerie or took some lingerie into
- 7 evidence during the search warrant?
- 8 A I am not aware of that, no.
- 9 Q Okay. You didn't collect any lingerie?
- 10 A I collected nothing from the house.
- 11 Q Okay. Did you witness -- during the
- 12 search of the Tundra, you had indicated that Hunt
- 13 was with you. Did you also -- do you know whether
- or not Detective Bolton was also there when you were
- 15 searching the Tundra?
- 16 A There is another -- my answer is no. There
- 17 is another person that appears on body camera in the
- 18 garage, a detective. I don't know the detective. I
- 19 don't know his name off the top of --
- 20 Q Okay. So it could be Detective Bolton,
- 21 you just don't know?
- 22 A That's correct.
- 23 Q Okay. And did either one of them enter
- 24 the car, the Tundra?
- 25 A I have no knowledge of that.

- Okay. When you reviewed the -- your body
- 2 cam, did you recall seeing either one of them
- 3 entering the Tundra?
- 4 A I do not recall seeing anybody else enter
- 5 other than me.
- 6 Q Okay. Was -- did you -- were you wearing
- 7 gloves during the search warrant?
- 8 A Yes.
- 9 Q Did you have any type of shoe covers on
- 10 during the search warrant?
- 11 A I do not recall having shoe covers on.
- 12 Q Okay. Do you recall seeing anyone else,
- 13 like Detective Bolton or Hunt, wearing shoe
- 14 covers --
- 15 A I do not --
- 16 Q -- during the search warrant?
- 17 A I do not recall seeing anybody else with shoe
- 18 covers.
- 19 Q Okay. What are you, what are you wearing
- 20 during the search warrant? Do you have --
- 21 A I am wearing a -- so I wear khaki trousers
- 22 with, with a polo shirt.
- 23 Q Okay. Like a, like a --
- 24 A Not now, it's cold in here, but it's not --
- 25 Q Okay.

- 1 A And then I wear -- you know, I had a -- I had
- 2 my tactical vest on I believe. I do not recall which
- 3 boots I had on that day or shoes I had on that day.
- 4 Q Other than, other than wearing gloves, did
- 5 you wear anything else that would -- the purpose of
- 6 which would be to further preserve the crime scene
- 7 as far as -- we already talked about the shoe
- 8 covers. You didn't wear those. You know, any type
- 9 of bodysuit or anything like that?
- 10 A I did not wear a bodysuit.
- 11 Q Okay. Do you know whether or not the
- 12 Toyota Tundra was driven out of the garage prior to
- 13 being loaded onto the tow truck?
- 14 A I do not. That occurred after I had left.
- 15 Q Okay.
- 16 A When I left, the Tundra was still in the
- 17 garage.
- 18 Q Okay. And presumably you don't know
- 19 anything about what happened to the Tundra once it
- 20 was towed and went to impound? Do you know anything
- 21 about that?
- 22 A I do not. I was not involved.
- 23 MR. BRUNVAND: Okay. So Willengy Ramos
- Wicks from my office has joined us.
- Do you have any questions, Willengy?

Page 37 1 MS. RAMOS WICKS: I don't have any 2 questions. 3 MR. BRUNVAND: Okay. Anyone else have any 4 questions? 5 MR. VONDERHEIDE: No questions. No questions. 6 MS. SPADARO: 7 MR. BRUNVAND: Okay.
