- 1 DEPOSITION IN DISCOVERY
- 2 TODD TENSLEY
- 3 Pursuant to notice duly given, the deposition of
- 4 TODD TENSLEY, called by the Defendant in the
- 5 above-styled cause, was taken by me, a Notary Public in
- 6 and for the State of Florida at Large, at the time and
- 7 place and in the presence of counsel enumerated on
- 8 Page 1 hereof.
- 9 Thereupon, it was stipulated and agreed by and
- 10 between the attorneys for the respective parties, by and
- 11 with the consent of the said TODD TENSLEY, that
- 12 signature to the said deposition be preserved.
- 13 THE COURT REPORTER: Do you swear or affirm
- the testimony you'll give will be the truth and
- 15 nothing but the truth?
- 16 THE WITNESS: I do.
- 17 TODD TENSLEY, having been first duly sworn, upon
- 18 interrogation in discovery, testified as follows:
- 19 DIRECT EXAMINATION
- 20 BY MS. POWERS SELLERS:
- 21 Q. Sir, can you please state your full name?
- 22 A. It's Todd Tensley.
- 23 Q. And what's your date of birth?
- 24 A. 7-17-1985.
- 25 Q. Have you ever taken a deposition before?

- 1 A. Not that I recall.
- 2 Q. Okay. So my name is Amanda Sellers. I
- 3 represent, along with Mr. Brunvand's office,
- 4 Dr. Kosowski.
- 5 And you've been subpoenaed to testify this morning
- 6 under oath.
- 7 Your only job is to tell the truth. If you don't
- 8 know the answer to a question, just let me know. I can
- 9 rephrase, or you can say I don't know.
- 10 And with that, we will get going.
- 11 You're a resident of Pinellas County?
- 12 A. Yes.
- 13 Q. And where do you work?
- 14 A. Tampa Bay Vet Specialists.
- 15 Q. What is your position?
- 16 A. Nurse manager.
- 17 Q. How long have you been working there?
- 18 A. Two years. A little over two years.
- 19 Q. And are you related to Dr. Michelle Tensley?
- 20 A. Yes.
- 21 Q. How so?
- 22 A. She's my wife.
- Q. How long have you all been married?
- 24 A. Eleven years. Ten years.
- 25 Q. Okay. Prior to living in Pinellas County,

- 1 have you lived anywhere else?
- 2 A. Yes.
- 3 Q. Do you have any arrest record or any criminal
- 4 charges where you've been -- you've had to go to court?
- 5 A. No.
- 6 Q. Okay. Did you speak to anyone prior to today
- 7 about getting the subpoena and having to come and
- 8 provide testimony?
- 9 A. As far as -- like, I wasn't actually
- 10 subpoenaed.
- 11 Q. Okay.
- 12 A. I talked to the state attorney, asking if I
- 13 got subpoenaed, and to schedule my meeting with you guys
- 14 today.
- 15 Q. Thank you for that.
- 16 Have you spoken to anyone about this case in
- 17 general?
- 18 A. No. Well --
- 19 O. And --
- 20 A. We -- by that, like, anybody or specific
- 21 people?
- Q. Anyone.
- 23 A. Just from the investigation early on.
- 24 Q. Okay. And what was the context of those
- 25 conversations?

- 1 A. It's with my witness statement.
- 2 Q. Are you talking about your discussion with law
- 3 enforcement?
- 4 A. Yes.
- 5 Q. All right. And I know you live, obviously,
- 6 with Dr. Tensley, who's your wife. Have the two of you
- 7 had any conversations about this case?
- 8 A. No.
- 9 Q. Okay. Have you had any conversations about
- 10 security in the building and just in general?
- 11 A. Yes.
- 12 Q. Okay. Tell me about those conversations.
- 13 A. As part of the management team, we talk about
- 14 security issues within the building, concerns that, you
- 15 know, arise with our staff and the public.
- 16 Q. Were there any discussions about locking
- 17 doors?
- 18 A. I don't recall.
- 19 Q. Have there been any issues with individuals
- 20 leaving doors unlocked?
- 21 A. We have self-locking doors, so, no.
- 22 Q. Tell me about those. So when you walk in the
- 23 door, it automatically locks behind you?
- A. Right. Like, you can walk out, but you have
- 25 to have a key or a code to get in, except for the front

- 1 door.
- 2 Q. And then once you get in with the code, what
- 3 happens with the lock?
- A. Once it shuts behind you, it's locked again.
- 5 Q. Okay. How many -- do you work in Building A
- 6 or Building B primary?
- 7 A. I work in Building A, primarily.
- 8 Q. And how many entrances are there to your space
- 9 in Building A?
- 10 A. At least five.
- 11 Q. And all five of those doors have self-locking
- 12 locks?
- 13 A. Yes.
- 14 Q. How many entrances are there in Building B?
- 15 A. I'm not sure.
- 16 Q. Did all of the doors have self-locking locks
- 17 back in March of this year?
- 18 A. In which building?
- 19 O. Both.
- 20 A. I can only speak to Building A. All of them
- 21 still had self-locking locks. It just didn't have a
- 22 combination on them. Only one of them got updated to a
- 23 combination.
- Q. And so the only difference is one got a
- 25 combination. The others all still automatically locked

- 1 once they were closed?
- 2 A. Correct.
- 3 Q. And you are unaware of the status of the locks
- 4 in Building B?
- 5 A. Correct.
- 6 Q. Okay. I want to talk to you about an incident
- 7 that occurred back on March 14th, 2023.
- 8 Do you recall speaking to Ms. Heinrich about an
- 9 incident that day?
- 10 A. Yes.
- 11 Q. And how did you come to find out about that
- 12 incident?
- 13 A. I was texted with a notification that Deb had
- 14 encountered a person in the closet next door. And they
- 15 wanted me to come next door to help check the area, to
- 16 make sure they were safe.
- 17 Q. Did you do so?
- 18 A. I did.
- 19 Q. What did you do to check the area?
- 20 A. We walked through the entire building. And I
- 21 went up into the electric closet, and then up on the
- 22 roof, just to see if there was anything noticeable up
- 23 there.
- Q. Was there anything out of the ordinary on the
- 25 roof?

- 1 A. Nothing out of the ordinary on the roof.
- 2 O. And what about in the closet?
- 3 A. Yes. There were some things that were found
- 4 that weren't normally supposed to be there.
- 5 Q. And what was that?
- 6 A. A box. A large box.
- 7 Q. Do you -- did you know at that time what was
- 8 in the box?
- 9 A. I didn't.
- 10 Q. Did you open the box?
- 11 A. I did.
- 12 Q. When did you open it?
- 13 A. That -- the moment we walked into the closet
- 14 and noticed, like, this doesn't belong here.
- 15 O. What was inside the box?
- 16 A. It appeared to be a wagon.
- 17 Q. Did you see -- so inside the box, was there
- 18 another box?
- 19 A. No.
- Q. What color was the wagon?
- 21 A. It appeared to be blue in color.
- 22 Q. And can you describe what kind of wagon it
- 23 was?
- 24 A. No.
- 25 Q. Do you recall seeing wheels on it?

- 1 A. Yes.
- Q. Were they small wheels or large wheels? Do
- 3 you know the approximate size?
- 4 A. I would say they were larger than small
- 5 wheels. Probably, you know, like, that big
- 6 (indicating.)
- 7 Q. Okay. Did you notice what kind of wagon? Was
- 8 there a brand on it?
- 9 A. I didn't notice a brand.
- 10 Q. Did you remove the wagon from the box?
- 11 A. I did not.
- 12 Q. What did you do after opening the box and
- 13 determining it was a wagon?
- 14 A. Closed it back up and left it there.
- 15 Q. And was there anything else in that closet?
- 16 A. I don't recall.
- 17 Q. Do you recall a lighter of sorts being found?
- 18 A. There was -- there was -- there was a lighter
- 19 somewhere in that closet.
- Q. And do you recall the room having any
- 21 particular smell?
- 22 A. Which room?
- 23 O. The closet.
- A. No. Not at that time.
- Q. And this is the utility closet; correct?

- 1 A. Correct.
- Q. Where exactly is the utility closet located --
- 3 A. It is --
- 4 Q. -- in reference to the main entrance?
- 5 A. For Building B, it's in -- it's behind the
- 6 bathrooms.
- 7 Q. And that particular door that is on the
- 8 utility closet, is there a lock on that door?
- 9 A. Currently, yes.
- 10 Q. Back on March 14th, was there a lock on it?
- 11 A. No.
- 12 Q. What about a week later?
- 13 A. I don't recall.
- Q. Do you recall when the lock was placed on that
- 15 door?
- 16 A. I don't recall.
- 17 Q. Did you put the lock on the door?
- 18 A. I did not.
- 19 Q. The -- after you found the wagon, where did
- 20 you go?
- 21 A. I believe we walked through the rest of the
- 22 building, through the vacant rooms.
- Q. And did you see anything or anyone out of the
- 24 ordinary?
- A. Not at that time, no.

- 1 Q. Did Ms. Tensley -- I mean, Ms. Heinrich, what
- 2 did she tell you whenever you were notified about this
- 3 wagon?
- 4 A. She told me that that wasn't there before.
- 5 Q. At that time, did she say that she had saw
- 6 anyone suspicious?
- 7 A. Well, as soon as I met her at that building,
- 8 she told me exactly what had happened to her.
- 9 Q. Okay. Can you elaborate on that?
- 10 A. She said she was walking back to the
- 11 electrical closet because that's where some of her
- 12 supplies are, and the lights were off, and she opened
- 13 the door. And there was a guy standing right there.
- 14 And it scared her. And he just walked away from her and
- 15 left. And that's what she told me.
- 16 Q. Did she tell you what he looked like?
- 17 A. She described him as a taller guy, dark hair,
- 18 glasses and -- no, not glasses -- but a mask and a hat.
- 19 O. What kind of mask?
- 20 A. Like a surgical mask, like one that, you know,
- 21 everybody wears nowadays.
- 22 Q. Did she say what kind of hat?
- 23 A. She did not say. Just a baseball hat.
- 24 Q. Did she tell you what kind of clothes or what
- 25 color?

- 1 A. I don't recall if she did.
- 2 Q. So after seeing that individual, seeing the
- 3 box that didn't belong, she then comes to get you all --
- 4 you. You all go to the closet, and then you check all
- 5 the empty rooms.
- 6 Did you walk around the parking lot?
- 7 A. No.
- 8 Q. Did you notify any of the other businesses in
- 9 the building?
- 10 A. Myself, did not, no.
- 11 Q. Do you -- are you aware of whether -- whether
- 12 or not she did?
- 13 A. I am not sure if she did.
- 14 Q. How large was the box?
- 15 A. It was probably about three and a half, four
- 16 feet tall. I don't recall how wide.
- 17 Q. What do you -- you had mentioned that
- 18 Ms. Heinrich, that's where she keeps her -- her
- 19 supplies. What kind of supplies does she keep in that
- 20 closet?
- 21 A. In that closet, it would have been light bulbs
- 22 for the rest of that building.
- 23 Q. Do you recall seeing sandpaper, foam?
- 24 A. I don't recall.
- 25 Q. Okay. Do you recall speaking with Detective

- 1 Compton --
- 2 A. I -- yeah. I don't recall the name, but I
- 3 recall speaking to a detective.
- Q. Okay. Well, you had indicated to them that
- 5 there was sandpaper, foam, and a torch on this shelving.
- 6 A. Okay. Yeah. I remember there was stuff being
- 7 in there. I don't remember exactly what it was. Like,
- 8 the biggest thing that stuck out was the box that was
- 9 out of the ordinary to see.
- 10 Q. When you saw -- you described the lighter as a
- 11 torch. Can you elaborate on that? What kind of
- 12 lighter? What kind of torch? Is it one and the same?
- 13 A. I guess it would be a lighter torch, like, the
- 14 shape of a gun with a handle, and then the torch comes
- 15 out here.
- 16 Q. Did you see if it was working?
- 17 A. We threw it away. That's all we did.
- 18 Q. And the other items that you found with --
- 19 other than the wagon, do you recall throwing those away?
- 20 A. No.
- 21 Q. If there was sandpaper or foam in there, is
- 22 that something that would be a supply used for
- 23 maintenance?
- A. I don't know.
- Q. What stood out to you about the torch itself

- 1 or the lighter?
- 2 A. The fact that it was sitting all by itself on
- 3 the shelf with -- just kind of by itself.
- Q. What did you think that it might have been
- 5 used for?
- A. I initially thought it was about someone maybe
- 7 using it for drugs.
- 8 Q. And what made you come to that conclusion or
- 9 that suspicion?
- 10 A. The style of the torch.
- 11 Q. Had there been individuals in that area that
- 12 were suspected of using drugs? Homeless people, that
- 13 you're aware of?
- 14 A. There's been homeless people.
- 15 Q. And what was your experience with the homeless
- 16 people in that area?
- 17 A. They use our fountains outside the building to
- 18 get water or spray themselves off.
- 19 Q. Is that a pretty common occurrence?
- A. Not common, no.
- Q. But it's happened more than once?
- 22 A. Yes. In the two years that I've been here,
- 23 yes.
- Q. Would you say several times?
- 25 A. I would say maybe four times in the two years.

- 1 Q. Have you ever called and reported to law
- 2 enforcement that there's people loitering in the area?
- 3 A. Not myself, no.
- 4 Q. Are you aware of other individuals calling the
- 5 police?
- 6 A. Yes.
- 7 Q. And tell me about those occurrences.
- 8 A. That would have been our front desk staff
- 9 calling about people at night loitering in the park --
- 10 parking lot.
- 11 Q. And when you say at night, is that after
- 12 people have left for the day, or during regular business
- 13 hours?
- A. We're 24-7 hours here, so.
- 15 Q. Okay. After throwing away --
- MS. POWERS SELLERS: Sorry. I am working from
- 17 home, and my daughter is here sick today, so I
- apologize for the background noise.
- 19 Q. (By Ms. Powers Sellers) The -- whenever you
- 20 threw away the lighter, threw away the torch, checked
- 21 all the offices, what did you do? Did you report this
- 22 to someone?
- 23 A. We took it to our administrative assistant to
- 24 let her know to potentially file a police report about a
- 25 suspicious person in the building.

- 1 Q. And who is that?
- 2 A. Christy Green.
- 3 Q. Are you aware of whether or not she followed
- 4 up with that?
- 5 A. Yes.
- 6 O. And what was the outcome? Did law enforcement
- 7 respond?
- 8 A. They did not respond. They, I guess, took the
- 9 information and just let it be at that, as far as I'm
- 10 aware.
- 11 Q. Are you familiar with the cameras in the area?
- 12 A. For our building?
- 13 O. Yes.
- 14 A. Yes.
- Q. Who is responsible for those cameras?
- 16 A. I am not sure.
- 17 Q. Do you know who installed them?
- 18 A. I do not.
- 19 Q. Do you know where they maintain the
- 20 recordings?
- 21 A. I believe it's in the cloud, so I'm not sure
- 22 where they maintain them.
- 23 Q. Are you aware of all of the locations of the
- 24 cameras?
- 25 A. Yes.

- 1 Q. And whenever Ms. Heinrich came to you about
- 2 this unknown individual in the utility closet, are you
- 3 aware of whether anyone decided to pull camera footage
- 4 to see who this individual might be?
- 5 A. I don't recall.
- 6 Q. Is that something that you thought about at
- 7 the time?
- 8 A. I don't recall.
- 9 MS. POWERS SELLERS: Give me just a moment.
- 10 Let me look at my notes.
- 11 Q. Okay. Let's -- between March 14th and
- 12 March 21st, were there any other incidents that you are
- 13 aware of, of unknown individuals in or around the area?
- 14 A. Not that I'm aware of.
- 15 Q. Did you work on March 21st, 2023?
- 16 A. Yes.
- 17 Q. And did you work on March 20th, the day
- 18 before?
- 19 A. I would have to check my schedule.
- 20 Q. Okay. Do you remember what time you arrived
- 21 at work on the 21st?
- A. Approximately 5:00 a.m.
- Q. Was it still dark at that time?
- 24 A. Yes.
- Q. What building did you enter at 5:00 a.m.?

- 1 A. Building A.
- 2 Q. And what does your typical workday look like?
- A. As far as?
- 4 Q. When you arrive at the office, where do you
- 5 go?
- 6 A. When I come in, I go into the ER and check on
- 7 the staff that's there, first thing.
- 8 Q. Do you remember any specific times that you
- 9 may have walked to Building B that morning?
- 10 A. Yeah. Yes. I either would have gone right to
- 11 our building where our people were and checked in with
- 12 them and let them know that I was there.
- And then I would walk around Building B to make
- 14 sure the lobby door and our admin office door was
- 15 locked. And I would walk around the building or drive
- 16 around the building prior to entering Building A.
- 17 O. And were those doors locked?
- 18 A. Yes.
- 19 Q. Did you check every external door to see if
- 20 they were locked, or just those two?
- 21 A. Just those two.
- 22 Q. So when you say you walk around Building B, do
- 23 you walk around the entire building --
- A. Yeah.
- Q. -- or just by those --

- 1 A. Yeah. The way the layout is, I end up
- 2 essentially walking around the entire building.
- 3 Q. And when you walked around the entire
- 4 building, did you see any individuals?
- 5 A. At that time of the morning, I did not.
- 6 Q. And about what time was it that you did that
- 7 walk-around?
- 8 A. It would have been around 5:00 a.m., between
- 9 5:00 and 6:00.
- 10 Q. Did you see any homeless people at that time?
- 11 A. I did not.
- 12 Q. Before we get on -- into the events of March
- 13 21st, I'm going to go -- rewind the day before.
- And it appears in your conversation with law
- 15 enforcement, that you were, in fact, working on the
- 16 20th.
- 17 There was a discussion about homeless people in
- 18 cars or homeless people with carts loitering around the
- 19 premises.
- 20 Can you elaborate on that?
- 21 A. Yeah. We had a couple that parked their car
- 22 in our parking lot and were pulling a cart through our
- 23 parking lot. And by the time -- go ahead.
- Q. What kind of cart were they pulling?
- 25 A. I don't recall.

- 1 Q. Was it a wagon-type cart or was it a
- 2 grocery-type cart.
- 3 A. I wouldn't say -- I wouldn't say it was a
- 4 wagon or a grocery. It was, like, maybe a luggage cart,
- 5 kind of a more vertical cart.
- Q. Was it -- do you recall what color it was?
- 7 A. I can't say, because it was dark out.
- 8 Q. And you were about to say something, and I
- 9 interrupted you.
- 10 A. I don't know what I was going to say.
- 11 Q. Okay. So you saw a couple pulling a cart.
- 12 Did you see them get into a vehicle?
- 13 A. I did not.
- 14 Q. And did you see other individuals in a vehicle
- 15 at some point?
- 16 A. I didn't see them, but my staff reported it to
- 17 me.
- 18 Q. Are you aware of when they saw a couple in a
- 19 cart -- and I mean, in a vehicle?
- 20 A. It would have been around 4:00 to 5:00 a.m.
- 21 Q. Did you personally see the couple pulling a
- 22 cart?
- 23 A. Yes.
- Q. What time was that?
- 25 A. I don't recall the exact time. It would have

- 1 been early morning, still.
- 2 Q. Would it have been around the time that you
- 3 would be doing that perimeter check?
- 4 A. It would have been after. Like --
- Q. But it was still dark?
- 6 A. Right. It would have been between 5:00 and
- 7 6:00 a.m.
- 8 Q. And where exactly did you see them?
- 9 A. They were in our back parking lot.
- 10 Q. The wagon or cart that they were pulling, do
- 11 you remember if that had two wheels or four wheels?
- 12 A. I don't recall.
- Q. What kind of vehicle -- do we know if the
- 14 couple that you saw is the same couple that you saw in
- 15 the Nissan Rogue, or are those two different incidents?
- 16 A. It was the same couple.
- 17 Q. Did you address them?
- 18 A. I don't remember if it was myself that did it
- 19 or one of the other staff members.
- Q. And would that have been on Sunday, the 19th?
- 21 A. I don't recall.
- 22 Q. And I'm not trying to pin you down necessarily
- 23 on dates if you don't recall. But what I'm trying to
- 24 figure out is, there seems to be an indication that
- 25 there were homeless people there in the parking lot or

- 1 around the building on Sunday, the 19th, and then again
- 2 on Monday, the 20th.
- 3 Do you recall two different days in that time
- 4 period where there were people on the property who were
- 5 not supposed to be there?
- 6 A. Yeah. On Monday, I was notified about it,
- 7 that they had -- my staff had seen the same people the
- 8 day prior. And that's when we addressed it on that
- 9 following day, the 20th.
- 10 Q. Okay. And how was it addressed?
- 11 A. They were approached and asked to not park
- 12 there unless they had business with us.
- 13 Q. Are you aware of how they responded?
- 14 A. I believe they respond respectfully and said
- 15 okay.
- 16 Q. Do you know about a response regarding they
- 17 were being stalked?
- 18 A. I'm not aware of that.
- 19 O. And other than that incident on the 19th and
- 20 the 20th, were there any other incidents that you
- 21 encountered or you became aware of that happened on that
- 22 weekend?
- 23 A. Not that I recall.
- Q. Did you ask that camera footage be pulled
- 25 regarding those two incidents?

- 1 A. I don't recall.
- Q. Do you know if anyone did?
- 3 A. They might have. I'm not sure.
- Q. Okay. Let's go to Tuesday, March 21st.
- 5 Do you recall speaking to a Ranate (phonetic)
- 6 employee about an unidentified male with a goatee seen
- 7 in the building?
- 8 A. I -- I do not recall that conversation.
- 9 Q. And -- and back to individuals who were found
- 10 loitering on the property, you mentioned, I believe, to
- 11 law enforcement, that people were in that area, using
- 12 drugs or you thought people were using drugs on the
- 13 premise.
- I know that you referenced the lighter and that
- 15 that might have been used for drugs. What is it that
- 16 you know or think about people using drugs in or around
- 17 your building?
- 18 A. We had an incident here right after I started,
- 19 where there was a encampment, if you will, next to
- 20 Building B.
- 21 Q. What do you mean by encampment?
- 22 A. Clothes, tarps, bicycle, stuff like that, that
- 23 were in between the bushes and the building that we
- 24 removed from the site.
- Q. What did you do with those items?

- 1 A. We threw them away, as directed by the police.
- 2 O. And what was it about that site that made you
- 3 suspect drugs?
- 4 A. The hypertrophic needles and paraphernalia.
- 5 You know, spoons, things that seemed out of place.
- 6 Q. When was this?
- 7 A. I don't recall the exact time. It was -- like
- 8 I said, it was when I -- roughly after I first started
- 9 here, so at least a year and a half ago.
- 10 Q. And there were -- okay. So there was that
- 11 incident, and then the couple of incidents that occurred
- 12 earlier this year in March.
- Do you remember any other time where individuals
- 14 have been in or around that area that were not supposed
- 15 to be there, that caused you concern or made you suspect
- 16 that there were being drugs -- that drugs were being
- 17 used?
- 18 A. There's always been individuals that walk
- 19 through our parking lot. And, you know, when you're
- 20 walking out in the middle of the night, you can --
- 21 unless you have a pet with you, it's kind of strange to
- 22 see someone walking through our parking lot. So it's
- 23 just always suspicious.
- Q. Okay. Let's get back to Tuesday, the 21st.
- 25 I'm sorry I'm kind of jumping all over here. But we had

- 1 gotten up to the point where you had double-checked the
- 2 rooms. You reported this incident to, I believe you
- 3 said, management?
- 4 A. Our administrative assistant.
- 5 Q. Or admin -- and after that, what did you do?
- 6 A. On -- I'm sorry. What was --
- 7 Q. The 21st.
- 8 A. The 21st, I didn't report.
- 9 Q. You're right.
- 10 A. Yeah.
- 11 Q. Okay. So let's go to the 21st. I'm sorry.
- 12 That's why I don't like skipping around, but sometimes
- 13 it has to be done.
- So on the 21st, you did the perimeter. You walked.
- 15 You made sure that the two doors were locked, and you
- 16 said that they were?
- 17 A. Correct.
- 18 Q. What did you do next?
- 19 A. I went back into Building A to start my day
- 20 officially.
- 21 Q. And after you go and start your day, do you go
- 22 back to Building B at any time?
- 23 A. Yes.
- Q. And what time was that?
- 25 A. Probably closer to 7:00, if I -- if I remember

- 1 correctly.
- 2 Q. And what was the purpose of going back over to
- 3 Building B?
- 4 A. To interact with our administration side, the
- 5 phone room, and the people in our -- that are on our
- 6 side of the building over there.
- 7 Q. At that time, did you see anyone who you had
- 8 not seen before, or out of the ordinary, in or around
- 9 Building B?
- 10 A. I did not.
- 11 Q. How long were you in Building B?
- 12 A. I don't recall.
- Q. Would you have been there for the rest of the
- 14 day, or would you go back to Building A?
- 15 A. I was back and forth several times throughout
- 16 that day.
- 17 Q. Okay. At any time going back and forth
- 18 between Building A and Building B, did you see anyone
- 19 that was out of the ordinary or suspicious, either
- 20 outside the building, in the lobby or bathrooms,
- 21 anywhere?
- 22 A. I did not see anyone suspicious that day.
- 23 Q. At any time, walking back and forth between
- 24 the two buildings, did you see anything, smell anything,
- 25 suspicious?

- 1 A. Yes.
- 2 Q. Okay. When was that?
- 3 A. I want to say it was between 8:00 and
- 4 10:00 a.m. that -- somewhere around those times -- that
- 5 I walked back from Building A to B. And as soon as I
- 6 entered the lobby, I could smell a strong odor of
- 7 bleach, what appeared to be bleach.
- 8 Q. Okay. So do you remember if it was the first
- 9 time that you walked to Building B that you smelled
- 10 bleach?
- 11 A. It was not the first time that I had been in
- 12 Building B.
- Q. Okay. Was it closer to breakfast or closer to
- 14 lunchtime?
- 15 A. I would say it was still early morning, like
- 16 8:00, between 8:00 and 10:00.
- 17 Q. Okay. And that's a wide range. So, I mean, I
- 18 understand why you're saying that, and I don't want to
- 19 -- you know, if you don't know, you don't know.
- 20 Let me get to the report and when you talked to
- 21 Detective Compton.
- Were you provided that report prior to this
- 23 deposition?
- 24 A. Briefly, by -- just real quick this morning.
- 25 And we've been in staff meetings, so I haven't had time

- 1 to reread it.
- 2 Q. Okay. But you were able to kind of read
- 3 through it a little bit?
- A. I -- I, like, saw the e-mail, but I didn't get
- 5 to pull it up because, again, being the nurse manager,
- 6 I've got a lot of staff here to take care of.
- 7 Q. Okay. So you had indicated that there was an
- 8 interview that morning. Do you recall that?
- 9 A. An employee interview?
- 10 O. Yes.
- 11 A. Yes.
- 12 Q. Do you remember what time that interview was?
- 13 A. I would have to refer back to my calendar for
- 14 that.
- 15 O. You told law enforcement it was at 6:30 in
- 16 Building A.
- 17 A. Okay.
- 18 Q. Does that sound accurate?
- 19 A. Yes.
- Q. And, again, I'm not trying to trick you. I'm
- 21 just trying to help you along here, because oftentimes
- 22 with time, our memories fade.
- 23 So whenever you present information to law
- 24 enforcement closer in time, we expect that that would be
- 25 probably more accurate than several months later; right?

- 1 A. Yes. Yeah.
- 2 Q. And I'm assuming that everything you told law
- 3 enforcement, whenever you spoke to them, was the truth
- 4 at the time. You wouldn't have any reason to lie to law
- 5 enforcement.
- 6 But you had indicated that there was, in fact, an
- 7 interview that morning. It was at 6:30, and it was in
- 8 Building A.
- 9 How long do interviews last, if you -- and if you
- 10 recall, how long did this one last?
- 11 A. I don't recall how long that particular one
- 12 lasted, but typically around here, an hour to an hour
- 13 and a half.
- 14 Q. Okay.
- 15 A. Depending on the service that they're
- 16 interviewing with.
- 17 Q. So that's in line with what you told law
- 18 enforcement, which you said the interview had concluded
- 19 around 7:30.
- 20 And at some point, you were beginning to walk from
- 21 Building B to Building A, between 8:00 and 9:00 in the
- 22 morning, to go to the bathroom. Do you recall that?
- 23 A. Yes.
- Q. And do you remember walking by the bathroom
- and getting ready to go to the bathroom, but realizing

- 1 or thinking that someone was in there?
- 2 A. Yes.
- 3 Q. What kind of noises, sounds, movement, did you
- 4 hear to make you think that someone was in there?
- 5 A. I just heard some, like, rustling noise.
- 6 Like, somebody was -- obviously, it was occupied. And
- 7 knowing that bathroom and how small it is, you could
- 8 just hear someone was in there.
- 9 Q. Can you describe to me that bathroom? I know
- 10 there's a urinal; correct?
- 11 A. Correct.
- 12 Q. And then there is a stall with a door; is that
- 13 right?
- 14 A. Correct. Yes.
- 15 Q. So technically, more than one person can be in
- 16 there and use the restroom at the same time?
- 17 A. Correct.
- 18 Q. Where were you standing whenever you heard
- 19 movement in the bathroom?
- 20 A. At the door entry, like, getting ready to push
- 21 the door open.
- 22 Q. Did you actually push the door open?
- 23 A. I had put my hand on it. And then -- because
- 24 -- like, leaned in like I'm getting ready to walk in.
- 25 And then I heard the noise. I was, like -- and that's

- 1 when I stopped.
- Q. Did you crack it at all?
- A. No, not enough to open it up.
- 4 Q. Did you see anyone in there?
- 5 A. I did not see anyone in there, no.
- 6 Q. The movement that you heard, did it sound --
- 7 was it loud and unusual, or was it what you would
- 8 normally hear whenever you hear somebody washing their
- 9 hands and --
- 10 A. It wasn't washing hands sound. It was just a
- 11 different -- just a sound, like, you knew someone in
- 12 there doing -- it wasn't washing hands. So water wasn't
- 13 running. It was just kind of muffled noise, moving
- 14 around, like, shuffling feet kind of thing.
- 15 Q. Did you hear any voices?
- 16 A. I did not.
- 17 Q. Did you smell anything at that time?
- 18 A. Not at that time, no.
- 19 Q. And once you decided not to go into that
- 20 bathroom, what did you do?
- 21 A. I went back to Building A and used the
- 22 restroom over there.
- Q. At some point, you went back to Building B
- 24 with another employee, Mr. Mordenga.
- 25 Is that a yes?

- 1 A. Correct. Correct.
- Q. Okay. And who is Mr. Mordenga? Is he related
- 3 to someone at the vet as well?
- 4 A. He is related to our hospital administrator.
- 5 Q. And who's the hospital administrator again?
- 6 A. Jennifer Mordenga.
- 7 Q. Okay. Do you recall what time it was that you
- 8 walked over to Building B with Mr. Mordenga?
- 9 A. Probably around 8:30, between 8:30 and 9:30,
- 10 somewhere in that hour.
- 11 Q. And did you all decide to walk together? Did
- 12 you just happen to be walking together?
- 13 A. We were working on something together, and I
- 14 was going with him between buildings.
- 15 Q. What were you working on?
- 16 A. A maintenance project in our Building A.
- 17 Q. So with Mr. Mordenga, around 8:30 or 9:00, you
- 18 all walked to Building B. What entrance did you use?
- 19 A. The lobby entrance of Building B.
- 20 Q. How long does it take, approximately, to walk
- 21 from Building A to the lobby entrance of Building B?
- 22 A. Under 30 seconds.
- Q. And when you walked in, you walked in through
- 24 the lobby. Did you see anyone out of the ordinary?
- 25 A. I did not.

- 1 Q. And did you notice anything out of the
- 2 ordinary?
- 3 A. Yes. At that time, I noticed a odor of what
- 4 appeared to be bleach.
- 5 Q. Okay. In the -- when you spoke to law
- 6 enforcement, you had indicated that it was after 10:00
- 7 whenever you smelled the bleach.
- 8 A. Okay.
- 9 Q. What time do you think it was, or do you just
- 10 not know?
- 11 A. No, actually -- like, talking to --
- 12 refreshing, like -- so I was back and forth between
- 13 Building A and B a lot. So I probably picked up stuff,
- 14 supplies. Like, we had our maintenance supplies in
- 15 Building B. And then I walked back over between. And
- 16 then me and Sam went back over mid-morning. So we were
- 17 back and forth a lot.
- 18 Q. Okay. Did you both notice a bleach smell?
- 19 A. Yes.
- 20 Q. And where did the bleach -- did you know where
- 21 the bleach smell was coming from?
- 22 A. I did not.
- 23 Q. Where were you standing when you first noticed
- 24 the smell?
- 25 A. In the lobby.

- 1 Q. And what did you do?
- 2 A. We continued to our part of the building where
- 3 our admin area is.
- 4 Q. And did you go into the admin area?
- 5 A. Yes.
- 6 Q. And what did you do after that?
- 7 A. We grabbed our supplies that we were coming
- 8 back for, and walked back to -- made our way back to
- 9 Building A.
- 10 Q. So the bleach smell was not -- was not really
- 11 a concern at that time, is that what you're telling me?
- 12 There was no reason to investigate?
- 13 A. It was a concern. I was looking for Deb to
- 14 see -- asked if she was cleaning. And I don't recall if
- 15 I found her at that particular moment in Building B, or
- 16 if she was back in Building A.
- 17 Q. Okay.
- 18 A. But I would have asked her about that, too,
- 19 because that was very out of the ordinary, to smell
- 20 that.
- 21 Q. And what did she say?
- 22 A. She said she didn't do anything. And she
- 23 didn't -- wouldn't have used bleach over there.
- Q. At some point, you went into the men's
- 25 restroom; correct?

- 1 A. Correct.
- Q. Who was with you when that happened?
- 3 A. Sam.
- Q. Was that before or after you found Deb?
- 5 A. I don't recall.
- 6 Q. Well, do you recall if you walked to
- 7 Building A first, and then came back and went into the
- 8 bathroom, or once you smelled the bleach, you then went
- 9 into the bathroom?
- 10 A. It was on our way back from Building B towards
- 11 Building A that we peeked in the bathroom to see if the
- 12 smell was coming from there.
- Q. And what -- what was your opinion at that
- 14 time?
- 15 A. That it was coming from the bathroom.
- 16 Q. And when you say peeked in, did you just crack
- 17 the door --
- 18 A. We opened -- we opened the door and looked in
- 19 there, and --
- Q. Did you walk in there?
- 21 A. I don't recall if I -- I don't recall walking
- 22 all the way in the bathroom, but opened the door all the
- 23 way.
- Q. And you know you're not going to get in
- 25 trouble for going in the bathroom?

- 1 A. Correct.
- 2 Q. It's a public space and --
- 3 Do you recall if anyone walked into the bathroom?
- 4 A. I believe Jake walked in there, looking for --
- 5 see, because at that time, that's when -- was -- we were
- 6 walking back from Building B. Looked in the bathroom.
- Jake approached us, asking if we found -- saw his
- 8 friend Steve.
- 9 Q. Where did you encounter Jake?
- 10 A. Near the entryway of, like, the bathroom and,
- 11 like, the hallway, in that vicinity.
- 12 Q. And this was after you had determined that
- 13 there was a bleach smell in the bathroom?
- 14 A. Correct.
- 15 Q. What was the conversation between you and
- 16 Jake?
- 17 A. Jake just asked us if we had seen his friend
- 18 Steve, that he was looking for him.
- 19 Q. And what was your response?
- 20 A. I said, I have -- I have not seen him.
- 21 Q. Did you all have a conversation about the
- 22 bleach smell?
- A. We did not.
- Q. What was the state of the bathroom?
- 25 A. It was a mess.

- 1 Q. And describe it, if you will.
- 2 A. Paper all over the place. There was -- I
- 3 recall seeing a couple of drops of blood. And then the
- 4 stall door was wide open, and you could see the paint on
- 5 the wall was wiped away. Which having been in that
- 6 bathroom several times before, I knew that that was
- 7 brand-new.
- 8 Q. Okay. So let's start with the blood. Where
- 9 did you see what you thought was blood?
- 10 A. By the doorway.
- 11 Q. Where by the doorway?
- 12 A. On the floor.
- Q. And what made you think it was blood?
- 14 A. The color.
- 15 Q. Was it wet or dry?
- 16 A. It was wet.
- 17 Q. And you said the bathroom was brand-new. Are
- 18 you referring to the paint?
- 19 A. No. It wasn't brand-new. It was, like -- I
- 20 knew what it looked like. But as far as, like, if
- 21 there's damage in the walls, like, spots missing in the
- 22 walls.
- Q. Okay. So when you opened the bathroom door,
- 24 you see what you think is blood. You see that the paint
- is rubbed off, from what you can tell, and there's paper

- 1 everywhere. Was there anything else?
- 2 A. I believe the -- the sink -- like, the sink
- 3 was a mess with stuff. But I don't recall if the
- 4 cabinets were open at the time. But the whole bathroom
- 5 just looked like something had -- something messy
- 6 happened in there.
- 7 Q. Okay. And so you come out of the bathroom --
- 8 well, let me -- let me go back.
- 9 Did you move anything in the bathroom when you were
- 10 there? Pick up any paper?
- 11 A. I did not. The only thing I touched was the
- 12 bathroom door.
- 13 Q. Did you notice anything on the bathroom door?
- 14 A. Not on the bathroom door at that time, no.
- 15 Q. And when you touch the bathroom door, is there
- 16 a door handle, or is it a push door where you just touch
- 17 the wall?
- 18 A. It is a push door.
- 19 Q. So -- and did Sam go in there with you
- 20 whenever you saw -- he saw the mess?
- 21 A. I don't recall.
- 22 Q. Do you -- when you saw what you thought was
- 23 blood, did you mention to Sam, hey, is that blood? I
- 24 mean, did y'all have a conversation about it?
- A. We had a conversation about, like, it looked

- 1 like there -- you know, something happened. The
- 2 bathroom was -- like, speculating, like, did someone
- 3 have an accident and tried to clean it up and it went
- 4 bad?
- 5 Q. Okay. And by an accident, you mean somebody
- 6 just maybe didn't make it all the way to the bathroom?
- 7 A. Correct.
- 8 Q. So at this time, you're still with Sam. You
- 9 all -- or you walk out of the bathroom. You're not sure
- 10 if Sam walked in the bathroom. But you walked out of
- 11 the bathroom towards the lobby?
- 12 A. Correct.
- Q. And that's when you ran into Jake Blanchard?
- 14 A. Correct.
- 15 Q. Was he with anyone?
- 16 A. He was not.
- 0. What was his state? Did he --
- 18 A. He looked stressed out. He was on the phone
- 19 with somebody, and he was -- he looked very stressed.
- 20 Q. And what exactly did he say to you? Just --
- 21 A. Have you seen my friend Steve? I'm looking
- 22 for him. I can't find him anywhere.
- Q. Did you know who Steve was?
- A. I did not at the time, no.
- 25 Q. And did you ask him who's Steve, or did you

- 1 just say no, and keep walking?
- 2 A. Yeah. I said, I -- I haven't seen anybody.
- 3 Q. Did you say, hey -- did you tell him anything
- 4 about the bathroom and what you had saw in the bathroom?
- 5 A. I did not.
- 6 Q. So at that time, the bleach, the blood, the
- 7 wall, none of that, in your mind at that time, seemed
- 8 relevant to tell Mr. Blanchard?
- 9 A. No. Mr. Blanchard was in the area, too,
- 10 because he was aware of the smell and stuff, too.
- 11 Q. Okay. Do you know if he was aware of the
- 12 blood in the bathroom?
- 13 A. I am not aware.
- Q. Okay. So how long was the encounter between
- 15 you and Mr. Blanchard?
- 16 A. I would -- it was probably under a minute. It
- was real quick, as he's on the phone, walking through
- 18 the area, looking for his friend.
- 19 Q. At that time, were there any law enforcement
- 20 there?
- 21 A. When we walked out the front door of the
- 22 lobby, there was an officer at some point. And I don't
- 23 remember if it was right after we saw Jake or shortly
- 24 thereafter.
- 25 Q. So sometime shortly after -- or right after

- 1 you saw Jake, law enforcement showed up. Was it just
- 2 one officer?
- A. I only initially saw one officer, yes.
- Q. Do you recall if you saw this officer in
- 5 passing when you were walking back to Building A?
- 6 A. Yes. They were outside of Building B, like,
- 7 on the sidewalk, walking into the building.
- 8 Q. Okay. When you saw law enforcement, what did
- 9 you do? Did you continue to Building A?
- 10 A. I believe we did.
- 11 Q. And Sam Mordenga was still with you at that
- 12 time?
- 13 A. Correct.
- Q. So you go back to Building A. And at that
- 15 time, did you just carry on your day? Did you have any
- 16 conversations with individuals about what you had seen
- in Building B?
- 18 A. Me and Sam had talked, like, well, I wonder
- 19 what was going on. And that was the only one that I had
- 20 talked to at the time, because we had -- like, we saw
- 21 the same stuff together.
- 22 Q. And what happened next? How did the events
- 23 unfold and how did law enforcement eventually get to
- 24 you?
- 25 A. I was -- throughout the day, I still had to go

- 1 back to Building B to conduct business there. So I was
- 2 back and forth.
- 3 And they were all in that -- all of the vicinity
- 4 throughout the day after that, I guess.
- 5 Q. Were you given any additional information
- 6 about what was going on?
- 7 A. No.
- 8 Q. Were you told to avoid certain areas?
- 9 A. Not at that time, no.
- 10 Q. Were they still allowing use of the restroom,
- 11 the men's restroom, at that time?
- 12 A. I don't believe they were allowing anyone to
- 13 use that, the restroom, but with the state that it was,
- 14 nobody was going to use it, anyways.
- 15 Q. Prior to law enforcement getting there, but
- 16 after you noticed the state of the bathroom, was anybody
- 17 notified, hey, you know, somebody needs to go clean up
- 18 the restroom?
- 19 Who's in charge of cleaning up that restroom?
- 20 A. I'm not sure who is responsible for that
- 21 building's restroom.
- 22 Q. Did you notify anyone to go and, hey, somebody
- 23 needs to be called to clean up the restroom?
- A. I might have talked to Deb about the restroom,
- 25 but I don't recall.

- 1 Q. Okay. Do you all have a janitorial service in
- 2 that building?
- A. I'm not aware of any. Like, if there is, it's
- 4 not through our company.
- 5 Q. So the owners of the building, to your
- 6 knowledge, do not have a service that goes in and cleans
- 7 all of the offices?
- 8 A. They may. I'm not aware of it, though.
- 9 Q. Who empties the garbage in -- in your offices?
- 10 A. We all do in our offices. Like, everybody is
- 11 responsible for that kind of function.
- 12 Q. And for mopping and sweeping and making sure
- everything is clean daily, who does that?
- 14 A. In our admin office, Deb does that.
- 15 O. And what about in the vet clinic?
- 16 A. Everybody is responsible for doing -- taking
- 17 part in that.
- 18 Q. Okay. Is there a private restroom in
- 19 Building B for employees, or do -- are they all having
- 20 to use that common restroom area?
- 21 A. It's the common restroom.
- 22 Q. So you're back and forth from Building A to
- 23 Building B after you see law enforcement. At some time,
- 24 did law enforcement stop you to ask you questions?
- 25 A. Yes.

- 1 Q. When was that?
- 2 A. I don't recall exactly when that was.
- 3 Q. Was it that day?
- 4 A. That -- I want to say it was that day, but I
- 5 don't recall exactly.
- 6 Q. Okay. It looks like -- do you remember law
- 7 enforcement coming to the office on the 22nd, the day
- 8 after?
- 9 A. Yes.
- 10 Q. Okay. Do you recall being questioned on that
- 11 day?
- 12 A. I recall being questioned. I don't recall
- 13 exactly which day.
- 14 Q. Okay. So Detective Compton responded to
- 15 1501-B South Belcher to interview you on March 22nd.
- 16 Does that sound familiar?
- 17 A. Yes.
- 18 Q. And at that time, where -- did he come to find
- 19 you in your office and say, hey, come here and let's
- 20 chat?
- 21 A. He did not come find me. I was in between --
- 22 I was walking between Building A and B again. And Deb
- 23 was passing the office that way, and said, you know,
- 24 that they would probably talk to me next.
- Q. Okay. And did you then go and approach them

- 1 and say, hey, I'm Mr. Tensley?
- 2 A. I walked into Building B and let them know
- 3 that I'm available if they need to talk to me.
- Q. And did they chat with you in Building B?
- 5 A. Yes.
- 6 Q. And at that time, did you -- what did you tell
- 7 them?
- 8 A. I told them what -- the events that I saw and
- 9 what actions I did that day and the day prior. And that
- 10 was it, as far as I recall.
- 11 MS. POWERS SELLERS: Okay. Just give me a
- 12 minute. Let me review my notes here.
- Q. What is the state of that bathroom normally?
- 14 Was it normally well kept? I mean -- or is it halfway
- 15 kept?
- 16 A. It's normally well kept. I don't feel like
- 17 there's that many people using it out of that building.
- 18 Q. Okay. On March 27th, you spoke with a female
- 19 detective, again at your office on Belcher. And the
- 20 purpose of that meeting was for her to obtain a written
- 21 statement from you regarding the information that you
- 22 had provided previously on the 23rd.
- 23 Do you remember that?
- 24 A. I don't remember the exact day, but I remember
- 25 doing a written statement.

- 1 Q. Okay. And I believe you had asked if you
- 2 could type the statement, because you -- you weren't
- 3 satisfied with your handwriting?
- 4 A. Correct.
- 5 Q. Okay. And you're aware that that statement
- 6 was recorded?
- 7 A. Yes.
- Q. Yes?
- 9 Okay. To your recollection, everything that you
- 10 said in that recorded statement that you typed later,
- 11 everything was what you remembered at or around the time
- of the incident that occurred on March 21st?
- 13 A. Yes.
- MS. POWERS SELLERS: Okay. I'm just going to
- 15 review my notes on this recording and make sure
- that there's nothing else that I need to address.
- 17 Q. I have a note here that you mentioned
- 18 encountering people doing drugs. But I believe that was
- 19 probably a question that I had for you that we've
- 20 already discussed.
- 21 You -- have you personally seen anyone doing drugs
- 22 on the premises?
- 23 A. Smoking things and speculating what it is. I
- 24 mean, is a cigarette a drug? One might say yes, so.
- 25 Q. Okay. And is that where -- where did that

- 1 happen?
- 2 A. That happens, like I said, throughout the
- 3 parking lot, in between buildings.
- 4 Q. Okay. So pretty common that you would see
- 5 somebody in or around that area smoking?
- 6 A. There's times that it would happen, like, the
- 7 locations between the dumpster from Building A, and then
- 8 the rest of the parking lot and Building B.
- 9 Q. Okay. Just for clarification, you -- you did
- 10 the interview with the detective about a week later.
- 11 And then Detective Gay asked you to write
- 12 something.
- 13 So you did the oral interview first, and then you
- 14 typed up a statement and provided that to the detective?
- 15 A. That sounds right.
- 16 O. Or was it vice-versa?
- 17 A. I remember being recorded, and I remember
- 18 typing it up. I don't remember, like, the timeline
- 19 between -- at that time, it all seemed happening at the
- 20 same time but, obviously, it didn't.
- 21 MS. POWERS SELLERS: Okay. Willengy?
- MS. RAMOS: Good morning.
- I don't have any questions. Thank you,
- Mr. Tensley.
- 25 THE WITNESS: Thank you.

- 1 MS. POWERS SELLERS: The state?
- 2 MS. SPADARO: Yes. Good morning.
- I do have some follow-up questions, just to

- 7 Q. So defense asked you about that written

- 11 liked.
- 12 Q. Okay. Okay. But you were provided with that
- 13 written statement of your audio recording; right?
