- 1 DEPOSITION IN DISCOVERY
- 2 DETECTIVE JERRY HUNT
- 3 Pursuant to notice duly given, the virtual
- 4 deposition of DETECTIVE JERRY HUNT, called by the
- 5 Defendant in the above-styled cause, was taken by me, a
- 6 Notary Public in and for the State of Florida at Large,
- 7 at the time and place and in the virtual presence of
- 8 counsel enumerated on Page 2 hereof.
- 9 Thereupon, it was stipulated and agreed by and
- 10 between the attorneys for the respective parties, by and
- 11 with the consent of the said DETECTIVE JERRY HUNT, that
- 12 signature to the said deposition be reserved.
- 13 THE COURT REPORTER: Raise your right hand,
- 14 please.
- Do you swear or affirm that the testimony
- 16 you're about to give in this cause will be the
- 17 truth, so help you God?
- 18 THE WITNESS: I do.
- 19 DETECTIVE JERRY HUNT, having been first duly
- 20 sworn via Zoom Video Communications, upon interrogation
- 21 in discovery, testified as follows:
- 22 DIRECT EXAMINATION
- 23 BY MR. BRUNVAND:
- Q. Good morning. My name is Bjorn Brunvand. I
- 25 represent Tom Kosowski. We're here for the continuation

- 1 of your deposition.
- 2 If you could please --
- MR. BRUNVAND: Oh, I tell you what, we got to
- 4 activate the recording. I'm sorry.
- 5 (Audio recording started)
- 6 MR. BRUNVAND: All right. Let me start over
- 7 again.
- 8 Good morning. My name is Bjorn Brunvand. I
- 9 represent Tom Kosowski. We're here on State of
- 10 Florida versus Tom Kosowski for a continuation of a
- 11 deposition of Detective Jerry Hunt.
- 12 Q. Detective Hunt, if you could please confirm
- 13 your -- your name?
- 14 A. Yeah. My name is Jerry Hunt and I'm a
- 15 detective with the Largo Police Department.
- 16 Q. And I believe that your deposition previously
- 17 started on one prior occasion; is that correct?
- 18 A. It started when? I apologize.
- 19 Q. There was one previous occasion where we
- 20 started the -- your deposition.
- 21 A. That is correct.
- 22 Q. And I think it lasted about -- a little shy of
- 23 three hours?
- A. That sounds about right.
- 25 Q. Okay.

- 1 A. You recorded it then so I'm sure the recording
- 2 is accurate.
- 3 Q. Yes. That's correct.
- 4 And Amanda Sellers was the attorney that -- that
- 5 was covering on that particular day.
- 6 A. Correct.
- 7 Q. I believe that her deposition had ended right
- 8 around the time when you had arrived at the scene where
- 9 the Toyota Corolla had been stopped and you were in the
- 10 process of putting together a search warrant; is that
- 11 accurate?
- 12 A. That sounds about right. Again, the
- 13 recording, I'm sure you reviewed the recording and
- 14 you're familiar with what questions are next. I think
- 15 she said she had 27 pages. We were around page 22 is
- 16 what she had told me in the -- in the deposition.
- 17 Q. Sure. Sure. And I have -- I have those 27
- 18 pages and I have -- I have some additional information
- 19 as well, so.
- 20 A. Okay.
- 21 Q. The -- you had indicated, and please correct
- 22 me if I'm wrong, but -- but -- but I believe you -- you
- 23 had indicated that you were present in Tarpon Springs
- 24 where the Corolla had been stopped and seized, and that
- 25 you were back and forth between sitting in your car

- 1 and -- and drafting a search warrant affidavit?
- 2 A. So the search warrant affidavit, the -- the
- 3 most of it had already been drafted for the car.
- 4 Q. Okay.
- 5 A. Because I had written that the previous day on
- 6 Friday when I was driving to Miami with Detective Wedin.
- Q. Okay.
- 8 A. But I was in and out of my car and I was on
- 9 scene where the vehicle was.
- 10 Q. Were -- were you working on -- on a different
- 11 search warrant at that same time or was it just
- 12 finishing the Toyota Corolla?
- 13 A. Just finishing the Toyota Corolla. So what I
- 14 had done is I had drafted the PC but I needed to add in
- 15 where the vehicle was stopped. I wanted to verify the
- 16 VIN to make sure there wasn't like a scrivener's error
- 17 from what the DMV had versus what was physically on the
- 18 car, things like that, so.
- 19 Q. Okay.
- 20 A. Get all that up to date, get it -- get it sent
- 21 over, get it -- get it signed and CloudGavel was working
- 22 for the -- the vehicle warrant.
- 23 Q. Okay.
- 24 When I -- when I look at some of the body cam
- 25 footage, it appears that you come and go. That --

- 1 that -- you're -- you'll come up to the car and then you
- 2 leave and then you come back --
- 3 A. Sure.
- 4 Q. -- on several occasions.
- 5 A. Correct.
- 6 Q. You had -- you had indicated previously in the
- 7 deposition that in your opinion, as a law enforcement
- 8 officer, that you believed that you could search -- you
- 9 could have searched the car without a search warrant.
- 10 A. Well, I think that Carroll doctrine would
- 11 allow us to search the vehicle; but under the
- 12 circumstances I think the most prudent thing to do is to
- 13 get a search warrant.
- 14 Q. Sure.
- 15 And -- and what was your understanding at the time
- 16 of the Carroll doctrine?
- 17 A. In reference to what gives us authority?
- 18 Q. To the particular circumstances -- well, as --
- 19 well, in general and as it relates to this particular
- 20 case.
- 21 A. Well, my understanding of Carroll was that
- 22 it's an exception to the search warrant requirement in
- 23 reference to if you have probable cause that a vehicle
- 24 contains fruits of a crime or used in a crime there
- 25 would be evidence of the crime therein. Because a

- 1 vehicle is a movable conveyance that you would be
- 2 allowed to search it without a warrant. But because we
- 3 had it seized and it was secured and the status of the
- 4 case, I felt that a warrant would be the most
- 5 appropriate.
- I had drafted it previously the day before because
- 7 I didn't know what jurisdiction it was going to be found
- 8 in. So obviously, you know, I only have jurisdiction in
- 9 Pinellas County, but if the vehicle was located in
- 10 another jurisdiction we would have to apply for and seek
- 11 a search warrant in that -- that jurisdiction in order
- 12 to be able to search it; and we would have to have that
- 13 agency assist us and effect a search warrant.
- 14 Q. Okay.
- 15 The -- the -- I mean, I think part of the Carroll
- 16 doctrine sort of relies on the exigency of the fact
- 17 that -- that a vehicle can be moved and --
- 18 A. Correct.
- 19 Q. -- and obviously, that didn't apply in this
- 20 case since it was seized, right?
- 21 A. We -- we had it seized so the most prudent --
- 22 the thing that we should do is get a warrant.
- 23 Q. And -- and the operator of the vehicle,
- 24 Dr. Kosowski, had also been seized, right?
- 25 A. He had been detained. Correct.

- 1 Q. Right. He was detained. He was -- was
- 2 handcuffed and sitting inside a patrol vehicle that he
- 3 himself could not exit without the assistance of law
- 4 enforcement; is that a fair statement?
- 5 A. Correct.
- Q. Okay.
- 7 Do you recall looking into the trunk of the
- 8 Corolla?
- 9 A. Yeah, I believe the trunk was opened, and
- 10 again, Tarpon Springs had their dash camera on so that
- 11 could be the most accurate representation of what
- 12 occurred on scene. It was on the vehicle the entire
- 13 time that it was stopped until I believe it was removed
- 14 by Joe's Towing.
- But yes, I believe I looked inside the passenger
- 16 compartment. I looked inside the trunk that had been
- 17 opened by officers; and I didn't enter the vehicle or
- 18 anything like that.
- 19 Q. Okay.
- 20 The -- Tarpon Springs did the initial stop,
- 21 correct?
- 22 A. Correct.
- 23 Q. And then that was prior to your arrival.
- A. Correct.
- 25 Q. And -- and then Tarpon Springs detained

- 1 Dr. Kosowski prior to your arrival.
- 2 A. Correct.
- 3 Q. Okay. Where were you coming from when you
- 4 were en route to -- to the stop?
- 5 A. So, I was at my home and I had been contacted
- 6 that the vehicle was hitting on Flock cameras and
- 7 investigators believed that it was on his way back to
- 8 Tarpon Springs; other investigators had coordinated with
- 9 Tarpon to contact them and let them know.
- 10 Detective Bolton and I were responding to the area
- 11 of Tarpon Springs so if it was located that we could
- 12 expeditiously be en route on the scene.
- I didn't -- think I was northbound on 19 when they
- 14 had affected the stop, in like the Palm Harbor area.
- 15 Q. Okay.
- And -- and any idea how -- how long between the
- 17 time the stop took place when you -- and the time that
- 18 you arrived at the -- at the scene?
- 19 A. Well, I know according to my report that I
- 20 authored, I was contacted at 1245 in the afternoon by
- 21 Sergeant Cabella -- or Caravella about the LPR hit on
- 22 the Corolla. At 1520 hours we responded to 34 West
- Orange Street because that's where the place the stop
- 24 had taken. And I think the stop was just a few moments
- 25 before that. So I believe Detective Owens might have

- 1 contacted me advising that the stop had been conducted
- 2 and we went out there.
- 3 Q. Okay.
- 4 When -- when you arrived who else was there from
- 5 Largo when you arrived at the scene?
- 6 A. I think I -- I think Detective Bolton,
- 7 might -- may have been the first -- we might -- it might
- 8 have been Detective -- Detective Owens and then
- 9 Detective Bolton. I -- I know that Detective Wagoner,
- 10 Detective Allred, Detective Owens, Lieutenant Lomonaco
- 11 came out -- I mean most of the division had responded to
- 12 the scene.
- I can't give you the exact times that they arrived
- 14 and things like that. I'm sure that they documented
- 15 that in their supplements.
- 16 Q. What -- what do you recall about what you
- 17 first did when you first arrived?
- 18 A. I believe I looked at the car. I make contact
- 19 with the other detectives. And then I started working
- 20 on updating my search warrant for location of the stop,
- 21 verifying VIN and doing those sorts of things.
- Q. When you say I believe I looked at the car
- 23 you're referring to the Toyota Corolla?
- A. Correct.
- 25 Q. Okay.

- 1 And when you looked at the car when you first
- 2 arrived, the trunk was closed?
- 3 A. I don't recall. I -- I'd have to check the
- 4 video for that.
- Q. Okay.
- 6 The -- the doors were closed?
- 7 A. I would check the video.
- Q. Okay.
- 9 A. Again, everything is on video. So all of my
- 10 actions, my movements, everything was on video.
- 11 Q. At some point in the video, and I -- and --
- 12 and I will tell you, from the video, the doors were
- 13 closed and the trunk was closed when you arrived.
- 14 A. Okay.
- 15 Q. At some point someone from Largo Police
- 16 Department puts on plastic gloves --
- 17 A. Okay.
- 18 Q. -- latex gloves and reaches into the car and
- 19 opens the car, the driver's side door.
- 20 A. Okay.
- Q. Do you know who that was?
- 22 A. If I looked at the video I could tell you.
- 23 Q. Okay.
- 24 I'll take a look here and see if I can --
- 25 MR. BRUNVAND: Give me one second.

- I don't know why it appears to be frozen.
- I tell you what, I'm going to see if I can
- 3 share the screen.
- 4 THE WITNESS: Okay.
- 5 MR. BRUNVAND: And I'm going to show you just
- 6 a still image that I have.
- 7 Q. (By Mr. Brunvand) Okay. Are you able to see
- 8 the image that's -- that's on the screen right now?
- 9 A. I can. I'm on the right side in the dark --
- 10 in the light blue dress shirt.
- 11 Q. Right. So -- walking away out of this -- out
- 12 of the screen?
- 13 A. Correct.
- And then Detective Bolton is the gentleman with the
- 15 gloves on, and the -- I guess it's maybe a gray polo
- 16 shirt and vest.
- 17 Wagoner is the --
- 18 Q. The one who is looking into the trunk?
- 19 A. Yes.
- 20 And then Detective Bolton --
- 21 Q. Detective Bolton?
- 22 A. Detective Bolton.
- 23 And then Detective Wagoner is the khaki pants with
- 24 the blue polo shirt, kind of looking in my direction.
- 25 And then Detective Allred is kind of where your

- 1 cursor is right there, with the khaki slacks, kind of
- 2 adjusting his carrier.
- 3 Q. Okay.
- 4 MR. BRUNVAND: Let me see if I can get this to
- 5 go back to the -- the -- and for some reason it's
- frozen. So I would have to -- I'm just going to
- 7 stop it and see if I can find the actual videos I
- 8 can show you.
- 9 Q. Well, actually, based on that, I can figure
- 10 out who's who as far as opening the door.
- 11 A. Okay.
- 12 Q. You don't recall seeing who opened the door
- or -- or you didn't -- in fact, I think you said without
- 14 looking at the video you don't recall whether or not it
- 15 was open or closed when you got there.
- 16 A. Correct. I mean it's -- I mean we're talking
- 17 it was, you know, almost two years ago.
- 18 Q. I understand.
- 19 The -- actually, let me try to find the video
- 20 because there's a statement made by one of the Largo
- 21 detectives questioning opening the trunk without --
- 22 prior to getting the search warrant and maybe you can
- 23 identify who that is. So give me -- give me one moment.
- 24 MR. BRUNVAND: I'm not sharing screen at this
- 25 point. Right?

- 1 THE WITNESS: You are not.
- 2 MR. BRUNVAND: Okay.
- All right. I do not know why I'm not able to
- 4 get the video to play right now.
- 5 Q. (By Mr. Brunvand) Anyways, the -- shortly
- 6 after the detective reaches into the car and opens
- 7 the -- the door, a statement is made by another
- 8 detective -- I assume they're all detectives, the people
- 9 that are there from Largo?
- 10 A. Correct.
- 11 Q. Okay.
- 12 And they basically -- the person says, you know,
- 13 should we be searching the car prior to getting a search
- 14 warrant; and another detective responds. And I'm
- 15 assuming it's the one who reaches into the car, which I
- 16 think might be Bolton, but I'm not a hundred percent
- 17 sure. Basically says something to the effect of I'm
- 18 just doing a cursory view.
- 19 A. Okay.
- Q. Do you recall any of that?
- 21 A. I don't.
- 22 Q. Okay. All right. And you may not have been
- 23 in the immediate presence at that time so -- so --
- 24 but -- but presumably if -- if I was able to show you
- 25 the video or if you looked at the video, and I believe

- 1 this is a Tarpon Springs video potentially, the -- you
- 2 would be able to identify, even just by the voices
- 3 possibly, the people that are speaking.
- 4 A. Possibly.
- 5 Q. Possibly. Okay. You're familiar with your
- 6 fellow detectives and to significant degree, you know.
- 7 A. Correct.
- 8 Q. Okay. All right.
- 9 But you have no recollection of any of that stuff;
- 10 is that correct?
- 11 A. I do not.
- 12 Q. Okay.
- When you were looking into the trunk of the
- 14 Corolla, did you see any blood?
- 15 A. No, I don't -- I don't recall seeing any blood
- 16 or anything like that. Again, the vehicle was going to
- 17 be searched. I believe, just going off my memory from
- 18 almost two years ago, Supervisor Klein I think was doing
- 19 some blind swabbing of the trunk after the warrant was
- 20 procured for presumptive blood.
- 21 Q. Sure.
- 22 A. I don't recall seeing pools of blood or
- 23 anything like that and there were a lot of contents in
- 24 the back of the trunk.
- 25 Q. Sure.

- 1 Did you see anything that -- that just by the naked
- 2 eye at that time appeared to you to be blood?
- 3 A. Again, I just did a brief look in. I didn't
- 4 see anything that was overwhelmingly pointing to it
- 5 being blood.
- Q. Did you see anything that was underwhelmingly
- 7 pointed towards blood?
- 8 A. I didn't process it so.
- 9 Q. Right. So you didn't see anything that, you
- 10 know, just by looking at it you say that looks like
- 11 blood.
- 12 A. Correct.
- 13 Q. Okay.
- And in fact, if you had, you probably would have
- 15 mentioned it, right?
- 16 A. Sure. Absolutely.
- 17 Q. Okay.
- 18 You had indicated that one of the things that you
- 19 were verifying was the -- the VIN number to make sure it
- 20 was the correct car?
- 21 A. Correct.
- 22 Q. Did you photograph the VIN, the -- for the --
- 23 A. Yes. I used my work cell phone to photograph
- 24 the VIN.
- 25 Q. Okay. All right.

- 1 And you included that in the affidavit, I assume?
- 2 That it was, in fact, the correct VIN?
- 3 A. I don't know that I put anything in the
- 4 affidavit about that I verified it; just that it was
- 5 the -- in reference to the affidavit for the search
- 6 warrant. It was a red Toyota four-door vehicle
- 7 registered to Tomasz Kosowski with the Florida license
- 8 plate EMFK38 with the VIN number. So I didn't -- I
- 9 didn't put in that I verified it, it's just that was the
- 10 VIN number.
- 11 Q. And I guess my question was: Did you have the
- 12 VIN number the night before?
- 13 A. I have the VIN number from DAVID.
- 14 Q. Okay.
- 15 A. But I wanted to confirm that that was the
- 16 correct number because humans make errors. I don't know
- if, you know, somebody fingered something when they were
- 18 putting Mr. Kosowski's, you know, data profile together.
- 19 O. Sure. Sure.
- Now I know you had some contact with Dr. Kosowski
- 21 at the scene of the stop.
- 22 A. That is correct.
- 23 Q. Do you recall the first time that you had
- 24 contact with Dr. Kosowski?
- 25 A. We used Detective Wedin's body camera to

- 1 record all of our interactions with Dr. Kosowski. So I
- 2 don't recall specifically without reviewing the video.
- 3 I mean, that's the -- the video recording of our
- 4 contact.
- 5 Q. Okay. Well, generally, do you recall that
- 6 neither you nor anyone else with Largo requested
- 7 permission from Dr. Kosowski to search the Corolla?
- 8 A. Correct. I don't recall ever asking him for
- 9 consent.
- 10 Q. Okay.
- 11 A. I do know that -- it is my understanding that
- 12 when Detective Bolton and Detective Allred made contact
- 13 with him to interview him and to speak with him, he had
- 14 invoked his -- his rights and they did not ask him any
- 15 questions.
- 16 Q. Okay. And that was later on in the evening,
- 17 right?
- 18 A. No, I think they, while I was working on my
- 19 warrant, I think they made contact with him to speak
- 20 with him about what was going on and -- and to talk to
- 21 him. So my understanding is, is that occurred pretty
- 22 early on in the -- when we arrived because I was -- I
- 23 was working on the warrant which is why I didn't stand
- 24 by with Detective Bolton to make that contact with
- 25 Dr. Kosowski.

- 1 Q. Okay.
- Were you wearing gloves, like latex gloves, at --
- 3 at the scene?
- 4 A. I don't recall wearing any. I didn't touch
- 5 anything though so I didn't -- I wasn't doing any
- 6 evidence collection or anything like that or going --
- 7 going in or out of the vehicle.
- 8 Q. Did you -- did you at some point reach into
- 9 the Corolla without touching anything?
- 10 A. Not that I can recall. I -- I was present
- 11 when, I believe it was Officer Rose took possession of a
- 12 cell phone after reading the warrant; and then I was
- 13 present when Supervisor Klein took custody of a
- 14 secondary cell phone; both of those were provided to
- 15 Detective-Wedin.
- 16 Q. Okay.
- 17 But if -- if there is video footage that suggests
- 18 that you reached into the -- to the Corolla, you'd be
- 19 able to look at that and -- and it would either confirm
- 20 or --
- 21 A. That vehicle was under video monitoring and
- 22 recording the entire time that it was on scene.
- 23 Q. Right. Okay.
- A. So that would be -- that would be accurate.
- 25 Q. So -- so it's possible you may have but you --

- 1 from what you recall you don't think that you had
- 2 reached into the --
- A. I don't have any independent recollection of
- 4 doing that; but there is a video recording and the video
- 5 recording is going to be the most accurate
- 6 representation of what happened.
- 7 Q. Okay.
- 8 Do you recall seeing any other members of law
- 9 enforcement reach into the vehicle with -- without
- 10 wearing latex gloves?
- 11 A. No, I don't recall that at all.
- 12 Q. Okay. And again --
- 13 A. The forensics division responded. They did
- 14 some brief processing on scene after the warrant was
- 15 affected, but those individuals wear gloves. They
- 16 follow protocols. They have policies and procedures
- 17 that they follow.
- 18 Q. Okay.
- 19 Do you recall or have -- have knowledge of how many
- 20 members of Largo Police Department examined the contents
- 21 of the open trunk of the Corolla prior to the -- the
- 22 Pinellas County Sheriff's Office forensics arriving?
- 23 A. I don't know. Again I would check the video
- 24 and I'm happy to identify anybody that you need
- 25 identified.

- 1 Q. Okay.
- 2 Did -- did you examine, yourself, any of the
- 3 contents of the trunk of the Corolla?
- 4 A. I believe I looked in the trunk. I didn't
- 5 reach in and touch anything or manipulate anything.
- 6 Q. Okay. So --
- 7 A. I don't -- I don't recall if that was before
- 8 or after the search warrant. Again, I would refer to
- 9 the video.
- 10 Q. Okay.
- 11 And as far as -- the same question for the interior
- 12 of the Corolla. Do you recall who, with Largo Police
- 13 Department, examined that prior to the arrival of
- 14 Pinellas County Sheriff's Office forensics?
- 15 A. I do not. Again there is video of the car and
- 16 that is the most accurate representation of what anyone
- 17 did on that scene.
- 18 Q. Okay.
- 19 A. And I'm happy to answer any questions or
- 20 identify anybody that you might have.
- 21 Q. Okay.
- 22 Were you present when the search warrant for the
- 23 car was read at the scene?
- A. I was present for a portion of it. I did not
- 25 stand by with Officer Rose while she read the entire

- 1 thing. But she captured that on her body camera was my
- 2 understanding.
- 3 Q. Okay.
- 4 And when she read the search warrant, where did she
- 5 read the search warrant?
- 6 A. She read it out to the car at the -- the hood
- 7 of the car.
- 8 Q. Okay.
- 9 And would it be fair to say that Dr. Kosowski,
- 10 being locked in the patrol car with air conditioning
- 11 running and handcuffs in the different location was
- 12 probably unlikely to be able to hear the reading of the
- 13 warrant?
- 14 A. I don't know how their video system works, so
- 15 if the video plays the audio, I mean that would be able
- 16 to be done but I don't -- I don't know that he heard it,
- 17 no.
- 18 Q. Okay.
- 19 So then let me, I guess, rephrase that then.
- 20 Would it be fair to say that unless they were
- 21 feeding audio into the patrol car --
- 22 A. Correct.
- 23 Q. -- where he was held and handcuffed, it is
- 24 unlikely that he would have been able to hear the
- 25 reading of the search warrant of his Toyota Corolla.

- 1 A. Correct.
- 2 Q. Okay.
- 3 And when the search warrant was read, had Pinellas
- 4 County Sheriff's Office forensics arrived?
- 5 A. I would check the -- the video. I don't have
- 6 their timestamps with me when they --
- 7 Q. Okay.
- 8 But at some point shortly after -- at some point
- 9 shortly after the reading of the search warrant is -- is
- 10 it fair to say that Pinellas County Sheriff's Office
- 11 forensics processed the car at the scene?
- 12 A. After the search warrant was written, which --
- 13 was read, excuse me, which I have a timestamp of
- 14 approximately 4:59 p.m. on the 25th of March, 2023.
- 15 After that was read, forensics did its initial
- 16 processing at the scene and then they removed the
- 17 vehicle to finish processing in their vehicle processing
- 18 bay.
- 19 Q. Do you know whether or not Pinellas County
- 20 Sheriff's Office forensics were able to obtain any
- 21 presumptive tests at the scene indicating the possible
- 22 presence of blood?
- 23 A. I don't recall whether or not they did that at
- 24 the scene or not. Detective Allred was tasked with
- 25 being the liaison with Forensics so I would imagine that

- 1 he would have any of that information with the
- 2 presumptive at the scene or whether it was done at the
- 3 vehicle processing bay.
- 4 My understanding is that there was blood found in
- 5 the trunk.
- 6 Q. At what point?
- 7 A. I -- I don't know.
- 8 Q. Okay. So -- so you're saying at some point it
- 9 was your understanding that -- that blood was found but
- 10 not necessarily at the -- at the site of 34 Orange
- 11 Street, correct?
- 12 A. I don't know where it was found. I don't
- 13 know -- I don't recall where the presumptive tests were
- 14 conducted that were positive. Again Supervisor Klein
- 15 was on scene. I would imagine that the forensics unit
- 16 members and technicians that did that would document
- 17 that in their reports.
- 18 Q. Okay.
- 19 My -- my understanding is that there were negative
- 20 processing results at the -- at 34 Orange Street as it
- 21 relates to blood.
- 22 Do you recall having any discussions with Klein or
- 23 Briggs about negative results for blood at the scene?
- 24 A. I don't have any independent recollection of
- 25 that, no.

- 1 Q. Okay.
- 2 A. I would -- I would refer to their -- their
- 3 expertise and their supplements.
- 4 Q. Okay. Okay.
- 5 A. But my understanding is, is that items in the
- 6 trunk were found to have blood on them when they did a
- 7 thorough processing; but again I would talk to
- 8 Detective Allred about that because he was present for
- 9 all of that.
- 10 Q. Okay.
- 11 And it's important, I believe, and I could be
- 12 wrong, that we're very careful about, you know, the
- 13 time -- the timeline of when things happen so that we
- 14 know what was known at the scene of the stop, what was
- 15 known later on and what have you. And -- and you don't
- 16 recall when you were made aware -- you don't recall
- 17 whether or not you were made aware about negative
- 18 findings on 34 Orange Street, correct?
- 19 A. No. I don't have an independent recollection
- 20 of that.
- 21 Q. Okay.
- 22 And in your reports do you have any -- any notes
- 23 suggesting that you were advised or that you learned
- 24 that there were negative findings --
- 25 A. I don't have anything.

- 1 Q. -- on 34 Orange Street?
- 2 A. I don't have anything in my report that I've
- 3 seen that --
- 4 Q. Okay.
- 5 A. -- would say that.
- 6 Q. Okay.
- 7 Do you have anything in your report suggesting that
- 8 there was positive findings for blood at 34 Orange
- 9 Street?
- 10 A. I --
- 11 Q. Not later on, but at 34 Orange Street.
- 12 A. I do not.
- 13 Q. Okay.
- 14 And do you recall speaking with Specialist Klein or
- 15 Briggs at the scene of 34 Orange Street about the
- 16 results of their -- or their conclusions of what they
- 17 had found or not found?
- 18 A. I don't -- I don't remember having a
- 19 conversation with them. So again, I would refer to
- 20 their reports.
- 21 Q. Okay.
- 22 A. And Detective Bolton as well as he's the
- 23 primary detective for -- for this case.
- 24 Q. Okay.
- 25 So Detective Bolton is -- is the primary detective.

- 1 What was your -- what was your role?
- A. I assisted him with his interviews. I would
- 3 say that I became the secondary detective during the
- 4 course of the investigation.
- 5 Q. Okay.
- 6 Does that generally mean that you're pretty much
- 7 going to share amongst the two of you anything that
- 8 might be of significance as it relates to the
- 9 investigation?
- 10 A. That's likely.
- 11 Q. Okay.
- 12 A. So we -- we were both -- up to getting to
- 13 Orange Street we were -- we had worked most everything
- 14 together. I was present for most all of his interviews.
- 15 There was some interviews that he had done the first day
- 16 that I wasn't present with; Detective Compton was
- 17 present for.
- 18 Q. Sure.
- But -- but presumably, if there was information
- 20 obtained by Detective Bolton during the interviews that
- 21 you were not present for that -- that were -- that was
- 22 of significance, he would most likely tell you about it.
- 23 A. Yeah. I mean he would probably tell me about
- 24 it.
- 25 Q. Okay.

- 1 And would it be fair to say that, you know -- well,
- 2 when you -- when -- last time you were deposed and you
- 3 were talking about the fact that you could -- could have
- 4 searched it without a search warrant, you know, you
- 5 had -- I believe you had indicated, you know, maybe
- 6 Cozzi would be in the trunk. Right?
- 7 A. That's possible.
- 8 Q. Okay. Obviously if you had opened the trunk
- 9 and Cozzi was in the trunk, you know, you would have
- 10 noted that and that would be significant.
- 11 A. Correct.
- 12 Q. Likewise, if -- if you had, you know, opened
- 13 the trunk and, you know, in plain sight saw large
- amounts of blood, that would be significant.
- 15 A. Correct.
- 16 Q. In fact, if you would see any blood in the
- 17 trunk it would be significant and it would be noted.
- 18 A. Correct.
- 19 Q. Okay.
- 20 The -- the search warrant for the Corolla, was that
- 21 a warrant that authorized you both to search it and to
- 22 seize it and then take it into evidence?
- 23 A. My understanding is that the sheriff's office
- 24 was listed on here, as well as Tarpon Springs because
- 25 we -- we were outside of our jurisdiction.

- 1 Q. Uh-huh.
- 2 A. Therefore, the Sheriff's Office forensics
- 3 division conducted their processing and whatnot, and
- 4 they seized the items and we later got the items out of
- 5 their property and evidence division.
- 6 Q. So when -- so when the -- when the Toyota
- 7 Corolla was initially taken from 34 Orange Street, who
- 8 made the decision to remove it from there and take it to
- 9 the impound?
- 10 A. Forensics made that decision.
- 11 Q. So the sheriff's department forensics?
- 12 A. To -- yeah, to preserve evidence and things
- 13 like that. They did -- we don't want to be removing
- 14 things from the vehicle sitting on the side of the road,
- 15 things like that; we want to be in a controlled
- 16 environment to preserve the integrity of the contents
- 17 therein.
- 18 Q. Okay. And -- and was it basically the -- was
- 19 that a decision that they made independently or did
- 20 Largo have any involvement in that aspect of it as far
- 21 as preserving it and impounding the vehicle?
- 22 A. I think that that's standard practice for the
- 23 Sheriff's Office is to process their vehicles in a
- 24 controlled environment. In fact, they have secured
- 25 evidence storage, secured evidence bays that they --

- 1 they search vehicles and process vehicles in.
- 2 Q. Okay. And I guess my question was did -- were
- 3 you consulted at all about whether or not the Toyota
- 4 Corolla should be moved from the location where it was
- 5 searched, to the secondary location where there was a
- 6 continuous search, or was it just done without
- 7 consulting with you?
- 8 A. I -- I don't have any independent
- 9 recollection, but I don't know.
- 10 Q. Okay.
- 11 A. That's always been my practice. That's --
- 12 that's what we've always done with the sheriff's office
- 13 when -- they take vehicles and they search them when we
- 14 get warrants and things like that.
- 15 Q. Okay.
- 16 Were you involved in the drafting of the body --
- 17 body warrant, the body search warrant?
- 18 A. No, I was not. Detective Moore was tasked
- 19 with that and took care of that.
- 20 Q. Okay.
- 21 Do you have any knowledge as to when that was
- 22 completed and ready for submission?
- 23 A. I know that CloudGavel was having issues
- 24 because it did not have the appropriate format for a
- 25 body warrant and so they had attempted to contact

- 1 CloudGavel. They didn't have luck with that and so they
- 2 had to handwrite the warrant and take it to the judge's
- 3 house. I would imagine that Detective Moore would have
- 4 documented his timeline with what he had done.
- 5 The only thing that I have is that when he had met
- 6 me and provided me with the true copy of the warrant I
- 7 did not keep a detailed timeline of the issues that he
- 8 was having when he was working with the attorneys and
- 9 trying to procure that warrant.
- 10 Q. Okay.
- 11 And -- and Detective Moore, is he with Largo Police
- 12 Department?
- 13 A. That is correct.
- Q. Okay. And so he -- he's the one that drafted
- 15 the body warrant?
- 16 A. Correct.
- 17 Q. Okay.
- Do you have the time that it was actually signed by
- 19 the judge?
- 20 A. I do not have the time that it was signed by
- 21 the judge. I would imagine that is -- I would imagine
- 22 he would have documented that but I don't have the time
- 23 with me now.
- 24 Q. But your understanding is that -- that he went
- 25 to the judge's home to have it signed?

- 1 A. That is my understanding and then he responded
- 2 to me; and that at approximately 12:50 a.m. on the 26th
- 3 of March 2023, he met me at the location where the
- 4 traffic stop was, provided me with the true copy of the
- 5 body warrant.
- 6 Q. Okay. And you say you don't know -- do you
- 7 know the judge that signed it?
- 8 A. I -- I would have to look at the body warrant.
- 9 Q. Do you have it readily available?
- 10 A. I do not. I have the warrants that I did.
- 11 Q. When -- when Dr. Kosowski was initially
- 12 detained, which was at the time of the traffic stop,
- 13 right?
- 14 A. Correct.
- 15 Q. From what you know was there probable cause to
- 16 arrest him at that time?
- 17 A. I would talk to Detective Bolton about that
- 18 because it's his case and he's the one that determined
- 19 when he had probable cause in reference to his arrest.
- 20 Q. Okay.
- 21 Would it be fair to say that -- that regardless of
- 22 whether he had probable cause or not he was not arrested
- 23 at that time?
- A. When we initially made contact with him we
- 25 were detaining him.

- 1 Q. Right.
- 2 A. We didn't place him under arrest until later
- 3 after -- actually until after the body warrant is when
- 4 Detective Bolton advised him that he was under arrest.
- 5 Q. There -- there are -- there's several
- 6 recordings in discovery that -- I think they're referred
- 7 to as -- I don't know if they're welfare checks or --
- 8 let me see here.
- 9 Yeah, I think they're -- follow-up.
- And it's basically videos, little, short segments
- 11 of videos where -- where various individuals with law
- 12 enforcement has contact with Dr. Kosowski during the
- 13 period that he is detained.
- 14 A. Okay.
- 15 Q. And some of those include you when you have
- 16 contact with him.
- 17 A. Okay.
- 18 Q. I believe at one point you actually help him
- 19 drink some water, if I recall.
- 20 A. I do.
- 21 Q. Yeah.
- 22 And at some point he's taken to Largo -- I mean to
- 23 Tarpon Springs Police Department to use the bathroom;
- 24 were you there for that?
- 25 A. I was.

- 1 Q. Okay.
- 2 There is a point in time where Dr. Kosowski is
- 3 asking to see everyone from law enforcement. And -- and
- 4 then there is a gathering where he's asking questions
- 5 about how long he's going to be there, you know, is he
- 6 going to be able to go home and -- and do you recall
- 7 that?
- 8 A. I do.
- 9 Q. Okay.
- 10 At that point he was still detained, right?
- 11 A. That's correct.
- 12 Q. Had not yet been arrested?
- 13 A. He was not -- yeah. He -- Detective Bolton
- 14 had not had that conversation with him at that point.
- 15 Q. Okay. All right.
- 16 And did you guys -- do you recall what kind of
- 17 responses you guys gave him when he was asking if he
- 18 could go home and we could maybe meet up again tomorrow
- 19 and talk about this?
- 20 A. I don't have the exact response written down,
- 21 but we downplayed the fact that he was being detained
- 22 and that, you know, once we got him the body warrant we
- 23 would go from there. He asked if he could go home and
- 24 meet with us tomorrow and he would provide us the, you
- 25 know, whatever we needed for the body warrant, items

- 1 that we were wanting to collect; but obviously we didn't
- 2 do that because of preservation of evidence and, you
- 3 know, things being -- possibly being tampered with.
- 4 But I do recall telling him that he was being
- 5 detained. But again I would -- the recording is the
- 6 exact conversation that I had with him.
- 7 Q. Right.
- 8 Was there any discussions about possibly releasing
- 9 Dr. Kosowski after the search of the Corolla had been
- 10 concluded?
- 11 A. With Dr. Kosowski?
- 12 Q. Yes. Any discussions, any thoughts about
- 13 that?
- 14 A. I would listen to the recording. Again, our
- 15 contact with him we downplayed any idea of him going to
- 16 jail that evening.
- 17 Q. Okay. Okay.
- But -- but apart from -- apart from the -- the
- 19 recordings, now looking back at it, was there in your --
- 20 in your opinion as a detective, second in command, was
- 21 Dr. Kosowski -- was there any chance that Dr. Kosowski
- 22 was going to get released that night?
- 23 A. I think that there was discussion with where
- 24 we were going to go but it was my opinion that we had
- 25 probable cause for his arrest. So had I been the lead

- 1 detective I would have made the same decision that
- 2 Detective Bolton did and arrested him that evening.
- 3 Q. Okay.
- 4 Did you indicate what time the Corolla was towed
- from the scene, do you have that information?
- 6 A. Let me take a look.
- 7 Q. Okay.
- 8 A. I notate that Detective Allred took custody of
- 9 the Corolla at 6:20 and maintained custody of the
- 10 vehicle until processing was completed, but I did not
- 11 notate when it was removed from the scene.
- 12 Q. Okay.
- 13 A. I just note that Detective Allred would have
- done that or again there is a video of when Joe's came,
- 15 put it on the truck bed, took it, forensics and
- 16 Detective Allred followed it to its final location where
- 17 it was processed.
- 18 Q. But -- but certainly no later than 6:20 and --
- 19 and -- and, you know, possibly sometime before that,
- 20 maybe around 6:00 or something like that?
- 21 A. I wouldn't imagine so. No, because he took
- 22 custody of it six -- at 6:20 is what I have notated in
- 23 my -- my report.
- 24 Q. Right. Mean -- meaning -- meaning what? Was
- 25 that -- that's when it left the scene or -- or --

- 1 A. That was when I spoke -- we spoke,
- 2 Detective Allred was tasked with taking custody of the
- 3 vehicle and going to the scene.
- 4 So again, my recollection from almost two years ago
- 5 is that the vehicle was put on a tow truck; it was on
- 6 the tow truck for a little while before it ended up
- 7 leaving. But Detective Allred coordinated following the
- 8 vehicle to PCSO forensic's vehicle processing bay.
- 9 If you look in my supplements later on, when I'm
- 10 tasked with that I -- I notate when the tow truck
- 11 leaves, when it arrives, when it's put into secure
- 12 storage; that's the responsibility of that detective
- 13 who's doing it, to maintain a chain of custody in
- 14 reference to that.
- 15 Q. Okay.
- Now after -- after the vehicle is -- is -- the --
- 17 the search of the vehicle has been completed, right? I
- 18 mean when it's on the tow truck to search it, the -- at
- 19 the street location has been concluded, Dr. Kosowski
- 20 remains in custody until -- at the scene until after
- 21 midnight, correct?
- 22 A. Correct. I mean we -- we leave to go to the
- 23 bathroom and things like that. He's detained, I
- 24 think --
- 25 Q. Sure.

- 1 A. -- during that time.
- 2 Q. Yeah, he's detained and he's sitting in the
- 3 back of this -- I mean it looks kind of crammed in the
- 4 back of that patrol car.
- 5 A. It's a Tahoe.
- 6 Q. I think at one -- at one point you actually
- 7 readjust the seatbelt or something, maybe in a -- in an
- 8 attempt to make it a little bit more comfortable maybe?
- 9 I don't know if you recall that or not.
- 10 A. That sounds accurate.
- 11 Q. Okay.
- 12 Why is the seatbelt on when he's not going
- 13 anywhere, sitting in the back of that; do you know?
- 14 A. I don't know why he was -- the seatbelt was
- 15 put on him.
- 16 Q. Okay. All right.
- 17 A. I -- I didn't put that on him.
- 18 Q. Okay.
- 19 Is there a reason why you couldn't have transported
- 20 Dr. Kosowski to the Tarpon Springs Police Department,
- 21 which is just ten minutes away and then -- or maybe
- 22 everyone could be a little bit more comfortable?
- 23 A. We were coordinating things with the State
- 24 with the warrant and things like that. Detective Bolton
- 25 was continuing his investigation and -- in reference to

- 1 whether or not he had probable cause for arrest. And I
- 2 think under an abundance of caution we did not remove
- 3 him from the place of the stop until we were comfortable
- 4 with doing that.
- 5 Q. So is -- is -- is the thought that you can
- 6 detain someone for, what, a reasonable time period?
- 7 A. My understanding of a Terry stop is that you
- 8 can detain somebody and that -- for a reasonable period.
- 9 We were affecting a body warrant for a homicide suspect
- 10 with a hope of collecting evidence and trace evidence
- 11 and things like that, so, we didn't want to remove him
- 12 from the stop and then have an issue later on. And he
- 13 was detained at that location until we secured that
- 14 warrant and then he was removed to the Tarpon Springs
- 15 Police Department where that warrant could be safely
- 16 affected because it would be the collection of evidence,
- 17 photographs, DNA and trace evidence from him in a
- 18 secured environment.
- 19 Q. Would you agree that -- that there's no
- 20 black-and-white, you know, guidance as to what a
- 21 reasonable time period might be?
- 22 A. I would say that due to the circumstances and
- 23 that we were actively working and trying to get a
- 24 warrant, I don't know what a reasonable period would be
- 25 for a -- for a homicide suspect under those

- 1 circumstances. That -- my opinion would be that's for a
- 2 judge to decide.
- 3 O. Sure. Sure.
- 4 And presumably it's your opinion that the period of
- 5 time that Dr. Kosowski was detained, in light of
- 6 everything, was a reasonable time period, right?
- 7 A. That would be my opinion, correct.
- 8 Q. Okay.
- 9 But -- but -- but what I'm asking you is are you
- 10 aware of any laws that breaks down sort of a limit on
- 11 what is constituted a reasonable time period?
- 12 A. I don't have any of that case law in front of
- 13 me, so.
- 14 Q. Okay.
- And has anyone suggested to you that there's like a
- 16 hard number or -- or is it your belief that -- that it's
- 17 sort of on case-by-case analysis?
- 18 A. I think that every case is dependent upon its
- 19 unique facts and circumstances.
- 20 Q. Okay. So I -- I -- I take that as you agree
- 21 that it's not -- there's not a hard number.
- 22 A. I would agree with that. I'm not aware of a
- 23 hard number.
- Q. Okay. All right.
- 25 A. If there is one and you have the case law I

- 1 would be happy to have that information and look into
- 2 it.
- 3 Q. Of course.
- 4 In your career -- well, first of all, how many
- 5 hours total was Dr. Kosowski detained before he was
- 6 arrested?
- 7 A. Well, the traffic stop was conducted at 3:19
- 8 on the 25th in the -- in the afternoon; 1519 hours. And
- 9 then I did not receive the body warrant until 0050 hours
- 10 on the 26th. So, 11 hours, approximately.
- 11 Q. Okay.
- 12 A. I'd have to sit down -- I'd want to sit down
- 13 and do the exact math to give you an exact --
- Q. Right. But somewhere in that range, right?
- 15 A. (Nods head).
- 16 Q. Have -- have you, in your career, ever had
- 17 another case where you detained someone for roughly
- 18 11 hours prior to making an arrest?
- 19 A. I have not. But this is -- this is a very
- 20 unique case and I've never had a case that's been like
- 21 this case.
- 22 Q. I understand. I understand.
- 23 You -- you indicated that you recall Dr. Kosowski
- 24 asking about being released, correct?
- 25 A. Yes, I believe. I don't recall his exact --

- 1 Q. Right.
- 2 A. -- verbiage but he had -- he had a
- 3 conversation with us about that.
- 4 Q. Sure.
- 5 Do you -- do you recall asking Dr. Kosowski how he
- 6 would get -- how he was going to get home if he was
- 7 released or after he was released?
- 8 A. I believe when I was downplaying things that I
- 9 did make that statement to him. Correct.
- 10 Q. Okay.
- 11 A. Or something to that account. Again --
- 12 Q. Sure.
- 13 A. -- there's a recording of it.
- 14 Q. Is it -- is it your opinion that -- that
- 15 the -- the most significant factor contributing to the
- 16 delay and -- and -- and then the extended period that
- 17 Dr. Kosowski was -- was being detained was the delay in
- 18 getting the body warrant?
- 19 A. It is my opinion that that is the only factor
- 20 that caused him to be there for as long as he is. We
- 21 had the search warrant pre-written for the Corolla. We
- 22 had no issues with CloudGavel. That went off well
- 23 without any issues.
- The factor that remained why we were there for so
- 25 long is because we were having issues with the body

- 1 warrant.
- 2 O. Sure.
- 3 But the Tarpon Springs Police Department was
- 4 five minutes away from the stop?
- 5 A. It was very close to the stop. I don't -- I
- 6 don't know -- I mean, at those hours, I -- at
- 7 approximately -- like the first -- when we went to the
- 8 bathroom, when we took him to the bathroom, we left at
- 9 0214 hours and we arrived at the Tarpon Springs Police
- 10 Department around -- I'm sorry, 2014 hours and then
- 11 2019 hours; so yeah, about five minutes with traffic at
- 12 that time.
- 13 Q. Okay.
- And what about Dr. Kosowski's home; how far was
- 15 that from -- from --
- 16 A. I'd have to -- I'd have to google that. I'm
- 17 not super familiar with Tarpon Springs. But it was
- 18 close by. It wasn't -- you know, it wasn't like --
- 19 Q. Fairly close by.
- 20 A. Yeah. Tarpon Springs is not a huge community
- 21 so he was close by his residence.
- 22 Q. Is there a particular reason why you -- you
- 23 could not have maybe escorted him either to Largo --
- 24 Tarpon Springs Police Department or to his home and
- 25 stayed stand -- standing by with him while you're

- 1 awaiting the -- the body warrant?
- 2 A. Again, I think under an abundance of caution,
- 3 under the Terry stop and him being detained at that
- 4 point and not making the physical rescue -- you know, he
- 5 obviously -- a detention of that length can go to a
- 6 de facto arrest, but he -- out of an abundance of
- 7 caution I believe that we just wanted to stay at the
- 8 place where he was stopped; detention cannot go beyond
- 9 the place of the stop. We were trying to get the body
- 10 warrant, Detective Bolton was piecing together a very
- 11 intricate investigation and determining whether or not
- 12 he had probable cause.
- Q. Okay. I know when you -- I think you said you
- 14 escorted him to -- to use the bathroom at Tarpon
- 15 Springs?
- 16 A. I accompanied him to the restroom; that is
- 17 correct.
- 18 Q. Alone, just you, or anyone else from Largo?
- 19 A. I think -- I mean Detective Bolton and I were
- 20 together. We drove there. I took the body camera, went
- 21 into the Tarpon Springs PD. I gave -- you know, I gave
- 22 him a reasonable amount of privacy but still maintained
- 23 visual contact with him. I asked him not to wash his
- 24 hands. He did wash his hands. You know, I mean just --
- 25 Q. He did or he did not?

- 1 A. He did wash his hands. He started to wash
- 2 them.
- 3 Q. Okay. So you asked him not to.
- 4 A. I asked him not to because we were getting a
- 5 body warrant.
- 6 Q. Uh-huh.
- 7 A. And then he used the restroom. He went over
- 8 to the sink to put his hands under the water and I
- 9 stopped him from doing that.
- 10 Q. Okay. So -- so he started to, sort of maybe
- 11 out of habit?
- 12 A. I don't -- I don't want to speak for
- 13 Dr. Kosowski.
- 14 O. Sure.
- Do -- do you recall whether or not he put soap on
- 16 his hands?
- 17 A. No, I don't believe he put soap on his hands.
- 18 Q. Okay. Did he put water on his hands?
- 19 A. I believe he -- his hands got wet, yes.
- Q. Okay. But you just stopped him pretty much
- 21 immediately?
- 22 A. Yes. I said hey, I need you to not wash your
- 23 hands. And then he was compliant.
- 24 Again, watch the video. Our entire conversation is
- 25 on there.

- 1 Q. Sure. Sure.
- 2 And -- and -- and why was that significant, the
- 3 idea that -- that he couldn't wash --
- A. For him --
- 5 Q. -- his hands?
- 6 A. Not to wash his hands?
- 7 Q. Yes.
- 8 A. It's significant because we're procuring a
- 9 body warrant which would include fingernail scrapings
- 10 and clippings. So if there were trace evidence of
- 11 Mr. Cozzi's DNA or blood underneath his fingernails, I
- 12 wouldn't want that to be washed off.
- 13 Q. Understood.
- 14 You would agree -- you would agree that
- 15 Dr. Kosowski did offer to -- he himself to appear the
- 16 next day voluntarily for the body warrant to be
- 17 completed, right?
- 18 A. He did offer that; however we would have no
- 19 way of maintaining a chain of custody with that
- 20 evidence.
- Q. Understood.
- 22 Do you know who -- who was responsible for making
- 23 the decision that Dr. Kosowski would remain detained and
- 24 not released?
- 25 A. Who was responsible for making the decision?

- 1 Q. Yeah, who made that decision. So after the
- 2 Corolla was seized and -- and -- and Dr. Kosowski was --
- 3 was detained, who made that initial decision?
- 4 A. I don't know who made that decision. I know
- 5 that ultimately Detective Bolton was the case agent. I
- 6 was -- I spoke with Detective Moore about getting a body
- 7 warrant. So he was -- he was detained so we could get
- 8 that warrant.
- 9 Q. Okay. You were in contact with the State
- 10 Attorney's office when you were working on the -- the
- 11 warrant?
- 12 A. Yes. Well, for the -- for the Corolla; I did
- 13 that.
- Q. For the Corolla, right. For the Corolla.
- 15 A. And the body warrant.
- 16 Q. And presumably the night before and at the
- 17 scene.
- 18 A. The day before. So I -- I was working on the
- 19 warrant. Again, like I said, I traveled to south
- 20 Florida with Detective Wedin; he drove. I was in the
- 21 passenger seat. I had my laptop with me and I was
- 22 writing that narrative on the PC.
- 23 Q. Okay.
- 24 MR. BRUNVAND: Guys, I need to take a real
- 25 quick break. Let's take -- are we good with taking

- 1 a five-minute break?
- 2 MR. VONDERHEIDE: That works.
- 3 MR. BRUNVAND: Okay. Thanks.
- 4 (There was a brief recess at 10:47 a.m. and
- 5 the proceedings reconvened at 10:52 a.m. with the
- 6 same appearances.)
- 7 MR. BRUNVAND: All right. Are we good?
- 8 THE WITNESS: We are.
- 9 MR. BRUNVAND: All right.
- 10 Q. (By Mr. Brunvand) Do you recall who you were
- 11 talking with at the State Attorney's office?
- 12 A. State Vonderheide.
- 13 Q. Okay. All right.
- 14 And did you discuss with -- with him the issue of
- 15 continued detention of Dr. Kosowski or the issue of
- 16 arrest of Dr. Kosowski?
- 17 A. Well, ultimately probable cause is up to the
- 18 officer. The State doesn't give guidance in reference
- 19 to having probable cause when an arrest is made. I
- 20 believe I had conversations with ASA Vonderheide about
- 21 he was aware that Dr. Kosowski was being detained and he
- 22 was notified when the arrest was made.
- 23 Q. Okay.
- 24 But as far as asking for his quidance as to
- 25 continued detention, was that done?

- Or was he just alerted as to what was taking place?
- 2 A. I explained to him what had taken place, where
- 3 we were at. He didn't voice any concerns to me that he
- 4 had to be -- be released or anything like that.
- 5 But again, the investigations are ultimately our --
- 6 our responsibility. The State has never, as practice,
- 7 given us guidance in reference to whether or not we have
- 8 probable cause for arrest and things like that. They do
- 9 assist us with search warrants and there's -- there's a
- 10 procedure that's set up for that, but ultimately we're
- 11 the ones that determine whether or not we have probable
- 12 cause or not.
- Q. And I guess -- I guess the follow-up, I guess,
- 14 would be because of the delays and -- and the extended
- 15 time period, do you recall whether or not you had any
- 16 discussions about, you know, how long you could detain
- 17 before -- before you had to make a decision about
- 18 releasing him or arresting him?
- 19 A. I don't -- I really don't recall that
- 20 discussion.
- 21 Q. Okay.
- 22 A. I may have asked if there was case law because
- 23 again, I wasn't sure -- I wasn't aware of any case law
- 24 that gives, you know, a hard black-and-white line of
- 25 this is the amount of time you have and things like

- 1 that.
- 2 Q. Okay.
- 3 And do you recall what his response was?
- A. I wasn't given any case law because if I was
- 5 given case law that hey, there was a dead -- dead
- 6 hardline, two, four, six, ten hours, we would have done
- 7 what was appropriate whether -- determined whether or
- 8 not we had probable cause to make physical arrest or,
- 9 you know --
- 10 Q. Release.
- 11 A. -- release him if we didn't have probable
- 12 cause.
- 13 Q. Okay.
- And would you agree that during the time period
- 15 that he is being -- that Dr. Kosowski is detained, he
- 16 did not have access to a phone?
- 17 A. That is correct.
- 18 Q. Did not have access to a lawyer?
- 19 A. That is correct.
- 20 Q. Okay. And was handcuffed in the back of the
- 21 police cruiser.
- 22 A. That is correct.
- 23 With the exception of taking his bathroom break I
- 24 mean he was --
- 25 Q. Sure.

- 1 A. -- you know.
- 2 O. Sure.
- 3 How long -- how long have you been a detective?
- A. I transferred up here, I think it was December
- 5 of 2020. So I just finished four years.
- 6 Q. Okay.
- 7 And how long have you been in law enforcement?
- 8 A. I started in December of 2007.
- 9 Q. Okay.
- 10 A. So what, I'm starting my 18th year.
- 11 Q. Very good.
- 12 The -- would you agree that -- that as a -- as a
- 13 law enforcement officer you do have the option, when you
- 14 have someone detained, to sometimes give them access to
- 15 a phone to make a phone call?
- 16 A. Sure.
- 17 Q. Okay. I mean, I'm assuming you probably have
- 18 done that in your career.
- 19 A. That's not my practice.
- 20 Q. Okay.
- 21 A. Individuals who end up getting arrested,
- 22 they -- they can use the phone call at -- to make a
- 23 phone call from the jail and things like that.
- 24 Q. Sure.
- 25 A. There have been situations. Recently I had a

- 1 case where a defendant wanted to speak with an attorney
- 2 but he said that he wanted to speak with me and asked
- 3 that if we could have the attorney come down, that he
- 4 would be willing to have a conversation with me and
- 5 things like that. I gave him the opportunity to call --
- 6 Q. Sure.
- 7 A. -- the attorney.
- But again, that was my case; I was the lead
- 9 detective and those circumstances were different in
- 10 reference to that case versus this case.
- 11 Q. Right. Right.
- 12 The -- but the bottom line is it -- you have the
- 13 discretion should you choose to use it.
- 14 A. Correct.
- 15 Q. Okay.
- And -- and probably most of the time when it is
- 17 used, it's -- it's where there might be a mutual benefit
- 18 by allowing it, to law enforcement and to the person
- 19 that's being detained.
- 20 A. I -- yeah. That would be -- be accurate.
- 21 Q. Okay.
- Were you -- do you recall if you were present
- 23 when -- when -- and I believe you were -- when there was
- 24 this little meeting, I guess, at the request of
- 25 Dr. Kosowski after several hours of being detained and

- 1 the Toyota Corolla having been removed from the scene?
- 2 A. My recollection is I was present for some
- 3 conversations with Dr. Kosowski with Detective Bolton.
- 4 He had asked to speak to everybody on scene.
- 5 Q. Right.
- 6 A. And from my recollection, we did not affect
- 7 that for him. We didn't -- we didn't have every member
- 8 of the scene come over to talk to --
- 9 Q. Sure.
- 10 A. -- Dr. Kosowski.
- 11 Q. Sure.
- But you do -- but you do have -- there is a moment
- 13 where there's multiple individuals; maybe -- maybe not
- 14 everyone but -- but at least two or three?
- 15 A. I believe -- I think -- I think on every
- 16 occasion that I was with Dr. Kosowski, it was me and
- 17 Detective Bolton.
- 18 Q. Okay.
- 19 A. I -- I'd have to look at the video again; like
- 20 I'm happy to look at that and the video's the most
- 21 accurate representation.
- 22 But I do recall Dr. Kosowski requesting to speak to
- 23 everybody on scene and I did not make that happen for
- 24 him. So there were occasions where we spoke with him
- 25 and there were a couple of people there.

- 1 Q. Right.
- 2 A. Like the Tarpon Springs officer wasn't -- had
- 3 to unlock the door for us and Detective Bolton and I
- 4 were there but we did not placate him with having a
- 5 meeting with everybody that was on scene.
- 6 Q. Understood. Understood.
- 7 But -- but during one of those meetings where there
- 8 was some questions back and forth and I -- and I'm not
- 9 sure if it was you or Bolton that started to get some
- 10 biographical information from him --
- 11 A. Detective Bolton, I believe, started getting
- 12 some biographical information and then he said that he
- 13 didn't want to provide any of that.
- 14 Q. Right. Right.
- 15 And -- and didn't want to talk anymore, right?
- 16 A. Correct.
- 17 Q. So basically at that point he invoked; but
- 18 your understanding is he had -- he had invoked earlier,
- 19 that's why --
- 20 A. My understanding is that he had invoked upon
- 21 initial contact with Detective Bolton.
- 22 Q. Okay.
- 23 A. During a conversation that we're having with
- 24 him Detective Bolton wanted to get some biographical
- 25 information; and during the course of recording that

- 1 biographical information, Dr. Kosowski explained he
- 2 didn't want to answer those questions and then --
- 3 Q. Sure.
- A. -- you know, so we -- we stopped, you know.
- 5 Q. And at least on one occasion, even in your
- 6 presence, if I remember correctly, Dr. Kosowski asked if
- 7 he could speak with a lawyer.
- 8 A. My understanding is he invoked his right to
- 9 counsel.
- 10 Q. Right.
- 11 A. And again, I would -- I would refer to all the
- 12 recordings.
- 13 Q. Understand. Understood.
- When -- when he's invoking his right to counsel,
- 15 did you guys have any discussions amongst yourself, you
- 16 and Detective Bolton or with any other supervisors about
- 17 whether or not you were going to give him access to
- 18 counsel while he's sitting there for hours on end?
- 19 A. No, I don't recall having a conversation about
- 20 that.
- 21 Q. Was it your belief that keeping Dr. Kosowski
- 22 detained for the duration that he was, that -- that that
- 23 was violating his civil rights?
- A. That is not my opinion, no.
- 25 Q. Okay.

- 1 Particularly as it relates to not having access to
- 2 a lawyer?
- 3 A. No, that is not my opinion.
- 4 Q. And would you -- would you -- what about as to
- 5 not giving him access to a telephone; do you believe
- 6 that that violated his civil rights?
- 7 A. No.
- 8 Q. Not giving him an access to the bathroom with
- 9 the exception of the one time?
- 10 A. I gave him access to the bathroom. As soon as
- 11 I was made aware that he wanted to use the restroom, we
- 12 made that -- those arrangements for him. So no, I do
- 13 not believe that his civil rights were violated.
- 14 Q. Okay.
- 15 You've indicated that -- that it wasn't your
- 16 decision as to when Dr. Kosowski would be arrested, but
- 17 that you felt like there was probable cause to arrest
- 18 him.
- 19 At what point did you feel like you had probable
- 20 cause to arrest Dr. Kosowski?
- 21 A. I think that -- and again, I don't have the
- 22 exact times because I don't have that in my report, but
- 23 in looking at the totality of everything, prior to us
- 24 taking him back and affecting the body warrant I believe
- 25 we have probable cause. In reference to the evidence

- 1 that was found at the -- in the bathroom of the doctor's
- 2 office, in the truck that was processed on the garage
- 3 floor of Dr. Kosowski's residence, the vehicle, the
- 4 items that were located inside the vehicle, the
- 5 paralytic agent, all of those things, I think that
- 6 that -- all of those things in totality gave us probable
- 7 cause for arrest.
- 8 Q. Okay.
- 9 A. But again, that wasn't my decision in
- 10 reference to this case; that was Detective Bolton's.
- 11 O. Understood.
- Do you recall Dr. Kosowski asking for a copy of the
- 13 search warrant for the Corolla?
- 14 A. I don't recall that; but again I would refer
- 15 to the video if he did ask for one.
- 16 Q. Okay.
- 17 A. I know one is -- one is with the -- with the
- 18 Corolla and one was also filed with the clerk's office.
- 19 Q. Obviously, Dr. Kosowski didn't have access to
- 20 the Corolla after he was detained, right?
- 21 A. That is correct.
- 22 Q. Okay.
- 23 So -- and but he was not provided a -- excuse me
- 24 one second.
- 25 He was not provided with -- with a copy, right?

- 1 A. No.
- Q. Okay.
- 3 Did you -- during the search at the location where
- 4 his -- where the Toyota Corolla was stopped, did you
- 5 take custody of Dr. Kosowski's iPhone and a TracFone?
- 6 A. I know that -- let me -- let me review this
- 7 real quick. I want to give you times and things like
- 8 that.
- 9 So after the warrant was read Officer Rose began a
- 10 precursory search of the vehicle, located a phone in the
- 11 cup holder at 1728 hours and that phone was provided to
- 12 Detective Wedin at 1729. And then at 1755 hours the
- 13 second phone was located by PCS forensic -- PCSO
- 14 forensic Supervisor Klein; and again, that was secured
- and provided to Detective Wedin at 1756.
- So Detective Wedin took possession of those two
- 17 phones and maintained custody of them.
- 18 Q. Were they in your custody at some point? You
- 19 handed them over to Detective --
- 20 A. Yeah, I think I was present. I called
- 21 Detective Wedin over and he took custody of them.
- 22 Q. Okay.
- 23 A. Again Officer Rose is with Tarpon Springs and
- 24 then Supervisor Klein was -- is with the Sheriff's
- 25 Office forensics division.

- 1 Q. Prior to seizing those two phones from
- 2 Dr. Kosowski at the Corolla search, did you or members
- 3 of the Largo Police Department have access to --
- 4 THE WITNESS: I apologize give me one second;
- 5 you disappeared.
- 6 MR. BRUNVAND: I disappeared?
- 7 THE WITNESS: Sorry. Can you hear me still?
- 8 MR. BRUNVAND: I can hear you, yeah.
- 9 THE WITNESS: I don't know what happened. The
- 10 whole -- I can hear you, I just can't see you
- 11 anymore.
- MR. BRUNVAND: Huh.
- THE WITNESS: But you can hear me so...
- MR. BRUNVAND: Yeah, I can hear you. I can
- 15 hear you.
- 16 THE WITNESS: Yeah. Okay. I apologize.
- 17 If you -- if you could restart your question.
- 18 My apologies.
- MR. BRUNVAND: Sure. Sure.
- 20 Q. (By Mr. Brunvand) So, prior to seizing
- 21 Kosowski's iPhone and TracFone during the Corolla
- 22 search, did you or Largo Police Department have access
- 23 to or use any data from his phones during the
- 24 investigation?
- Do you understand my question?

- 1 A. Yeah. Like -- we didn't like -- I didn't have
- 2 any access to his phones or anything like that. I know
- 3 that subsequent warrants were used. We utilized the
- 4 Flock system to -- for like the tags and things like
- 5 that, but we -- we didn't have like live location of him
- 6 or any of his content for any of his electronic media
- 7 stuff, no.
- 8 Q. Okay.
- 9 I believe around 2112 hours, or 9:12 p.m.,
- 10 Dr. Kosowski had asked you once again for an attorney
- 11 or -- or for a lawyer and that you responded we do not
- 12 contact an attorney for you on scene.
- Does that -- do you recall saying that?
- 14 A. That sounds accurate. I mean, I -- again, I
- 15 recall having somewhat of a conversation like that and I
- 16 refer to the video for the exact words I used.
- 17 Q. Okay.
- 18 And -- and what is the reason why individuals such
- 19 as Dr. Kosowski, in -- in general, at the scene when
- 20 they've been detained, are not given access to a lawyer;
- 21 do you know?
- 22 A. So my understanding is and how I've always
- 23 done it, with the exception of the case I just recently
- 24 did, any time that somebody wants an attorney and they
- 25 invite their -- invoke their right to counsel, I don't

- 1 ask them any more questioning. They have a right to a
- 2 lawyer before any questioning and during any questioning
- 3 and that's just not our practice. I mean, we don't --
- 4 we don't call attorneys for suspects and have them come
- 5 out.
- I mean, he was being lawfully detained under Terry.
- 7 We were working an active investigation. We were
- 8 procuring a search warrant for him, and that's not
- 9 something that we do. We don't -- we don't get an
- 10 attorney for them. That's -- they have a right to
- 11 counsel if they want them to be present before or during
- 12 questioning but we weren't questioning him so he was
- 13 being held for a warrant.
- 14 Q. He -- he -- he was -- and I think it was
- 15 shortly before the biographical information was -- was,
- 16 you know, obtained or started to obtain and, you know,
- 17 his place of employment and such, either Bolton or you
- 18 did advise him of his rights.
- 19 A. Bolton advised him of his rights.
- 20 Q. Okay. Right.
- 21 And when you advise them of their rights that
- 22 includes the right to an attorney.
- 23 A. Yes. Before or during any questioning.
- Q. Okay. All right.
- 25 And -- and I think you've indicated that your

- 1 policy and what you do is you -- you just stop asking
- 2 questions at that point and -- and don't provide a
- 3 lawyer.
- A. Yes. If they invoke their rights we do not
- 5 conduct an interview. We continue with what we need to
- 6 for our investigation and then they're transported to
- 7 county jail which they can make any arrangements they
- 8 need to for counsel.
- 9 Q. Being second in command of this investigation,
- 10 have you reached any conclusion as to how Steven Cozzi
- 11 died?
- 12 A. I have not.
- 13 You're asking by the means of how he died.
- 0. Correct.
- 15 A. Okay.
- Q. And then I guess as a follow-up to that, do
- 17 you have an opinion as to how Dr. Kosowski intentionally
- 18 caused the death of Steven Cozzi?
- 19 A. Well, I believe that I had explained to -- was
- 20 it -- was it Amanda at the previous --
- 21 Q. Uh-huh, right.
- 22 A. Yeah.
- 23 That it is my opinion, through evidence that has
- 24 been processed and collected, that Steven Cozzi was --
- 25 there was an incident that occurred in the bathroom of

- 1 his law office where his blood was located. He was
- 2 abducted from that area, placed in a Toyota Tundra that
- 3 Dr. Kosowski had purchased, that he did not register;
- 4 was taken to his residence in Tarpon Springs; was
- 5 removed from the Tundra and placed in his Toyota
- 6 Corolla; and was disposed of someplace in South Florida
- 7 where we had later gotten pings and had located a
- 8 dumpster and some videos and things like that.
- 9 I did not review that -- that video. But I -- I do
- 10 not know the mechanism that he used. I know that we
- 11 found a paralytic agent in Dr. Kosowski's possession
- 12 that was, from my understanding, taken without consent
- 13 from his medical practice.
- 14 But I -- I don't want to speculate on -- on
- 15 anything. Those are the facts that I know and I believe
- 16 that Steven Cozzi was killed and his body was disposed
- 17 of in South Florida.
- 18 Q. Okay.
- 19 But as far as specifically as to what happened, how
- 20 it happened, beyond what you just told us you don't know
- 21 anything beyond that.
- 22 A. I would talk to Detective Bolton about that.
- 23 Q. Okay.
- Are you familiar with some red-and-white fibers
- 25 being located on ballistic vests that were located in --

- 1 in, I believe, in the Corolla?
- 2 A. That sounds familiar.
- Q. Do you know what the significance of those
- 4 red-and-white fibers if any?
- 5 A. Well, I do believe that, according to video
- 6 surveillance, the day that Steven Cozzi was last seen at
- 7 his law office he was wearing a red sweater. But I
- 8 would talk to Detective Bolton about the significance to
- 9 any evidence in reference to his case.
- 10 Q. There is a -- also I believe a black duffle
- 11 bag with brass knuckles, duct tape, et cetera.
- 12 A. Masks, paralytic agent, all of those things.
- Q. Right. What's the significance -- evidentiary
- 14 significance of those items?
- 15 A. Well, we have a person that was abducted from
- 16 an office so I think that having a paralytic agent in
- 17 his possession, masks, duct tape, those all go towards
- 18 somebody that was going to abduct somebody.
- 19 Q. Would -- but would you agree that -- that
- 20 specifically there's no indication necessarily that any
- 21 of those items were used?
- 22 A. I don't know what has been done in reference
- 23 to the forensics processing of any of those items.
- 24 Q. Okay.
- Do you know, when the -- when the body warrant was

- 1 read by Deputy Spicer of the Pinellas County Sheriff's
- 2 Office, and not a Tarpon Springs Police Department
- 3 agent, do you know why it was read by Deputy Spicer?
- A. Deputy Spicer's a Pinellas County deputy, has
- 5 jurisdiction in the entire county; PCSO forensics was
- 6 collecting the evidence. So just for continuity with
- 7 having one agency do the -- the warrant versus two, I
- 8 think that was probably the reason that it was done.
- 9 Q. Okay.
- 10 A. Obviously, Tarpon Springs had conducted the
- 11 traffic stop for Dr. Kosowski's vehicle which is what
- 12 predicated them to do the warrant and everything because
- 13 they had detained him. But typically when I do warrants
- 14 outside of our jurisdiction, many times I use the
- 15 sheriff's office just for continuity; especially if
- 16 forensics is taking custody of the evidence.
- 17 Q. Would -- would it be fair to say that the
- 18 location where the body warrant was served was also in
- 19 Tarpon Springs Police Department jurisdiction?
- 20 A. In Pinellas County, yes.
- 21 Q. Right.
- 22 A. Ultimately the sheriff's office has
- 23 jurisdiction everywhere in Pinellas County.
- 24 Q. But did -- did you say the time that
- 25 Dr. Kosowski was actually arrested? Do you have that,

- 1 the exact time that he was arrested?
- 2 A. I don't have that. I would say that all of
- 3 that information and that determination was done by
- 4 Detective Bolton.
- 5 Q. Was it -- was it after -- before or after
- 6 the -- the body warrant was -- was conducted?
- 7 A. Detective Bolton explained to Dr. Kosowski
- 8 that he was -- what he was being arrested for after the
- 9 body warrant was conducted.
- 10 Q. Okay.
- 11 And do you know when the body warrant was -- was
- 12 completed?
- 13 A. The collection of evidence was completed at
- 14 1:44 a.m. on the 26th.
- 15 Q. Okay.
- 16 A. Is what I have documented -- documented in my
- 17 report.
- 18 Q. What additional evidence had been obtained
- 19 from the time of the initial stop by Tarpon and --
- 20 and -- and his arrest? So during that 11-plus hours
- 21 that he was detained --
- 22 A. My understanding is that presumptive blood was
- 23 located in the trunk; the bag that you've just indicated
- 24 with the mask, duct tape, paralytic agent, those things.
- 25 A large sum of cash, I think it was well over \$200,000

- 1 was in his possession; firearms was located in the
- 2 vehicle.
- 3 Q. Okay.
- 4 So any indication that firearms might have been
- 5 used in -- in --
- 6 A. I'm not sure.
- 7 O. -- in the location of the bathroom?
- 8 A. I'm -- I'm -- I'm not aware of any but I would
- 9 talk to Detective Bolton on any other evidence that he's
- 10 located. I know that there was a -- I think there was a
- 11 firearm with a silencer that was seized from his
- 12 residence; but again, Detective Bolton has all that
- 13 information. I'm just going on information I've
- 14 obtained over the past two years.
- 15 Q. Okay. Are you aware of any evidence that was
- 16 suggesting the use of any firearm in that bathroom?
- 17 A. I'm not aware of anything.
- 18 Q. Okay.
- 19 Were you involved in transporting the Toyota
- 20 Corolla and Tundra to Joe's Towing in Largo on
- 21 March 30th, 2023?
- 22 A. Yes.
- Q. And why was it necessary to transport the
- 24 vehicles to Joe's Towing?
- 25 A. So, the Pinellas Sheriff -- Pinellas County

- 1 Sheriff's Office has their vehicle storage and things
- 2 like that. We do not do long-term evidence storage with
- 3 the sheriff's office. And we do vehicle storage, it's
- 4 contracted through Joe's Towing. So I used to be a
- 5 member of traffic safety unit, so all of our vehicles
- 6 that are used in our traffic homicides and things like
- 7 that are stored in an evidence bay there.
- 8 So since these two items -- these two vehicles were
- 9 seized as evidence we had to have a place to secure
- 10 them; so our long-term vehicle evidence storage is at
- 11 Joe's Towing.
- 12 Q. Do you know how the vehicles are maintained at
- 13 Joe's Towing?
- 14 A. So they are under lock and key and the key is
- 15 submitted as evidence with our property division
- 16 downstairs. And my understanding is that shows -- also
- 17 has surveillance system on the -- on the property that
- 18 overlooks those evidence bays.
- 19 Q. Do you know whether or not the batteries are
- 20 maintained?
- 21 A. On what?
- 22 Q. On the -- on the vehicles.
- 23 A. Oh -- no. So, one -- like the Tundra was
- 24 secured in its own garage because there wasn't space for
- 25 it in the -- in like the vehicle compound that's

- 1 segregated and secured, so they had an extra open garage
- 2 that we've used in the past, so that's -- that's in
- 3 there alone. But we don't maintain the batteries on
- 4 vehicles, no.
- 5 Q. Okay. So then what about anything done as far
- 6 as fuel additives to the gasoline or the tires or
- 7 anything like that?
- 8 A. There is no vehicle maintenance that is
- 9 conducted on the vehicles when they are submitted as
- 10 evidence.
- 11 Q. What do you understand as far as the owner of
- 12 the vehicle being able to retrieve either one of those
- 13 two vehicles?
- 14 A. At the disposition of this case, after trial
- 15 and when it would be allowed to be disposed of as
- 16 evidence, the vehicle owner would be able to take
- 17 custody of the vehicles.
- 18 Q. Okay.
- 19 If there was ever a consideration of returning one
- 20 or two vehicles prior to the conclusion of the trial, is
- 21 that a decision that your department would make or is
- 22 that a decision that the State Attorney's office would
- 23 make?
- A. That, in my opinion, that would be a decision
- 25 that would be derived at mutually by both the State

- 1 Attorney's office and the Largo Police Department.
- 2 Q. Okay.
- 3 Have you considered possibly returning either one
- 4 of the vehicles to Dr. Kosowski or his representative?
- 5 A. No. And in fact, when I was a member of the
- 6 traffic safety unit, that was not our practice. The
- 7 vehicle that is being stored as evidence remains in
- 8 custody of evidence until that time which the case has
- 9 been disposed of, whether with a -- whatever that
- 10 disposition is and after a reasonable time for any
- 11 appeals to have taken place.
- 12 Q. Were you involved with the RPO that was sought
- 13 in this against Dr. Kosowski?
- 14 A. No. I believe Detective Compton authored that
- 15 RPO.
- 16 Q. When the RPO had been -- had been drafted, do
- 17 you know whether or not Dr. Kosowski had already
- 18 appeared for first appearance or advisory court?
- 19 A. I do not know the timeline of that, no. I
- 20 apologize.
- 21 Q. Okay.
- 22 A. But again, Detective Compton is the one that,
- 23 from my recollection, did all the RPO stuff.
- 24 Q. Are you familiar at all with the frequency
- 25 that people who are charged with capital first-degree

- 1 murder actually are allowed to be released on bond?
- 2 A. I don't have any of those numbers. No, I'm
- 3 not aware.
- 4 Q. Would you agree that it's very rare? Or do
- 5 you not know?
- 6 A. I don't -- I don't know. I don't -- I
- 7 don't -- I didn't run the stats for it, so I would
- 8 imagine that, you know, if you're saying that it's rare
- 9 I would say -- imagine that I would -- I would give
- 10 validity to that; but I don't know.
- 11 Q. Okay.
- 12 And so as far as the RPO is concerned, you had
- 13 no -- no involvement in that whatsoever?
- 14 A. No.
- 15 Q. Okay.
- 16 There's an allegation in the RPO that Dr. Kosowski
- 17 has serious mental illness, or having recurrent mental
- 18 health issues. You have any involvement in providing
- 19 information that would support that allegation?
- 20 A. I do not.
- 21 Q. Did you yourself have any concerns about
- 22 Dr. Kosowski having any type of mental illness?
- 23 A. Well, in reference to the crime that he was
- 24 arrested for, I don't think that it's normal for a
- 25 plastic surgeon to -- or an attorney that he's having a

- 1 feud with, that -- that would be, to me -- I mean, I
- 2 think that circumstances of the case may -- would be one
- 3 that he could be suffering from mental health issues.
- 4 Q. Okay.
- 5 But as far as what those issues would be, do you
- 6 have any -- any idea or any thoughts?
- 7 A. I had very little contact with Dr. Kosowski
- 8 and all of it's video and audio recorded.
- Q. Okay.
- 10 And again, I guess as to statements in the RPO
- 11 about human blood in the trunk bed, you didn't provide
- 12 any of that information; is that accurate?
- A. Not to my recollection, no. Again,
- 14 Detective Allred is the one that was with forensics when
- 15 that was being processed so he would have been the law
- 16 enforcement officer that had firsthand information in
- 17 reference to that.
- 18 Q. Did you have information that there was human
- 19 blood in the trunk bed?
- 20 A. That was relayed -- in the truck bed?
- 21 Q. Yes, in the truck.
- 22 A. I'm sorry. I thought you said in the trunk.
- 23 Yes, in the truck bed, I had information in reference to
- 24 that.
- 25 Q. Okay. What about in the trunk bed? Trunk.

- 1 A. In the trunk of the Corolla --
- 2 O. Yes.
- 3 A. -- I was provided that information by
- 4 Detective Allred.
- 5 In reference to the bed of the Toyota Tundra, I was
- 6 present when the residential search warrant was affected
- 7 by Tarpon Springs and I was present with two Tarpon
- 8 Springs detectives and I observed what appeared to be
- 9 blood. That also tested presumptively positive later on
- 10 by forensics in the bed of the Tundra the night of the
- 11 residential search warrant.
- 12 Q. Okay. And -- and would you agree though that
- 13 a -- that -- that a presumptive test does not
- 14 conclusively indicate that blood is present?
- 15 A. There could be false positives; however, it is
- 16 my understanding that the substance that was tested,
- 17 tested positive as Steven Cozzi's blood from PCS --
- 18 PCSO lab.
- 19 Q. And do you know the date that you obtained
- 20 that information?
- 21 A. Detective Bolton is the one that got all that
- 22 information and sent those lab reports out -- or those
- 23 lab requests out.
- Q. Presumably on a date after the arrest of
- 25 Dr. Kosowski?

- 1 A. Yes.
- 2 Q. Okay.
- 3 A. But you asked if they could be --
- 4 Q. Right.
- 5 A. -- false positives.
- 6 Q. Sure.
- 7 A. It's possible; however this test that tested
- 8 positive ended up, in fact, not just being blood but it
- 9 ended up being Steven Cozzi's blood.
- 10 Q. Sure. Sure.
- 11 But -- but the point being that when it's first --
- 12 when you see what you believe might be blood, and -- and
- it's tested and it's positive presumptively for blood,
- 14 at that point you don't really know that it's blood, you
- 15 know that it's tested -- presumptively tested as blood,
- 16 but you can't -- you can't say that it's blood at that
- 17 point in time.
- 18 A. What I will say is that it is my understanding
- 19 through cases that presumptive tests are sufficient for
- 20 probable cause; and the reason that we follow up with
- 21 the laboratory is for proof beyond a reasonable doubt.
- 22 Q. Okay. So I understand you to say it's
- 23 sufficient for probable cause; but again, my -- my
- 24 question is you can't say that it's actual blood until
- 25 it's been actually tested forensically to indicate that

- 1 it's actual blood; would that be a fair statement?
- 2 A. I just want to qualify my answer.
- 3 Q. I understand. I understand.
- 4 And I just want to further clarify.
- 5 A. Not a problem.
- 6 Q. Okay.
- 7 The RPO also stated that there was a large quantity
- 8 of human blood at the 1501 Belcher bathroom. Again, you
- 9 didn't provide that information?
- 10 A. No.
- 11 Q. Okay.
- 12 And -- and I think the quantity of blood, to some
- 13 degree, has already been discussed.
- 14 A. Yes.
- 15 Q. Would -- would it be fair to say your initial
- 16 impression at -- at the 1501 Belcher bathroom was that
- 17 there was not a lot of blood there; did not appear to be
- 18 a lot of blood there?
- 19 A. I would say that the initial observations
- 20 there was what appeared to be blood on the door, on the
- 21 urinal, right next to the urinal, on the toilet; but
- 22 upon further processing and inspection with the floor,
- 23 there appeared to be a larger quantity of blood that was
- 24 smeared in a circular area and there was a drain on the
- 25 floor. So I don't know that I can give you an exact

- 1 quantity of blood that was in the bathroom.
- 2 Q. Okay.
- 3 Are you familiar with the first responding officers
- 4 at the -- at that location making statements that it did
- 5 not appear to be a significant amount of blood in the
- 6 bathroom?
- 7 A. I would refer to them and their reports and
- 8 anything else that you might have.
- 9 Q. Okay.
- 10 So -- so you don't recall that or --
- 11 A. I don't recall the exact verbiage that the
- 12 other officers used.
- Again, I went in; my first initial impressions were
- 14 there was some blood here, there was some blood there;
- and then upon closer inspection Detective Bolton was the
- one that had noticed the larger area on the floor by the
- 17 drain and the circular pattern. There was discoloration
- 18 on the wall. He brought that to my attention. I went
- 19 back in and took a look at it with him and observed what
- 20 he had located.
- 21 Q. Were you involved at all in -- in seizing
- 22 firearms and -- and/or silencers as a result of the RPO?
- 23 A. No, I was not involved in any of that. In
- 24 fact, the only part of Dr. Kosowski's residence that I
- 25 had entered was the garage area. And that was after the

- 1 search warrant was affected.
- 2 Q. You had mentioned a substance when you talked
- 3 about probable cause. You've mentioned a substance that
- 4 had been taken from the surgery facility where
- 5 Dr. Kosowski was working?
- 6 A. So, upon probable cause we had the paralytic
- 7 agent. We did not know where that had come from. It is
- 8 my understanding that it had come back to the batch that
- 9 was at one of his employers. I don't have the dates
- 10 that that was done. I don't have the people that
- 11 corroborated that. That was just something in being
- involved in the case that I came to be aware of after
- 13 Dr. Kosowski's arrest.
- 14 Q. Do you know what that agent was?
- 15 A. Off the top of my head, no. I could -- I
- 16 believe it was listed in Detective Bolton's arrest
- 17 affidavit.
- 18 Q. Is there -- is -- is there a thought that that
- 19 agent was used to commit the murder?
- 20 A. You'd have to talk to Detective Bolton about
- 21 that.
- 22 Q. The -- the blood that you just described as
- 23 seeing at 1501-B Belcher bathroom initially, can you --
- 24 can you quantify that? I mean was it like -- as far as
- 25 teaspoon, tablespoon?

- 1 A. The area on the ground was -- appeared to be a
- 2 good portion of blood. But again, with there being a
- 3 drain in the floor there, I don't -- I don't know how
- 4 much blood in totality was lost at that scene. But it
- 5 appeared to be a larger amount, a -- a pool of blood
- 6 that was cleaned up.
- 7 Q. What -- would it be -- would it be fair to say
- 8 that -- okay. A pool, that it was cleaned up.
- 9 A. Uh-huh.
- 10 Q. So there's no -- there's not a pool of blood
- 11 present in the bathroom.
- 12 A. Correct.
- 13 Q. Okay.
- And presumably you've been to crime scenes where
- 15 there were -- there's blood everywhere.
- 16 A. Correct.
- 17 Q. Okay.
- That's not what we're talking about here.
- 19 A. Was this a -- I -- I would say that in looking
- 20 at that scene and in looking at the photos after
- 21 processing, it appeared that there was an event where a
- 22 larger quantity of blood was there and cleaned up.
- 23 Q. Okay. If you --
- 24 A. I -- I can't tell you how many liters. I
- 25 can't -- I can't tell you -- tell you that. I mean

- 1 we're -- can -- I apologize for that but that's the act
- 2 of it being cleaned up and things like that.
- Q. Understood.
- 4 So if you were going to try to gather blood from
- 5 that scene -- all right? -- collect it as evidence,
- 6 would it be fair to say that even collecting a teaspoon
- 7 of blood would be a challenge? To actually collect the
- 8 blood.
- 9 A. Blood that had not been cleaned up --
- 10 Q. Right.
- 11 A. -- I would say -- I would say that you had the
- 12 swipe on the door, by the urinal and on the toilet,
- 13 that -- that was a small amount of just pure blood that
- 14 had been missed in the cleaning process.
- 15 Q. And again, so my question is: If you were
- 16 going to try to gather the blood that's there, what you
- 17 believe is blood that's present, it would be a challenge
- 18 to even collect a teaspoon; is that a fair statement?
- 19 A. Because of it being cleaned up?
- 20 Q. Because -- well for whatever reason. I
- 21 mean --
- 22 A. Yes.
- 23 Q. -- in order for you to -- if I ask you to go
- 24 in and collect the substance that you believe might be
- 25 blood, it would be a challenge for you to collect even a

- 1 teaspoon of blood.
- A. Of blood alone?
- 3 Q. Right.
- A. Without anything else, with the cleaning
- 5 agents and things like that, yes. There was a -- a
- 6 smaller amount of blood that had not been cleaned up
- 7 that was left behind that was missed by Dr. Kosowski.
- 8 Q. Do you -- do you disagree with
- 9 the -- or do you -- do you have issues with the officer
- 10 who originally goes to this bathroom and who makes
- 11 statements to Mr. Blanchard and others that there
- doesn't appear to be a lot of blood in this bathroom?
- 13 Do you -- do you have issues with -- with --
- 14 with those statements?
- 15 A. Well, I think that to the naked eye and
- 16 without looking thoroughly after processing the scene, I
- 17 can see how that statement would be made.
- 18 Q. Okay.
- 19 A. But after the scene had been processed by
- 20 forensics, after evidentiary collection had been done,
- 21 alternate light sources had been used and you could see
- 22 where blood had been and cleaned up, then I think that
- 23 you have a -- a better view of the scene and you -- you
- 24 would have a different opinion.
- 25 Q. Sure. And -- and I don't know to what degree

- 1 you're familiar with the other substances that may cause
- 2 false positives as it relates to what's seen on the
- 3 walls and on the floor and what have you, but that's a
- 4 consideration, right?
- 5 A. I don't know everything that would provide a
- 6 false positive for whatever items forensic uses. I
- 7 don't know exactly what chemical agent they're using,
- 8 whether it's STR, sand, or luminol or whatever.
- 9 Q. Right.
- 10 And you -- would you -- would you
- 11 defer to the testimony and the judgment of -- of the
- 12 experts on that?
- 13 A. I would.
- 14 Q. Okay.
- 15 You -- you spoke in -- in the last time you were
- 16 deposed about an unknown male with a goatee and a
- 17 Jack Hanna-style shirt. Do you recall that?
- 18 A. Yes.
- 19 Q. And did you actually identify that person on
- 20 the surveillance video?
- 21 A. Did I identify that person?
- 22 Q. Yeah. I mean did you -- did you see that
- 23 person on the surveillance video?
- 24 A. Yeah, the -- I couldn't see their face but the
- 25 individual that enters -- and I'll get you the

- 1 timestamps. Give me a second.
- 2 In reference to the surveillance video, the
- 3 individual that enters dressed in jeans, a long-sleeve
- 4 white shirt and the backpack at around 8:34 a.m., the
- 5 shirt matches that description of what Celeste Bacher
- 6 had explained that she had observed; however there was a
- 7 box that was being carried by that individual and the
- 8 face was obscured on the surveillance video so I do not
- 9 know about facial hair and things like that.
- 10 Q. Okay.
- 11 A. When they entered the business.
- 12 Q. How many times does this person appear on the
- 13 surveillance video?
- 14 A. From what I watched and from my recollection,
- 15 that person enters and then is never seen again.
- 16 Another person matching that body description and
- 17 whatnot later exits at around 10:22 a.m. but they're
- 18 wearing a different outfit at that time. And that's the
- 19 person that is pulling on the wagon.
- 20 Q. Is it -- is it your belief that that's the
- 21 same person?
- 22 A. It's my belief that that's the same person and
- 23 that it's Dr. Kosowski.
- Q. So -- so the -- the person who is referred to
- 25 as the unknown male with the goatee and a Jack

- 1 Hanna-style shirt, you believe that's --
- 2 A. I believe that's the first person that is seen
- 3 on surveillance entering the property and I also believe
- 4 that that is Dr. Kosowski.
- 5 Q. Now, I thought there was a description of that
- 6 male having a goatee.
- 7 A. Celeste Bacher provided that description to
- 8 me. She approached me when I was on scene.
- 9 Q. Okay.
- 10 A. But again, the surveillance video -- because
- 11 there's no internal surveillance, the surveillance video
- 12 outside, when you watch it there's a -- there's a box
- 13 that's on his shoulder and you cannot see his face.
- 14 Q. Okay.
- 15 A. But again, in reference of the description of
- 16 the white Jack Hanna-style safari shirt, and the shirt
- 17 that I saw on the surveillance video, it appears to be
- 18 similar. It's a similar description.
- 19 Q. Would it be -- would it be fair to say that
- 20 there's no information that Tom Kosowski had a goatee at
- 21 the time?
- 22 A. I -- I'm not aware of whether he had a goatee
- 23 at the time or whether he had a fake goatee or whatever.
- 24 I -- I didn't have contact with the Dr. Kosowski that
- 25 day.

- 1 Q. Okay.
- 2 A. The only time I made contact with him he did
- 3 not have a goatee.
- Q. Okay. Did you question any of Dr. Kosowski's
- 5 neighbors and ask them if he had a goatee or not?
- 6 A. I did not.
- 7 Q. And why not?
- 8 A. I didn't question any of his neighbors.
- 9 Q. Okay. That was someone else's job?
- 10 A. Yeah. Someone else did neighborhood
- 11 canvasses.
- 12 Q. Okay.
- Did any other Largo Police Department agents
- 14 interview Ms. -- Mrs. Bacher after her photo lineup;
- 15 after she viewed the photo lineup?
- A. I did not do a photo lineup with her and I'm
- 17 not aware of -- I don't know. I did not interview her
- 18 and I did not conduct the lineup with her.
- 19 Q. When you -- when you first spoke with Jake
- 20 Blanchard -- I believe on March 21st, '23?
- 21 A. Yes.
- 22 Q. Did he indicate to you that he thought
- 23 Kosowski had harmed Steven Cozzi?
- A. The only person, you know, when we originally
- 25 showed up, we don't really know what we have. We're at

- 1 the infancy of our investigation and one of the things
- 2 that we do is we try to find out as much information as
- 3 we can about our victims. The only person that was
- 4 listed as ever having an incident with Steven Cozzi was
- 5 Dr. Kosowski.
- 6 Q. Okay.
- 7 A. However, I will say we didn't, you know -- and
- 8 maybe in hindsight we should have, but we -- we didn't
- 9 go and interview Dr. Kosowski. We -- we followed
- 10 evidence on surveillance video in reference to the
- 11 Toyota Tundra and that led us to Dr. Kosowski. Again,
- 12 we wanted to put all of our assets and resources on what
- 13 we knew we had. You know, we had Steven Cozzi in the
- 14 bathroom, removed from the bathroom, in the -- the wagon
- 15 to the Tundra; so we were following the evidence.
- 16 Q. Okay.
- 17 And I just want to make sure that you answered the
- 18 question. Did -- did -- did Jake Blanchard say that he
- 19 thought Kosowski had harmed Steven Cozzi?
- 20 A. I don't recall that statement being made; but
- 21 again, Detective Bolton interviewed him and I'm pretty
- 22 sure he audio recorded that so I would refer to the
- 23 audio recording.
- 24 Q. Okay. I believe you indicated when you were
- 25 first deposed that you believe Steven Cozzi's body is in

- 1 a landfill in Collier County.
- 2 A. Yes.
- 3 Q. Okay. Tell me a little bit more about that.
- 4 What -- what is -- what's your basis for that and --
- 5 and --
- 6 A. I didn't --
- 7 Q. -- and how strong is your belief?
- 8 A. I didn't respond to south Florida so my
- 9 opinion is based on conversations that I've had with the
- 10 unit that did respond there.
- 11 My understanding is after getting a warrant for
- 12 Dr. Kosowski's cellular telephone that there were cell
- 13 phone hits that led our team to a dumpster in south
- 14 Florida; that cadaver dogs hit on that dumpster; that
- 15 investigators ended up getting a video surveillance from
- 16 the trash truck that picked it up, and interviewing that
- 17 individual. He overwhelmingly described the odor of --
- 18 of a decaying carcass. In looking at the video it
- 19 appeared that there were trash bags that looked like a
- 20 body going into that trash truck.
- 21 But again, I -- I haven't looked at any of those
- 22 videos firsthand and that's my belief in reference to
- 23 following the evidence and what my team has shared with
- 24 me. But I -- again, I haven't looked at all of that
- 25 myself because I wasn't present for that portion of the

- 1 investigation.
- 2 Q. Are you -- are you comfortable putting a
- 3 degree of certainty as to that belief?
- 4 A. Without looking at everything firsthand by
- 5 myself I would refrain from giving a degree of
- 6 certainty.
- Q. Okay.
- 8 And -- and you do know that extensive searches were
- 9 done at the Collier County landfill?
- 10 A. I do know that.
- 11 Q. And I don't believe anything was found that
- 12 suggested that the body was there or had been there.
- 13 A. I don't know how -- because of the time delay,
- 14 I don't know how probable it would have been to be able
- 15 to find Steven Cozzi due to the time delay and the
- 16 amount of trash that was packed upon it, and all of
- 17 those things. I mean it's a huge landfill.
- 18 Q. Sure. And I don't know that -- I know
- 19 you're -- you're explaining why it wouldn't be there but
- 20 my question was, there wasn't anything that was located.
- 21 A. We did not locate his body, no; that is
- 22 correct.
- Q. Or any parts of his body.
- 24 A. That is correct.
- 25 Q. Or any part of any clothing that may be

- 1 associated with him.
- 2 A. That is correct.
- Q. Or anything belonging to him.
- A. Again, we do not locate any evidence in
- 5 reference to this case there. But again, I -- I don't
- 6 know how probable it would have been to locate any
- 7 evidence given the time delay and the circumstances.
- 8 Q. But sufficiently probable that a very
- 9 significant amount of resources were -- were dedicated
- 10 to that -- to that search over a period of days.
- 11 A. We did allocate a lot of resources. Again, I
- 12 wasn't present for any of that.
- 13 Q. Understand.
- And you may have already asked -- answered this.
- 15 But do you believe that there was a significant
- 16 bloodletting event at the 1501 Belcher bathroom --
- 17 1501-B Belcher bathroom?
- 18 A. I do, in looking at the totality of the scene
- 19 after forensics processed, and the cleanup that was done
- 20 and the drain on the floor.
- 21 Q. Do you recall having any discussions with
- 22 Pinellas County Sheriff's Office forensics about the
- 23 luminol results from that bathroom?
- 24 A. I believe Supervisor Camacho had informed me
- 25 and Detective Bolton that there was a presumptive

- 1 positive test for blood in the bathroom.
- 2 Q. Anything else?
- A. In reference to the?
- 4 Q. The luminol results.
- 5 A. Not off the top of my head.
- 6 Q. Anything about, you know, the significance of
- 7 the findings, you know, good or bad?
- 8 A. Is there a specific thing that you're
- 9 inquiring about?
- 10 Q. No. I'm saying, was there any other
- 11 discussion about the significance of the findings that
- 12 they had reported to you? I mean, you know, here --
- 13 here are -- here is the positives, here are the
- 14 potential negatives; here is the strength of it.
- Any of that type of discussion beyond just saying
- 16 presumptive positive?
- 17 A. Yeah, no, I don't recall any specific details.
- 18 Other -- other than the -- I believe it was Supervisor
- 19 Camacho had explained that it was presumptively positive
- 20 for blood.
- 21 Q. Okay.
- I believe on --
- 23 A. I know later on -- I apologize.
- Q. No, go ahead.
- 25 A. I know later on we were notified by the

- 1 lieutenant of the PCSO AFIS division that one of
- 2 Dr. Kosowski's prints was found in the utility closet at
- 3 the lawyer's office in reference to it, but that didn't
- 4 come from forensics. That came after forensics had
- 5 processed they had found fingerprints and things like
- 6 that; they sent that to AFIS and then they got a
- 7 positive match to Dr. Kosowski.
- 8 Q. Okay.
- 9 Was it your understanding that Dr. Kosowski had
- 10 been to that building for depositions and other matters?
- 11 A. It's my understanding that he was present for
- 12 a deposition. It is my understanding that he also
- 13 confronted Steven Cozzi in the same bathroom that this
- 14 incident took place during -- or --
- 15 Q. During that deposition?
- 16 A. At deposition, yes.
- 17 Q. Okay.
- 18 There's a canvass of -- of the neighborhood of 511
- 19 Seaview on March 22nd. I think Detectives Wagoner,
- 20 Sinni and Wedin?
- 21 A. Okay.
- 22 Q. Were you part of that?
- A. I was not.
- Q. Do you know anything about that particular
- 25 neighborhood canvass? Anything significant or anything

- 1 that you know about what they did and what they were
- 2 able to uncover?
- 3 A. No. I know that detectives had been tasked
- 4 with following surveillance video, following the Tundra.
- 5 We had located it on a PSTA surveillance as well and
- 6 they continued kind of leapfrogging down the road trying
- 7 to follow that Tundra where it went. Detective Gay had
- 8 located the Tundra, got a tag from it on a Flock hit
- 9 from a Tarpon Springs plate reader. And I believe they
- 10 were doing a neighborhood canvass to try to find any
- 11 personal surveillance that homeowners had to take that
- 12 vehicle to -- into the neighborhood and to
- 13 Dr. Kosowski's house.
- 14 The most important thing of significance
- 15 Detective Cor -- excuse me. Detective Compton had
- 16 viewed the video surveillance next-door to Dr. Kosowski
- 17 and had located the Tundra as well as the Corolla. The
- 18 Tundra going back to the residence and then never being
- 19 seen again, and then the Corolla leaving and then going
- 20 back to the residence.
- 21 But as far as canvassing the rest of the
- 22 neighborhood, I'm not -- I'm not aware of any specifics.
- 23 The only videos I had viewed was in reference to the --
- 24 the neighbor right next-door to Dr. Kosowski to the
- 25 south.

- 1 Q. The -- when did you become aware of the fact
- 2 that Dr. Kosowski was not at home on March 22nd,
- 3 March 23rd?
- 4 A. So, that would have been the day that
- 5 Detective Bolton and I responded to his residence. So,
- 6 we -- that would have been the 23rd.
- 7 Q. Okay.
- 8 A. So we went to the 511 Seaview Drive around
- 9 like 11:25. It was our intent to have a knock and talk
- 10 with Dr. Kosowski. And we arrived on scene; there
- 11 were -- garage door was shut, there was no cars in the
- 12 driveway. We went and knocked on the front door; there
- 13 was no answer. There was a door on the -- the main
- 14 floor; we went and knocked on that door and there was no
- 15 answer so we believed that he wasn't home.
- 16 Q. Okay.
- 17 A. Or I mean, he wasn't answering the door.
- 18 So I don't know -- I know that there was some plate
- 19 readers that came back later on. I don't know when I
- 20 was made aware of that in reference to the vehicle being
- 21 in south Florida.
- 22 Q. So I believe when you did this knock and talk
- 23 I guess, that you had your body camera, Axon Capture
- 24 camera activated.
- 25 A. So I was wearing a dress shirt. I took

- 1 Detective Bolton's work cell and he logged into the
- 2 Capture app that's on the cell phone.
- 3 Q. Right.
- 4 A. I put it in my pocket so I could covertly
- 5 record our contact.
- Q. Okay.
- 7 A. Without having, you know, what appeared to be
- 8 a camera strapped to my chest.
- 9 Q. Okay.
- 10 And when there's no answer, do you -- do you walk
- 11 around the side of the house and the perimeters of 511
- 12 Seaview?
- 13 A. So we walked downstairs. We walked in the
- 14 driveway. We didn't go back on his property. There was
- 15 a marsh area to the north that Detective Wedin had
- 16 looked up and seen that it was -- I think it's like
- 17 Swiftmud or something; it's not his property. And so we
- 18 went on that property just to kind of see what we could
- 19 see in the back.
- 20 On the north side of the house there's a chain link
- 21 fence. There's like sparse bushes. Originally I had
- 22 seen some tracks in the -- on the north side of the
- 23 driveway, kind of going through like a dirt, shell area.
- 24 And then I could see from that property to the north,
- 25 kind of looking through the chain link fence there was

- 1 some tracks and I kind of thought that it might be like
- 2 a pool worker or like -- with like the pool equipment;
- 3 they typically have the little thing on the back with
- 4 the wheels, so I didn't think that that was really
- 5 anything of note.
- 6 We did go to the neighbor to the south where
- 7 Detective Compton had reviewed their surveillance. She
- 8 was very cooperative. She allowed us to go in her
- 9 backyard and we just kind of went in the backyard to
- 10 kind of surveil what we could see from her property
- 11 without going on his property.
- 12 Q. So -- so the Axon Capture app did you -- that
- 13 was on Bolton's phone that you put in your pocket so you
- 14 could record interactions between Dr. Kosowski and
- 15 yourself, or whoever might answer the door -- right?
- 16 A. Right. And then when there was no answer I --
- 17 I turned the recording off.
- 18 Q. Why did you turn it off before you walked the
- 19 perimeters and -- I mean, you could have just kept it
- 20 on, right?
- 21 A. I guess I didn't see a reason to have it on.
- 22 I had it -- I was capturing it with the intention of
- 23 having a conversation with Dr. Kosowski.
- 24 Q. Okay.
- 25 A. So -- I use the same cell phone to take

- 1 photographs so Detective Bolton has those photographs
- 2 and they were uploaded in Evidence.com.
- Q. Would -- do you know whether or not the --
- 4 the -- the particular cell phone, this is Doc -- I mean
- 5 Detective Bolton's cell phone, right?
- 6 A. Uh-huh, yes.
- 7 Q. Do you know whether or not the GPS coordinate
- 8 feature for photographs was disabled on that phone?
- 9 A. I did not disable anything. I -- I could
- 10 barely get my -- my zoom thing working. I'm not super
- 11 tech savvy with computers.
- 12 Q. Okay.
- 13 A. I don't know what it records. I don't know if
- 14 Evidence.com or Axon captures that information when
- 15 we -- when we put it up. I -- I don't have any idea
- 16 about that.
- 17 Q. The photo --
- 18 A. I do know when you look at the photos you can
- 19 see the shrubbery and I kind of zoom in and look at
- 20 that. There -- there's a chain link specifically on the
- 21 north side because your former attorney had asked some
- 22 questions as well. There's no question on the south
- 23 side. That -- there's a -- there's a -- there's a fence
- 24 there. There's grass that's in her yard and shell
- 25 that's in his. We were very cautious of not going on

- 1 his property. And to the best of my knowledge I stayed
- 2 out of any property that belonged to him. I was in, you
- 3 know, that -- that property to the north.
- 4 But you can see from the -- from the photographs
- 5 that I took, kind of my viewpoint and where I was.
- 6 Q. Okay.
- 7 Would you agree that, you know, had you kept the --
- 8 the Axon app activated it would show us exactly where
- 9 you went on the -- both sides of the perimeter of the
- 10 property?
- 11 A. In hindsight, absolutely. Like, that wasn't
- done in any malicious intent or anything like that.
- 13 Everyone's been very forthcoming with me about, you
- 14 know, when we were on scene Detective Wedin found --
- 15 looked up the property appraiser, this is where it was,
- 16 and looking at the topography, I guess would be the
- 17 correct word, we -- we felt that we were not on his
- 18 property whatsoever.
- 19 Q. Okay.
- I believe when -- when you were deposed by
- 21 Ms. Sellers and you were talking about the use of the
- 22 SWAT team to gain entry to 511 Seaview, that SWAT became
- 23 necessary because you were serving a homicide warrant;
- 24 is that correct?
- 25 A. That wasn't a decision that I made but yeah,

- 1 any time that we're serving what we would deem a high
- 2 risk warrant we -- we use the SWAT team. And in fact,
- 3 you know, after the -- the incident that happened with
- 4 the FBI a few years ago, even when we're serving child
- 5 pornography warrants and things like that, we use our
- 6 SWAT team now just out of an abundance of caution.
- Q. Okay.
- 8 Had it been determined at that time that -- that --
- 9 that you were investigating a homicide?
- 10 A. I don't know when that determination would've
- 11 been made but yeah, I mean we're -- it was our belief,
- in looking at the evidence on scene, that Steven Cozzi
- was not just missing but he had been murdered.
- Q. Okay. So -- so I know -- I know when you guys
- 15 have contact with Kosowski, you know, at the scene with
- 16 the Corolla, you guys are still referring to it as a
- 17 missing person investigation; but should I assume from
- 18 that that really you had decided prior to the search
- 19 of -- of the home at 511 Seaview that you believed that
- 20 this was a homicide investigation?
- 21 A. Yeah, I would say that that's accurate. I
- 22 mean every time I go to a suicide to investigate it I
- 23 always investigate it as if it's a homicide.
- 24 Q. Okay.
- 25 A. I mean, you know, if we -- if we start at a

- 1 homicide for many of these cases, we don't end up having
- 2 to come back later on or miss things. You know, just
- 3 like a suicide, I don't want to -- it was titled a
- 4 missing person, he was listed as missing person, but we
- 5 were concerned that he had been murdered; if that makes
- 6 sense.
- 7 Q. Okay.
- 8 A. I don't know -- I don't know that we had
- 9 probable cause at that point for Dr. Kosowski upon
- 10 affecting the search warrant but it was a concern of
- 11 ours that he had been murdered.
- 12 Q. What is -- what is your definition of -- of
- 13 homicide?
- 14 A. The killing of one person by another person
- 15 with -- with the intent to effect their death.
- 16 Q. Okay.
- 17 A. I mean that's a summation of what the Florida
- 18 state statute is for. I mean my -- my opinion of what a
- 19 homicide is what the Florida statute says it is.
- 20 Q. Okay.
- I believe you indicated in your first deposition
- 22 that the -- if -- if the 511 Seaview garage had been
- 23 opened by law enforcement prior to the search warrant
- 24 being read, that that wouldn't matter. Is that -- do
- 25 you recall that?

- 1 A. I believe what happened in reference to that
- 2 is the SWAT team con -- conducted the securing of the
- 3 residence, the clearing of the residence. I think that
- 4 the garage door was opened by that SWAT team --
- 5 Q. Okay.
- 6 A. -- prior to detectives reading the warrant.
- 7 But I mean, we had the warrant. We were reading the
- 8 warrant to the house. I don't -- I don't know if it
- 9 got -- I don't recall if it got reclosed or whatever.
- 10 I know Tarpon Springs had their body cameras on and
- 11 I would -- I would watch those body cameras.
- 12 Q. Okay.
- 13 A. To see what's -- what's been -- what happened.
- Q. What's the purpose of reading the warrant to
- 15 the house?
- 16 A. So, I don't see a reason to read a warrant to
- 17 an inanimate object; however there has been attorneys
- 18 that have told me from case law that it needs to be
- 19 done. There has been attorneys that told me it does not
- 20 need to be done. This is a situation where I'd rather
- 21 be safe than sorry, so, you know, we -- it's our
- 22 practice currently to read -- to read the warrants.
- 23 Q. Okay.
- Is it -- is it your belief that it may not be
- 25 required?

- 1 A. I don't have case law to support or refute it
- 2 so I've been -- I've been given conflicting answers from
- 3 different attorneys. But again, I think that -- I like
- 4 to -- I like to practice things in an abundance of
- 5 caution, so I'd rather do something that may not be
- 6 necessary but we're allowed to do, than to not do
- 7 something that is necessary and not do it appropriately.
- 8 Q. Did you enter the -- the residence or the --
- 9 or the garage of the residence when it was being
- 10 searched?
- 11 A. The only place that I entered in
- 12 Dr. Kosowski's house was the garage; and I did enter it
- 13 with Detectives -- I believe it was Melton and I can
- 14 give you the other name -- Sergeant Crawford, who
- 15 conducted the search. We -- I was present for it. I --
- 16 you know, they're the ones that opened the vehicle, did
- 17 those things.
- 18 I was present for those things and observed what
- 19 they observed. I -- I believe I directed one of them;
- 20 there was a -- a freezer in the -- in the back. There
- 21 was another cart. There was -- there was a cart similar
- 22 to the one that was used in this incident that we found
- 23 in there.
- 24 Again I would refer to their body cameras. They
- 25 had their body cameras on during the time that I was in

- 1 the home, and that completely depicts everything that I
- 2 did while in the residence -- or in the garage of the
- 3 residence.
- 4 Q. Did -- did you take any photos during the --
- 5 during the time that you were in the garage?
- 6 A. I don't -- I don't recall taking any photos.
- 7 I don't know if we had the work cell -- if I had
- 8 Bolton's work cell phone or not. I don't recall that.
- 9 Forensics was coming in to do it. I don't know that I
- 10 would have done that.
- 11 But again I would look at the -- I would look at
- 12 the video because if --
- 13 Q. You're -- so you may have taken photos but
- 14 you're not sure.
- 15 A. Yeah, I'm not aware of taking any.
- 16 Q. If you took photos would they have been
- 17 preserved in evidence?
- 18 A. Yes.
- 19 Q. Okay.
- 20 And do you know if anyone else took photos of -- of
- 21 the people that you were with?
- 22 A. The only people that I was with were Bolton
- 23 myself, Crawford, and Melton.
- Q. Right.
- 25 A. Yeah, so I -- I don't recall them doing it.

- 1 Again, I would look at the -- the video.
- Q. Okay. So you rely on the video. It's
- 3 possible that it may have happened but you -- you don't
- 4 recall.
- 5 A. I don't have any independent recollection of
- 6 that, no.
- 7 Q. Okay.
- 8 What about did you yourself participate in the
- 9 search of the truck?
- 10 A. In the search of the truck?
- 11 Q. Right.
- 12 A. I was --
- 13 Q. In the garage.
- 14 A. I was present when they were looking in the
- 15 truck. I -- I observed the red substance in the bed of
- 16 the truck that later was presumptive as blood and then
- 17 later tested positive as Steven Cozzi's blood; but I
- 18 didn't -- I didn't search anything. I didn't take
- 19 anything. I didn't do anything like that.
- 20 We did a kind of precursory in the garage to see,
- 21 you know, what needed to be processed and then forensics
- 22 came in and -- and conducted their investigation. And
- 23 then I left the scene to go home prior to forensics
- 24 ending their investigation.
- Q. Okay. So -- so when you left home they were

- 1 still -- Pinellas County Sheriff's Office forensics were
- 2 still processing?
- 3 A. Correct.
- 4 Q. When you left to go home, what if any results
- 5 did you have from the forensic processing?
- 6 A. I believe I found out the next -- I think I
- 7 found out that evening that -- from Supervisor D'Jimas
- 8 that the -- there was presumptive blood in the truck.
- 9 And then I later learned, in speaking with
- 10 Supervisor Stropes, about the -- the substance on the
- 11 garage floor.
- 12 Q. When you say that -- later that evening, are
- 13 you talking while you were there at the location?
- 14 A. While -- while I was there before I left to go
- 15 home.
- 16 Q. Okay.
- 17 A. I believe I had that information that evening
- 18 because I spoke -- I spoke with Supervisor D'Jimas.
- 19 Q. And would that have also most likely been
- 20 captured on video?
- 21 A. No. I don't -- I don't know. I -- so
- 22 forensics doesn't video their processing of scenes.
- 23 Q. Okay.
- 24 A. Tarpon Springs use their body cameras when
- 25 they were in the precursory search; but then as far as

- 1 the rest of it, I don't know that anything was on body
- 2 camera, no.
- 3 Q. Okay.
- 4 What time did you leave that location?
- 5 A. I -- I apologize. I didn't document the time
- 6 that I left. I can -- I might be able to search back
- 7 through the call history and get a timestamp of when I
- 8 logged out.
- 9 O. Was it --
- 10 A. It was early -- it was early in the morning.
- 11 Q. Okay. If you're going to roughly guess, you
- 12 know what --
- 13 A. My guess would be like around 1:00 or
- 14 2:00 a.m.
- 15 Q. Okay.
- 16 A. So, but again, I don't have an exact time for
- 17 you. I apologize.
- 18 Q. Do you recall who the forensic technician was
- 19 that provided you with the information prior to you
- 20 leaving?
- 21 A. Supervisor D'Jimas is the one that I had
- 22 spoken with.
- 23 Q. And specifically she told you that there was a
- 24 presumptive positive for blood?
- 25 A. Correct.

- 1 Q. In the truck -- on the truck bed?
- 2 A. The truck bed is my recollection.
- 3 Q. Okay.
- 4 And she was physically present at the scene as
- 5 well?
- 6 A. She was. And again, I would refer to her
- 7 supplements and forensic supplements in reference to
- 8 what they processed, what they did, what their findings
- 9 were.
- 10 Q. Okay.
- 11 Did you speak to anyone else other than her?
- 12 A. That evening at the scene?
- 13 Q. Right; of the forensic people.
- 14 A. Not that I can recall. I typically speak with
- 15 the supervisors.
- 16 Q. Do you know what time the search of the
- 17 residence started?
- 18 A. I do not.
- 19 Q. Were you at the --
- 20 A. And that was conducted -- that occurred after
- 21 I had left.
- 22 Q. Okay.
- 23 A. I was not present for that.
- Q. So you did not participate in the walk-through
- 25 then, right?

- 1 A. The final walk-through, no. In fact, I --
- 2 yeah, no, I did not participate in any of that.
- 3 Q. Did you participate in an earlier walk-through
- 4 or you just strictly were in the garage?
- 5 A. I participated in the cursory in the garage
- 6 with the two detectives from Tarpon.
- 7 Q. Right.
- 8 A. I never went inside his home.
- 9 Q. Okay. That's right.
- 10 A. I mean his garage is his home. I never went
- 11 inside the living area of 511 Seaview.
- 12 Q. Understood.
- 13 Is there a particular reason why you decided to
- 14 leave before the search of the residence? The -- the
- 15 living quarters?
- 16 A. I was exhausted.
- 17 Q. Okay. All right.
- 18 A. It's 2:00 o'clock in the morning. I mean,
- 19 we'd been working 18-, 19-, 20-hour days. I had a dog
- 20 at home. I needed to take care of, you know, personal
- 21 things. I -- I needed to go home and go to bed.
- Q. And was ASA Spadaro at the scene --
- 23 A. She was --
- Q. -- when you left?
- 25 A. She responded to the scene prior to SWAT

- 1 getting there.
- 2 Q. Okay.
- 3 A. Yeah.
- 4 Q. And what did you observe about her involvement
- 5 of being there during the time that you were there?
- 6 A. While I was there she was in the street with
- 7 other members of law enforcement.
- 8 Q. Okay.
- 9 So while you were there Spadaro did not enter the
- 10 residence?
- 11 A. No.
- 12 Q. Okay.
- 13 A. I -- like I said, I went in the garage --
- 14 Q. At least not that you saw.
- 15 A. I didn't go in the residence. Well, no, I
- 16 mean nobody went in the residence except for the two
- 17 detectives -- I mean the SWAT team, the two detectives
- 18 and then the forensics division, they went and
- 19 processed.
- 20 But we -- when forensics is processing we want to
- 21 reduce contamination as much as we can. Unfortunately
- 22 due to having the SWAT team affect the warrant, you
- 23 know, that -- that was something we have to overcome.
- 24 But it's not our practice to walk through scenes when
- 25 forensics is processing.

- 1 Q. Right.
- 2 A. We want to preserve and collect evidence.
- 3 Q. Okay.
- 4 What about going into the garage area where you
- 5 were located? Did Spadaro come in there or stayed in
- 6 the street with the other one --
- 7 A. While I was on scene she was in the street.
- 8 I'm not aware of anything else.
- Q. Okay.
- 10 Were any instructions provided by Spadaro as to how
- 11 to conduct the search while you were present?
- 12 A. We were informed by the State Attorney's
- 13 office that we needed to ensure that we did not search
- 14 anything in the residence, that Tarpon Springs needed to
- 15 conduct the search to have jurisdiction.
- 16 Q. Okay.
- 17 A. From the best of my recollection, ASA Spadaro
- 18 came out kind of as a liaison with the State, provided
- 19 us with that information and then we made that request
- 20 to Tarpon Springs PD and they -- they assisted us in
- 21 that.
- 22 Q. As -- as Largo Police Department detectives,
- 23 do you guys wear body cameras?
- A. So, I'd have to check the dates. At the time
- of this case coming out, the body camera program was new

- 1 to our agency.
- 2 Q. Uh-huh.
- 3 A. Detectives do not wear body cameras. We can
- 4 utilize them for interviews and things like that but
- 5 we're not mandated to have them on us and recording at
- 6 all times.
- 7 Q. And when you do use them for interviews or
- 8 what have you, do you use it through the app on the
- 9 phone or do you actually have one of the cameras
- 10 available to you?
- 11 A. So every member has been issued a camera.
- 12 Q. Okay.
- 13 A. I use it when I do, you know, off-duty details
- 14 when I'm in uniform.
- 15 Q. Okay.
- 16 A. Typically I record my interviews on a digital
- 17 recorder covertly.
- 18 Q. Okay.
- 19 A. My concern is that if I have a camera strapped
- 20 to my chest people might be less likely to talk to me;
- 21 but I like to, you know, when I'm interviewing victims
- 22 of crimes and suspects of crimes and things like that,
- 23 and subjects and defendants, I like to audio record
- 24 those contacts.
- 25 So at that time it was -- it was new to the agency,

- 1 it wasn't something that we were widely using. And I
- 2 think a lot of us have -- now we have the app and we
- 3 have some other things. So I tend to use my digital
- 4 recorder. I know Detective Bolton uses the app for a
- 5 lot of the interviews he does.
- 6 I'm -- I'm afraid that there's going to be a
- 7 malfunction with the phone and then I'm going to lose an
- 8 interview.
- 9 Q. Okay.
- 10 A. So I typically use my digital audio recorder
- 11 with my cases.
- 12 Q. Okay.
- 13 So it would be fair to say that you -- you had body
- 14 cameras available that you could have worn during the
- 15 search of 511 Seaview but chose not to.
- 16 A. I didn't search 511 Seaview.
- 17 Q. I understand.
- During your time in the garage at 511 Seaview, you
- 19 could have worn your body cam but you did not.
- 20 A. I didn't have it with me, I don't think but --
- 21 Q. Okay.
- 22 A. -- again, Detective Melton and
- 23 Sergeant Crawford had their body cameras, so I felt that
- 24 it was --
- 25 Q. They had their body cameras on?

- 1 A. Yeah, their body cameras were recording. When
- 2 Detective Bolton and I were inside and --
- 3 Q. Right.
- 4 A. -- I had -- the only time that I was inside of
- 5 that property body cameras were activated by Tarpon
- 6 Springs PD.
- 7 Q. Okay. All right.
- 8 The tag flipper that -- that I think was discussed
- 9 in your first depo, do you know whether or not -- was
- 10 there a tag -- what you would describe as a tag flipper
- 11 on the Toyota Tundra?
- 12 A. Yes.
- Q. And do you know whether or not that's
- 14 something that -- in that particular one does it
- 15 scroll -- does it provide different tags or does it just
- 16 bring like a black screen over the license plate?
- 17 A. So it's a flipper. So it's a mechanical
- 18 device that you can put two tags on, kind of sandwiched
- 19 like this, and then you would activate it and it goes
- 20 down and flips. And so you've got one tag when you're
- 21 driving around, you hit the button and then, you know,
- 22 activate it however you activate it and then it
- 23 mechanically flips it.
- 24 Q. And specifically was -- was that -- did it
- 25 have two tags on it?

- 1 A. I didn't -- I don't -- I don't recall what all
- 2 was on -- I would -- I would check the crime scene
- 3 photos and things like that.
- 4 I'm -- I -- I'm pretty sure, just going off memory,
- 5 that the New Jersey tag that we got off Flock was not on
- 6 the truck. We --
- 7 Q. Okay.
- 8 A. -- we could not locate it.
- 9 Q. Did you yourself examine this tag flipper?
- 10 A. I recall seeing it activated on the truck but
- 11 again, I don't remember what was on it, what tags were
- 12 on it, things like that.
- 13 Q. When you say you recall seeing it activated,
- 14 did -- did you examine it yourself or do you just -- or
- 15 did someone else activate it?
- 16 A. Someone else activated and then I saw it flip.
- 17 Q. Okay. Okay.
- 18 Do you know who that person was that actually
- 19 activated it?
- 20 A. I don't remember, no. I apologize.
- 21 MR. BRUNVAND: I know we've been going for a
- 22 while. If anyone needs a break just let me know.
- 23 THE WITNESS: I'll use the restroom whenever
- you guys want to take a break, but we can continue.
- MR. BRUNVAND: How long have we been going?

- THE WITNESS: It's 12:26 right now, so.
- 2 MR. BRUNVAND: All right.
- 3 Should we take a little break, Nathan?
- 4 MR. VONDERHEIDE: I mean, if you guys want to.
- 5 Whoever needs a break. I'm good to go.
- 6 MR. BRUNVAND: Why don't we -- why don't we
- 7 take a little break. Let's take -- let's take a
- 8 ten-minute break.
- 9 THE WITNESS: Okay.
- 10 (There was a brief recess at 12:26 p.m. and
- 11 the proceedings reconvened at 12:34 p.m. with the
- 12 same appearances.)
- 13 Q. (By Mr. Brunvand) All righty.
- 14 Were you -- were you aware -- and this will be on
- 15 the day that the search of the Corolla took place.
- 16 Were you aware that Tom Kosowski was driving from
- 17 Miami prior to --
- 18 A. Yes. So -- so I was contacted earlier that
- 19 afternoon that plate hits had come back, that he was
- 20 traveling, it appeared to be from Miami toward, you
- 21 know, back in this direction. I believe it was
- 22 Detective Compton and Detective Gay that had come in
- 23 on -- on Saturday morning and had started kind of
- 24 querying those -- those tag readers and -- and kind of
- 25 picking up where we left off. And I was notified at

- 1 12:45 by Sergeant Caravella that there had been an LPR
- 2 hit registered to Dr. Kosowski and that they believed he
- 3 was heading back to the Tampa Bay area from south
- 4 Florida. But I don't know what camera that was on. I
- 5 wasn't privy to any of that information.
- 6 Q. Okay.
- 7 You had indicated earlier that when Dr. Kosowski
- 8 requested access to a bathroom that you provided it to
- 9 him shortly thereafter, I believe you said.
- 10 A. Yeah.
- 11 Q. If there is a two-and-a-half-hour delay
- 12 between the time when he first asked for access to the
- 13 bathroom and when you provide him with use of a
- 14 bathroom, would that be consistent with -- with -- with
- 15 your time period that you remember or --
- 16 A. I don't know if Dr. Kosowski had asked
- 17 somebody for a restroom prior to asking me -- asking --
- 18 me -- me being aware of it.
- 19 Q. Okay.
- 20 A. As soon as I was aware of it, we made efforts
- 21 to provide him with that. I didn't want to deprive him
- 22 of -- of using a restroom if we could do it, first of
- 23 all, lawfully, and then safely, and then appropriately
- 24 to preserve the evidence that we were seeking a warrant
- 25 for.

- 1 Q. Did -- do you believe that it took
- 2 two-and-a-half hours for you to make that accommodation
- 3 or do you believe that he asked someone else and that
- 4 person did not convey the information?
- 5 A. I don't recall my process of getting that done
- 6 taking two-and-a-half hours.
- 7 Q. Okay.
- 8 A. I don't --
- 9 Q. Is it your belief that it probably did not or
- 10 you -- or you're not sure?
- 11 A. It's my belief that when I was noti -- it --
- 12 it's my recollection that as soon as I was aware that he
- 13 needed to use the restroom we provided him with
- 14 accommodations to do that.
- 15 Q. Okay.
- 16 A. And again I don't -- I can't -- I don't know
- if he asked another officer, I don't know if he -- I
- 18 don't -- I don't know that.
- 19 MR. BRUNVAND: Hold on one second.
- Okay. Never mind.
- 21 Q. During your interactions with Dr. Kosowski,
- 22 you mention making him whole on several occasions.
- Do you recall what -- can you elaborate on what --
- 24 what you meant by that?
- 25 A. I think, like I said earlier, you know we were

- 1 trying to downplay our contact and, you know, keep him
- 2 cooperative, and I think to -- to -- to allow him to, I
- don't know, to be all like, you know, I apologize that
- 4 we -- you're being detained; I know this is taking
- 5 longer than anticipated. It was taking much longer than
- 6 any of us had anticipated. In an ideal world we would
- 7 have been able to do the body warrant right in
- 8 conjunction with that Corolla warrant and it may have
- 9 taken an extra 45 minutes or an hour. I mean in an
- 10 ideal world that's how CloudGavel is supposed to work
- 11 and unfortunately we didn't have that.
- I think that it was probably just a word that I
- 13 used to try to keep a good rapport with him.
- 14 Q. Okay. All right. Recognizing the fact that
- 15 the Supreme Court allows you to be untruthful from time
- 16 to time if -- in interacting with people that you --
- 17 A. That is -- that is accurate, but, you know,
- 18 quite frankly, you know, taking into the totality of the
- 19 circumstances -- I mean, even not the circumstances, you
- 20 know, I try to conduct myself in doing the right thing.
- 21 And so, when he needed to use the bathroom I tried to
- 22 get that accommodated for him.
- I can totally understand why he was, you know,
- 24 upset that he had been in the back of the car for so
- 25 long, I recognize that; but, you know, unfortunately

- 1 that was outside our realm of control.
- 2 Q. Understood.
- 3 A. So I -- my entire job is talking to people who
- 4 have done some of the most deplorable things in society
- 5 and, you know, being respectful of them and trying to
- 6 find out their story and find a reason why they do what
- 7 they do; and I think that's just kind of how I conduct
- 8 myself.
- 9 Q. Who made the decision to handcuff Dr. Kosowski
- 10 behind his back?
- 11 A. Well, he was handcuffed behind his back by
- 12 Tarpon Springs Police Department when they took him into
- 13 custody.
- 14 Q. Okay.
- 15 And when -- when -- when Dr. Kosowski asked you to
- 16 loosen your handcuffs, did -- did you assist him with
- 17 that or no?
- 18 A. I don't -- I don't remember. Again, all of
- 19 that's in the video recording.
- 20 Q. It -- was it -- was he handcuffed with his
- 21 arms behind his back for -- for more than ten hours, for
- 22 the -- I mean for the duration of -- of -- of his
- 23 detention?
- A. Well, it's interesting that you bring that up.
- 25 He was handcuffed behind his back until he slipped his

- 1 cuffs in front of him when I told him we were getting
- 2 the body warrant and he started sucking underneath his
- 3 fingernails and cleaning his fingernails off on his
- 4 teeth. So he put his hand -- hands in front of himself.
- 5 Q. At some point.
- 6 A. At some point. Actually at -- right before we
- 7 left to go to the police department. So, like around
- 8 like 12:29:04. And then he tries to put his hands back
- 9 behind his back at 0031 hours approximately, but he's
- 10 unsuccessful. I didn't catch it until I reviewed the
- 11 in-car video. When we took him out at the Tarpon
- 12 Springs Police Department to affect the body warrant I
- 13 didn't realize that he had slipped his cuffs and that
- 14 they were in front of him. It just didn't click with me
- 15 until I watched the video.
- 16 Q. Okay.
- 17 Is there a reason why -- why you do it behind his
- 18 back instead of in front when he's locked in a car like
- 19 that?
- 20 A. Absolutely, there's a number of reasons.
- 21 So this is a person who knows what he did. He
- 22 knows -- he knows what happened. He knows where Steven
- 23 Cozzi is. He knows what he did. And I'm not willing to
- 24 risk my life for his comfort. I don't know if he would
- 25 try to attack me, if he was handcuffed in the front.

- 1 We would want to keep him handcuffed in the back
- 2 for preservation of evidence, which Dr. Kosowski showed
- 3 when he slipped his cuffs and started tampering with
- 4 evidence and, you know, cleaning underneath this
- 5 fingernails and sucking on them, things like that,
- 6 20 minutes before we were going to the police department
- 7 to effect a body warrant. So there's a plethora of
- 8 reasons why we have somebody handcuffed behind their
- 9 back.
- 10 It is our policy that detained individuals that are
- 11 handcuffed are handcuffed behind the back, given absent
- 12 a -- a medical issue or something like that. But for
- 13 safety and for preservation of evidence I think that
- it's most appropriate that he was handcuffed behind his
- 15 back.
- 16 Q. And then you said you -- you were not aware of
- 17 these things until later on when you watched the video.
- 18 A. Correct.
- 19 Q. Okay.
- 20 A. Again I didn't handcuff him, Tarpon Springs
- 21 did. I think it's appropriate he was handcuffed behind
- 22 his back. And in the moment I didn't realize when he
- 23 was brought in that an officer hadn't inadvertently
- 24 moved the handcuffs up front but that he had, in fact,
- 25 slipped it himself.

- 1 Q. Okay.
- 2 Was there any time during his detention, you know,
- 3 whether it's at the two-hour mark, the five-hour mark,
- 4 the eight-hour mark, whether there was any consideration
- 5 given to loosening up the handcuffs or -- or anything
- 6 like that?
- 7 A. Again, it -- he may have asked me; I would
- 8 look at the -- the video.
- 9 So how handcuffs work, with 18 years of being a law
- 10 enforcement officer, if you're handcuffed behind your
- 11 back and I have them very loose what ends up happening
- 12 is you -- your wrist is not a perfect circle but the
- 13 handcuff is a circle. And so if it's too loose it ends
- 14 up putting pressure on it and things like that; and if
- 15 it -- it needs to be tight enough to where we can get a
- 16 finger inside of it so they stay in place so the person
- 17 doesn't, you know, have issues with the handcuffs. And
- 18 then secondly it needs to be tight enough and not too
- 19 loose to where they can slip the handcuff.
- 20 So it's -- if -- it is my practice that when I have
- 21 handcuffed people as a patrol officer and detective,
- 22 when they ask I typically check; and if it is a
- 23 situation where it is appropriately fastened, there's no
- 24 reason to adjust them. If there's a situation where
- 25 they are too tight and it does not have that finger

- 1 spacing, then I would adjust it for them.
- I don't recall whether or not I did that with him,
- 3 but his entire contact's on video; I would refer to the
- 4 video.
- Q. Okay.
- 6 Would you agree that Tom Kosowski was overall
- 7 cooperative?
- 8 A. I would agree with that.
- 9 THE WITNESS: Can you hear any of the
- 10 background that I have over here?
- MR. BRUNVAND: Can I what?
- 12 THE WITNESS: Can you hear any of the
- 13 background that I'm hearing?
- MR. BRUNVAND: No.
- 15 THE WITNESS: No? Okay.
- MR. BRUNVAND: No.
- 17 Q. (By Mr. Brunvand) The Corolla's trunk was
- 18 closed prior to the Pinellas County Sheriff's processing
- 19 unit starting their examination of the vehicle.
- 20 Do you know why it was closed?
- 21 A. So, I know that you had said earlier when we
- got on scene it was closed; a Largo officer opened it
- 23 we're not sure who.
- Q. Right.
- 25 A. And then it was closed again.

- 1 Q. Right.
- 2 A. And so your question is why was it closed
- 3 after it had already been --
- Q. The second time, right.
- 5 A. I didn't close it but if I were to speculate I
- 6 would imagine for evidence.
- 7 Q. Okay.
- 8 A. You know, purposes for preserving evidence for
- 9 preservation.
- 10 Q. Okay. All right.
- 11 A. Again, I don't know, you know, if it was
- 12 opened for just a precursory search to ensure that, you
- 13 know, Steven Cozzi wasn't in the back and then, you
- 14 know, I -- I would say that it would have been closed
- 15 afterwards just to preserve evidence; we're on the side
- 16 of a road.
- 17 Q. Okay. I mean clearly the -- the search of the
- 18 Corolla, once you have the search warrant -- is there a
- 19 search prior to the forensic doing their or do the
- 20 forensics go first and then you guys do the search?
- 21 A. I don't think anyone entered the vehicle with
- 22 the exception of the cell phones. I -- I don't recall
- 23 entering it. I think that it was -- they were looking
- 24 for any -- anything right then that we could get because
- 25 the processing would take hours to conduct. But it

- 1 would -- it would be my practice to have forensics
- 2 process and search the vehicle in coordination.
- 3 So I think they -- and again, I'm just speculating
- 4 on why they did some certain things at the scene. I
- 5 think they were -- I think they were just looking for
- 6 any overt evidence that we would have during the
- 7 detention phase upon making contact with him. And then
- 8 they brought it back to the legal processing bay to
- 9 conduct their thorough forensic investigation.
- 10 Q. Okay. Were you directing Specialist Klein
- 11 to -- to -- regarding the presumptive blood testing of
- 12 the Corolla at the scene? Do you recall that?
- 13 A. I don't recall that.
- 14 Q. Okay.
- 15 A. It's pos -- it's possible.
- 16 Q. Okay.
- 17 A. I don't recall having -- I don't recall what
- 18 the details of any conversations I had with her.
- I know that we were talking about we were going to
- 20 be moving it to the -- to the evidence bay, they were --
- 21 they were taking the cell phones and then again, I think
- 22 they were looking for any overt evidence that we -- that
- 23 we could see right then and there.
- 24 Q. The search warrant indicates specifically that
- 25 the vehicle may be searched -- maybe towed from the

- 1 current location in front of 34 West Orange Street,
- 2 Tarpon Springs, to Largo Police Department to be
- 3 searched and processed.
- 4 Is that where it was towed to?
- 5 A. It was towed to the processing bay for the
- 6 sheriff's office. They have a secure vehicle processing
- 7 center off of 49th Street. That's where it was taken.
- 8 Q. Is there a reason why -- why the search
- 9 warrant would say Largo Police Department instead of the
- 10 sheriff processing bay?
- 11 A. An error. We don't -- we don't have an open
- 12 facility to do secured searching for vehicle processing.
- 13 We have a vehicle processing room but it's utilized as a
- 14 garage.
- 15 Q. So --
- 16 A. And forensics would have searched -- would
- 17 have taken it to their -- their location.
- 18 Q. So you -- you -- you drafted the search
- 19 warrant affidavit.
- 20 A. I did.
- 21 Q. Who -- who drafted the actual search warrant?
- 22 A. So I put it in the PC narrative. I work in
- 23 accordance with the State, specifically ASA Vonderheide,
- 24 to get the search warrant put together and through
- 25 CloudGavel and -- and so I think that may have just been

- 1 a -- an error on our part that it was listed as Largo PD
- 2 rather than their -- their location.
- 3 Q. Okay.
- 4 A. Because the sheriff's office is who takes
- 5 custody of all of our evidence. They take custody --
- 6 they're the ones processing it. They're the ones that
- 7 are using their equipment. They have all the equipment
- 8 that they use at their -- at their vehicle base. So
- 9 just an error.
- 10 Q. Have you had any contact during this
- 11 investigation or any other investigation with
- 12 Supervisor Stropes with the Pinellas County Sheriff's
- 13 Office forensics?
- 14 A. Yes. I spoke with her in reference to some
- 15 patterns that they had located in the residence, I
- 16 believe. Give me a second.
- 17 Yeah, I spoke with Supervisor Stropes in reference
- 18 to the garage floor being tested with luminol and having
- 19 a positive reaction. Through further forensic
- 20 processing areas of possible blood were located and
- 21 tested positive through presumptive testing.
- I called her from my desk, I believe, and had a
- 23 telephone conversation with her.
- O. And when was that?
- A. I want to say it was on the 24th of March.

- 1 Prior to right when I got back from Miami. I don't -- I
- 2 don't remember the time of day but I do remember having
- 3 a telephone conversation with her.
- 4 Q. And when -- when -- when was Dr. Kosowski
- 5 initially detained and then arrested?
- 6 A. The 25th. This was reference to the garage
- 7 floor of the residence for the search warrant --
- 8 Q. Right.
- 9 A. -- on this residence.
- 10 Q. Right.
- 11 And -- and was the purpose of the call to include
- 12 that information in your search warrant application?
- 13 A. Yes.
- 14 Q. Is it your understanding that Stropes was
- 15 never at 511 Seaview when it was being processed?
- 16 A. I don't -- I don't know. I know that D'Jimas
- was the supervisor on scene; Bolton had gotten
- 18 information from forensics and then I had contacted
- 19 Stropes who is a supervisor with the forensics division.
- 20 I don't know if she took that. I don't -- I don't know
- 21 if she processed it or back at the -- the testings or if
- 22 she went over what was in the -- the report. I had
- 23 gotten the information from her and from
- 24 Detective Bolton.
- 25 Q. Is it -- is it possible that you're mistaken

- 1 about Stropes being the one that provided that
- 2 information?
- 3 A. I'm pretty confident I had a conversation with
- 4 Stropes.
- 5 Q. Okay.
- 6 Were you aware of Celeste Bacher's failure to ID
- 7 Kosowski as a person of interest; were you involved in
- 8 that?
- 9 A. I was not involved in a photo pack. I don't
- 10 think I knew about that until actually I was asked about
- 11 it in my first depo.
- 12 Q. Were you aware that -- that she had been
- 13 interviewed?
- 14 A. I spoke with her briefly the first day of the
- 15 investigation when she approached me and then I had no
- 16 further contact with her.
- 17 Q. And she's the one that's describing the goatee
- 18 man, right?
- 19 A. Correct.
- 20 Q. So her lack of identifying Kosowski, you did
- 21 not know that until after you had submitted the search
- 22 warrant affidavit?
- 23 A. Correct.
- 24 Q. Would you have included that in the search
- 25 warrant affidavit if she had -- if you had -- if you

- 1 were aware of the information? That she did not
- 2 identify Kosowski?
- 3 A. Well, I think that we do -- I mean, I would
- 4 have provided all the information for the case to the
- 5 ASA that's working with us and we draft the warrant
- 6 together. So if it needs to be addressed then I mean,
- 7 it's our responsibility to report what we have and what
- 8 we know at the time -- right? -- whether it's good bad
- 9 or indifferent.
- 10 O. Sure.
- 11 A. So if it needed to be included it would be
- 12 included.
- 13 Q. Okay. I mean obviously, if she had identified
- 14 Kosowski that would be significant, right?
- 15 A. Correct.
- 16 Q. And so, I mean, it -- would it be fair to say
- 17 that the opposite then is also significant?
- 18 A. Yeah.
- 19 Q. Okay.
- 20 A. I -- I -- I would say that -- I didn't
- 21 interview her so I don't know if she -- I think there's
- 22 a difference between saying I can't identify the person
- 23 and then identifying the wrong person. So, I think
- 24 those are two entirely different things.
- Q. What's your -- and what's your understanding,

- 1 did -- did she identify the --
- 2 A. I don't know. I wasn't aware of the photo
- 3 pack until I believe my depo; but I wasn't aware that
- 4 had taken place.
- 5 Q. Okay. So even to this -- to this date you're
- 6 not familiar with all the circumstances surrounding that
- 7 attempt to identify him.
- 8 A. I am not. I don't know what her statements
- 9 were; I did not conduct that interview and I don't know
- 10 what she said.
- 11 Q. Okay.
- 12 Do you know whether or not Specialist Klein and
- 13 Briggs were alerted to the fact that detectives with
- 14 Largo Police Department had opened the trunk and the
- 15 door and -- and reached into both places prior to them
- 16 doing the forensic examination?
- 17 A. I don't -- I don't know if they were aware of
- 18 that. I don't know that any detectives reached into the
- 19 trunk of the vehicle prior to forensic's examination
- 20 prior to the warrant being done. I know that I did not
- 21 do those things.
- 22 Q. Okay.
- When you were at 511 Seaview in the garage, did you
- 24 see any ammunition?
- 25 A. I'm trying to think.

- 1 Q. Sure.
- 2 A. I don't recall.
- 3 Q. Do you recall seeing any hunting gear?
- 4 A. I don't recall. Again, there -- there's a
- 5 SWAT team with video body cameras and the two detectives
- 6 that I were with had their body cameras activated that I
- 7 was with the entire time.
- 8 Q. When did you learn that Dr. Kosowski was a
- 9 surgeon?
- 10 A. When did I learn that he was a surgeon?
- 11 Q. Right. Was it before or after the search of
- 12 511 Seaview?
- 13 A. I don't know. I think we -- I mean we were
- 14 aware of the lawsuit that was going on but I don't -- I
- 15 don't know when we determine -- when we learned, you
- 16 know, what type of medicine he practiced or that he was
- 17 a plastic surgeon or whatever he was. I don't have a
- 18 timeline for that. I apologize.
- 19 Q. Okay.
- 20 The -- can we go through the reports that you have
- 21 authored in this case?
- 22 A. Yeah.
- The supplements?
- 24 Q. Yeah. So what would be the first supplement?
- 25 A. It is -- the first one starts out on 3/21/2023

- 1 I was contacted by Sergeant Recla.
- 2 Q. Okay. All right.
- A. And that supplement in itself is eight pages
- 4 long and that details March 21st and then the early
- 5 morning hours of March 22nd.
- 6 Q. It's eight pages?
- 7 A. Yes.
- 8 Q. One, two -- so it looks like the one I have is
- 9 eight pages. Let me -- let me -- let me share --
- 10 A. It's eight pages.
- 11 Q. No, I'm saying -- I'm sorry. It looks to me
- 12 like mine is seven; but let me -- let me share what I
- 13 have and let me know if I'm missing something here.
- 14 A. Okay.
- 15 (Screen shared.)
- 16 Q. Can you see that?
- 17 A. When I contacted Sergeant Recla, yeah.
- 18 Q. Okay. And so that's one page.
- 19 A. That's page 174; that's one, yeah.
- 20 Q. 175 is two.
- 21 A. Hold up. Hold on one second. Go back. Go
- 22 back up.
- Oh, see this is -- so just keep going up. Stop
- 24 right there.
- 25 So my first page reads paragraph, you know: This

- 1 is to supplement OPD. Then it says on 3/21/23, and then
- 2 it says, taking into account; the next paragraph
- Officer Bure; the next paragraph, I then began to note;
- 4 next paragraph, as you enter the front main doors; and
- 5 then page two starts with: After noting the general
- 6 layout of the office building.
- 7 Q. Okay.
- 8 A. Which is going there. So I think that it's --
- 9 it's just the spacing printed out differently.
- 10 Q. Okay.
- 11 A. Because yours -- it looks like yours is
- 12 printed as a totality, like the entire report, and mine
- 13 was printed just this supplement.
- 14 Q. Okay.
- A. So it starts with: On 3/21/2023 and then my
- 16 last page says -- the last -- second-to-last paragraph
- 17 says, since I observed a PSC bus traveling northbound
- 18 and then it says this case is still active NFI.
- 19 O. What's --
- 20 A. So you have the full report.
- 21 Q. Okay.
- 22 A. Yeah.
- 23 Then my second supplement --
- Q. Hold one second. Let me -- let me make sure
- 25 that --

- 1 Okay what's your second one?
- 2 A. The second one -- all my supplements start out
- 3 this is to supplement the case number -- but it says on
- 4 Wednesday 3/22nd --
- 5 Q. Right.
- 6 A. -- 2023. This is where we respond to Whitney
- 7 Circle. Detective Bolton -- I used his work cell phone
- 8 to photograph the residence. I get the Ring
- 9 surveillance.
- 10 That supplement I have as being two pages; the
- 11 last -- second-to-last paragraph is: I subsequently
- 12 contacted Largo Police dispatch and spoke with
- 13 Dispatcher 5801 for the soft inquiry with NCIC/FCIC.
- Q. Okay. I have that.
- 15 A. Okay.
- My next supplement is dated Thursday 3/23 of 2023.
- 17 Q. Yes.
- 18 A. And it is -- in my opinion, it's two pages
- 19 because the last page says this case is still active
- 20 NFI.
- 21 Q. Okay.
- 22 A. But the one before that is: The list was
- 23 submitted as an attachment to Largo Police records in
- 24 reference to Tarpon Springs SWAT team.
- Q. The list --

- 1 A. So I got -- the end of that -- that
- 2 supplement, right -- right before that thing, I list out
- 3 the SWAT team members and I say that list was later
- 4 submitted as an attachment to Largo Police records; this
- 5 case is still active NFI is the ending of that
- 6 supplement.
- 7 Q. Oh, the ending, okay. Got it. Got it. Yeah.
- 8 Yeah.
- 9 A. And then the next supplement, I'm confident
- 10 that it's just one page. It's Friday 3/24 2023 with
- 11 Detective Wedin.
- 12 Q. Go to Miami?
- 13 A. Yes.
- 14 Q. Okay.
- 15 A. And then the next one is Saturday 3/25/2023, I
- 16 was contacted by Sergeant Caravella. 12:12:45 hours by
- 17 Sergeant Caravella.
- 18 Q. And then that's two pages or --
- 19 A. That's -- so that, on mine on the format, it's
- 20 three pages because it ends: This case is still active
- 21 NFI on the third page. But the last -- the last
- 22 paragraph of substance is: At 0417 I responded to
- 23 Pinellas County Jail property division and submitted the
- 24 true copy of the warrant.
- 25 Q. Same. I have it.

- 1 A. Okay.
- 2 And then the next supplement is Thursday, 3/30.
- 3 Assisted Detective Moore with the infotainment warrants.
- 4 Q. Okay.
- 5 A. And that, for me, is three pages. It ends on
- 6 4/20/2023 I responded to the criminal court complex and
- 7 met with ASA E. Lipton.
- 8 Q. Yes.
- 9 A. Okay. Just so you're aware, too, I did note a
- 10 scrivener's error in there, a little bit up there. It
- 11 says search warrant number 92 and then it says S --
- 12 SW392, that's -- that should be number 93. So the pound
- 13 signs above three, that was a scrivener's error. So
- 14 it's -- those two warrants were number 92 and 93.
- 15 Q. So the search warrant for the Tundra?
- 16 A. Is 92.
- 17 Q. Is ninety -- 392?
- 18 A. It is number 92. And the search warrant for
- 19 the Corolla is number 93.
- Q. Oh, I got it. So it should -- instead of 322
- 21 it should be -- let me --
- 22 A. It should be pound sign 93.
- Q. Got it. Okay.
- A. My next supplement is dated 4/26 of '23.
