THE COURT: Can we have Mr. Mosley out?

THE BAILIFF: We do have Mr. Mosley up, your Honor.

THE COURT: Yes. Can we have him out, please?

THE BAILIFF: Yes, your Honor.

THE COURT: Thank you.

(DEFENDANT ENTERED THE COURTROOM)

THE COURT: All right. Mr. Mosley is present in court.

Good morning.

MR. PETREDIS: Good morning, your Honor.

Justin Petredis on behalf of regional counsel for Mr. Mosley.

THE COURT: Okay.

MS. SULLIVAN: Courtney Sullivan for the State.

THE COURT: All right. And Mr. Petredis, you are new to Mr. Mosley's case; is that correct?

MR. PETREDIS: Yes, your Honor.

THE COURT: All right. And there was a conflict with the Public Defender's Office. Did you note any conflicts on your end?

MR. PETREDIS: The initial conflict check

1 came back clear.

2 THE COURT: All right.

3 MR. PETREDIS: They are going to keep
4 checking it, but at this point we are clear.

5 THE COURT: All right. And so have you had a
6 chance to get discovery yet? I assume not?

7 MR. PETREDIS: I have gotten some of it
8 through our system. I have been going through as
9 much as I can. And I have reached out to Ms.
10 Sullivan in regards -- I started the process of
11 getting some depositions scheduled.

12 THE COURT: Okay. Great.

13 Anything to add?

14 MS. SULLIVAN: No. And I explained to
15 Defense this morning, I will make sure that I
16 communicate with him about discovery and make sure
17 he has everything that I know that is extremely
18 important. I know it's hard for him to know --
19 not know what he doesn't have.

20 THE COURT: Right.

21 MS. SULLIVAN: So we are going to make sure
22 he gets everything he needs. I am going to get
23 back to him probably today with the depo dates
24 that he is requesting so we get that going.

25 I am going to ask for maybe an October

1 pretrial because I think our depo dates are going
2 to be in September.

3 THE COURT: Sure.

4 MS. SULLIVAN: And then we are still six
5 months out from the trial date. I let Mr.
6 Petredis know immediately what the trial date was
7 and that I very much was still aiming for that
8 trial date, and he said he is going to do his best
9 to make that work. He has no conflicts. I don't
10 want to speak for you, but --

11 MR. PETREDIS: No.

12 MS. SULLIVAN: -- he did a conflict check on
13 the trial date immediately --

14 THE COURT: Okay.

15 MS. SULLIVAN: -- and he was clear.

16 THE COURT: All right. So do you want to try
17 October 22nd?

18 MS. SULLIVAN: That works for the State.

19 MR. PETREDIS: Yes, your Honor.

20 THE COURT: All right. October 22 for a
21 pretrial, and if there is anything you need to
22 come see me about sooner than that, you are
23 welcome to set it.

24 MR. PETREDIS: Yes, your Honor. Thank you.

25 THE COURT: All right.
