The Grand Jurors of the State of Florida, impaneled and sworn to inquire and true charge make in and for the body of the County of Pinellas, upon their oath do charge that

THOMAS MOSLEY

in the County of Pinellas and State of Florida, on or between the 29th day and the 30th day of March, in the year of our Lord, two thousand twenty-three, in the County and State aforesaid unlawfully and from a premeditated design to effect the death of [REDACTED] did inflict sharp force injuries on the said [REDACTED] and as a direct result thereof, the said [REDACTED] died, and during the commission of such felony, THOMAS MOSLEY carried, displayed, used, threatened to use, or attempted to use any weapon; contrary to Chapter 782.04(1)(a)/775.087(1)(a), Florida Statutes, and against the peace and dignity of the State of Florida. COUNT TWO

And the Grand Jurors of the State of Florida, impaneled and sworn to inquire and true charge make in and for the body of the County of Pinellas, upon their oath do charge that THOMAS MOSLEY, in the County of Pinellas, State of Florida, on or between the 29th day and the 31st day of March, in the year of our Lord, two thousand twenty-three, in the County and State aforesaid, unlawfully and from a premeditated design did cause the death of [REDACTED] a child [REDACTED], while being a caregiver of [REDACTED] contrary to Chapter 782.04(1)(a)/782.07(3)/827.03, Florida Statutes, and against the peace and dignity of the State of Florida.
