The notice shall contain specific information as to the place at which you claim to have been at the time of the alleged offense, and as particularly as is known

to you or to your attorney, the names and addresses of the witnesses by whom you propose to establish your alibi. You are under a continuing duty to disclose promptly to the State Attorney's Office the names and addresses of any additional witnesses which may come to your attention subsequent to the filing of your witness list.

If you fail in any particular manner to comply with the provisions of Rule 3.200, a motion will be made to exclude any and all evidence, except your own testimony, offered by you for the purpose of proving an alibi.
