#### **Related Cases**

Attorneys and self-represented parties must advise this court of related cases currently pending or recently decided. See appellate rule 9.380 for information and rule 9.900(k) for a form.

#### **Child Custody Cases**

Attorneys and self-represented parties must file a separate "Notice of Custody or Visitation Issue" if child custody or visitation is an issue in the case. The court expedites such appeals.

#### **Service on Opposing Counsel and Self-Represented Parties**
