BY ORDER OF THE COURT:

The petition for writ of certiorari is denied as to the circuit court appellate division's order signed on May 29, 2019, that affirms the appellant's appeal in case 18-000022-AP-88B.

The petition for writ of certiorari is dismissed as to the circuit court appellate division's sanctions order signed on May 29, 2019, to the extent that it merely grants entitlement to fees and costs. *Cf. McIlveen v. McIlveen*, 644 So. 2d 612, 612 (Fla. 2d DCA 1994).

The petition for writ of certiorari is dismissed as untimely to the extent that it seeks review of orders dated April 2, 2018; April 19, 2018; and June 6, 2018. This court's October 3, 2019, order to show cause is discharged.

The petition for writ of certiorari will proceed as to the circuit court appellate division's sanctions order signed on May 29, 2019, only to the extent that the petition challenges the requirement that the petitioner must appear by counsel in the Sixth Circuit. Respondent shall serve a response to the petition for writ of certiorari within 30 days. Petitioner may serve a reply within 30 days thereafter.




