



ORDER VACATING ORDER DISMISSING CASE WITH PREJUDICE

THIS CAUSE is before the Court *sua sponte*. Having considered the case file, the applicable law, and being otherwise fully advised in the premises, the Court hereby **FINDS** as follows:

1. On November 7, 2025, this Court entered an Order Dismissing Case with Prejudice (“Dismissal Order”).
